Hawaiian Platform Completed at UH Manoa

On December 22nd Walter Ritte, Hano Naehu and Kalaniuoa Ritte flew to Oahu to finish the last stone platform (9ft. by 9ft. by four ft. high) at the administration building at the University of Hawaii. This was the final act concerning the battle to save Haloa the taro and the first born of the Hawaiian people from GMO manipulation and patent ownership by the UH. The platform will serve as a Hawaiian Protocol Area at UH, and as a daily reminder to the administration that Hawaiians are the original people of these islands. The platform was built in a day and finished by 7:00pm that Friday night, many people came to kokua. Kalaniakea Wilson was the over all coordinator of the event, which calls for Taro, Hawaiian plants and trees to be grown surrounding it.

Protesting IRS' Tyranny Could Be Deadly Ed Brown says he is not afraid of death!

Ed Brown, barricaded in his Plainfield, N.H. home, said he's preparing for an armed standoff with U.S. Marshals. "I don't fear death," he said.

Brown, 63, has been convicted of conspiracy to defraud the federal government. His wife, Dr. Brown, 65, a local dentist, convicted of conspiracy to defraud the federal government, federal income tax evasion, failing to collect federal payroll taxes for employees in her dental office in what has been referred to as a "kangaroo court".

Ed and Elaine Brown have been on trial for daring to expose the idea that normal Americans are not required by law to pay Federal Income Tax. The judge has struck down 40 of the Brown's motions in court, and has refused to allow them to present evidence in their defense.

If the income tax is truly legal, why cannot the jury hear the evidence and decide for themselves? asks supporter "Marie" who experienced the holocaust of Nazi Germany during WWII. She said that from her perspective we are living in "Communist China" right now. She said that the "news is being filtered and that the people are not getting exposed to the truth just like it was in Nazi Germany".

Ed Brown said that the only "positive" outcome of this stand off will be the trial convictions will be vacated as null and void, and a new trial for the Browns will be held, and the jury will be allowed to hear and see every piece of evidence that would exonerate the Browns. Otherwise, there will be a stand off, and when they come for him, he will defend himself, and he believes that other Americans will defend him as well, with force of arms if necessary.

A clarion call has been made to encircle Ed Brown with a wall of protection from armed Americans, and their firearms and video cameras.

[MAN: It can happen to anybody who refuses to pay taxes not owed. It can happen to YOU. We need to stage massive protests and rallies on behalf of people like the Browns, and do it in front of IRS, DOJ, and Federal Court property. We need to DEMAND that our County Commissions pound on County Sheriffs till the sheriffs do their job and run federal agents out of the county and protect people like the Browns from federal tyranny; or run them out ourselves as is our Right to do as Sovereigns. Let us not forget the extreme limit of federal authority in the states. We can and should organize to protect each other from Lingle/Bush/IRS unconstitutional Police State tactics and to make citizens' arrests, en masse, of federal agents attempting unlawful arrests and home invasions, as in the case of the Browns. Marine gets 18-month prison term after pleading guilty in the killing of innocent Iraqi man

Marine Pfc. John J. Jodka was part of a squad of seven Marines and a Navy corpsman accused of kidnapping a man in the town of Hamdania, west of Baghdad, taking him to a roadside hole and shooting him, then trying to cover up the killing.

Jodka, 20, pleaded guilty Oct. 27 to assault and conspiracy to obstruct justice and agreed to testify. In exchange, prosecutors dropped charges of murder.

7 New Orleans Cops Surrender

Seven police officers are charged in a deadly bridge shooting in Hurricane Katrina's aftermath. Sept. 4, 2005, shootings on the Danziger Bridge less than a week after the hurricane hit. Two people died and four people were wounded.

Police say the officers were responding to a report of other officers being attacked when they came under fire. Police also claim one of the men, Ronald Madison, was reaching for a gun. Madison, a 40-year-old mentally retarded man, and James Brissette, 19, were killed on the bridge.

The coroner said Madison was shot seven times, with five wounds in the back.

Madison's brother, Lance, denies he or his brother was armed. He said they were running from a group of teens who had opened fire on the bridge when seven men jumped out of a rental truck and also shot at them without warning.

Sgts. Kenneth Bowen and Robert Gisevius Jr., officer Anthony Villavaso II and former officer Robert Faulcon Jr., were indicted last week on first-degree murder charges. Officers Robert Barrios and Mike Hunter Jr. were charged with attempted first-degree murder, and Officer Ignatius Hills was charged with attempted second-degree murder. No bail for the four accused of first-degree murder. Bail will be \$100,000 per count for the other three officers. Defense attorneys say the seven officers are innocent.

Bush Gives 16 Pardons to Minor Criminals

President Bush issued 16 pardons to minor criminals and commuted the sentence of an Iowa man serving time for a drug conviction.

Six of the federal offenses were drug crimes, while others included bank fraud, mail fraud, the acceptance of a kickback, a false statement on a loan application and conspiracy to defraud the government over taxes, aiding cocaine distribution, conspiracy to possess marijuana, and conspiracy to distribute methamphetamine.

With this batch, Bush has issued 113 pardons and commuted three sentences in his nearly six years in the White House, according to spokesman Tony Fratto.

A pardon amounts to federal forgiveness for one's crime, while a commutation cuts short an existing prison term.

"Requests for executive clemency receive intense individualized consideration based upon an established set of objective criteria," spokesman Fratto said.

He said that after investigation by the Office of the Pardon Attorney at the Justice Department, most weight is given to these factors: the seriousness of the crime; how long ago it was committed; the acceptance of responsibility and showing remorse; post-conviction conduct and contributions to society; any specific compelling need for relief; official recommendations, including from the sentencing judge, the probation officer and the federal prosecutor.

Highschool Racism Against Caucasian Club Demonstrates Race-based Double Standard At California School

A 15-year-old girl's effort to start a Caucasian Club at her California high school has won her some support ~ and an avalanche" of anger.

Freshman Lisa McClelland gathered about 250 signatures from students and adults to start a club at Freedom High School in Oakley, Calif., that would focus attention on European heritage and history.

Her campaign has won the support of many students, not all of them white, who say such a group would be no different from the school's other ethnic clubs, which include the Black Student Union, the Latinos Unidos and the ALOHA club for Asian-American students.

"I applaud Lisa McClelland. She should be allowed to be proud of her heritage and want to know more about it just like anyone else," said one student on the high school's e-mail forum. "What a bunch of hypocrites when people start using the word 'racist.' Why isn't the Latino club racist? Or the Asian or African-American club?"

But the Caucasian Club has run into opposition from those who accuse the club of fueling racial tension. Darnell Turner, vice president of the East County National Association for the Advancement of Colored People, said he fears the club could morph into a white-supremacy group after Lisa graduates. "I think she's doing this for the right reasons, but what's going to happen when she graduates? What's it going to turn into?" said Mr. Turner, who added he was speaking for himself and not the NAACP. He suggested that she change the name to the European-American Club so that the focus would be on heritage, not race.

Lou Calabro, president of the European-American Issues Forum, said he spoke with Lisa on Wednesday when she called to ask for advice. Since then, he's become an informal adviser for the would-be club. He sent letters to two civil-rights organizations requesting an investigation of the school administration.

In the letters, he accused Principal Eric Volta of "resisting the formation of the club" when he said it "would upset the alleged current positive feelings at the school," said Mr. Calabro in a letter to the U.S. Department of Education's Office for Civil Rights. He cited e-mail he received from Lisa on Friday describing her difficulty in finding an adviser for the club and threats from other students. She also said that teachers are allowing students to place anti-Caucasian fliers around campus criticizing her campaign. "She's scared," said Mr. Calabro "One white football player called her [obscenity]. Others are calling her names. She's only 15, so naturally she's upset."

She has been advised that she picked a tough road to travel and she must mature to that reality and deal with it if she is to succeed with her proposal. Poor baby.

Linda Lingle is Disqualified for Felonies

CHAPTER 831 UNIFORM ACT ON STATUS OF CONVICTED PERSONS §831-2 Rights lost.

[b] A public office held at the time of conviction is forfeited as of the date of the conviction, if the conviction is in this State, or, if the conviction is in another state or in a federal court, as of the date a certificate of the conviction from the trial court is **filed in the office of the lieutenant governor who shall receive and file it as a public document.** An appeal does not affect the application of this section.

§831-3.1 Public office means an office held by an elected official.....Time of conviction means the day upon which the person was found guilty of the charges by the trier of fact or determined to be guilty by the court.

ALSO, under Section 19-3.5, HRS, any person who knowingly takes an oath prescribed or authorized by law and willfully makes any false statement of fact while under oath therein shall be guilty of voter fraud which is a Class C felony punishable by up to five years imprisonment and/or \$10,000 fine. Lingle knew of her felony.

Under the "Uniform Act on Status of Convicted Persons," a person sentenced for a felony may not become a candidate for or hold public office from the time of the person's sentence until the person's final discharge. A felon must receive final discharge before he/she is eligible to file nomination papers. Lingle not discharged.

Qualifications for Office for State: A candidate running for state elective office with a district residency requirement must be a qualified voter of the district from which he/she seeks election...if applicable, provide final discharge for any felony conviction. Lingle's felonies disqualify her from voting and candidacy.

Objection or challenge of a candidate may be made by the Chief Election Officer, the City/County Clerk, a registered voter such as George Peabody, or an officer of a qualified political party. See Section 12-8, HRS. My objections were made known to Chief Elections officers Yoshina and counsel Steven Chang before 11-7-06

8. I resolve to focus on the ways America could be so much better with a very small government -- not to dwell on all the wrongs that exist today.
9. I resolve to cleanse myself of hate, resentment, and bitterness. Such things steal time and attention from the work that must be done.
10. I resolve to speak, dress, and act in a respectable manner. I may be the first Libertarian someone has encountered, and it's important that he get a good first impression. No one will hear the message if the messenger is unattractive.
11. I resolve to remind myself that someone's "stupid" opinion may be an opinion I once held. If **I** can grow, why can't I help **him** grow?
12. I resolve not to raise my voice in any discussion. In a shouting match, no one wins, no one changes his mind, and no one will be inspired to join our quest for a free society.
13. I resolve not to adopt the tactics of Republicans and Democrats. They use character assassination, evasions, and intimidation because they have no real benefits to offer Americans. Crimes of Politicians Must Be Stopped by The People (You are The Militia)




