Army Troops To Be Domestic PoliceFORCE: TREASON

Army Times (dated Tuesday, September 30, 2008), starting Oct. 1, 2008, the 1st Brigade Combat Team's mission is to be an on-call federal response force to be used domestically against Americans in America. The Army brigade will be called upon to help with civil unrest and crowd control, traffic control, as well as subduing so called "unruly or dangerous individuals." The Army brigade will be known as a Consequence Management Response Force, or CCMRF ("sea-smurf").

This is the first time an active unit has been given a dedicated domestic assignment to provide command and control for federal homeland defense efforts and civilian control outside of War; and, it is TREASON to assign domestic police duties to the U.S. military, violates the Posse Comitatus Act and the Insurrection Act, and is ultra vires to the Constitution for the united States of America. This turn of events, likely related to the current economic meltdown and expected civil unrest, is extremely disturbing and a threat to our freedom, our Republic.

Chuck Baldwin, candidate for President from the Constitution Party, wrote that "To understand my concern for this new "homeland Army brigade," it is important that we rehearse the principles of liberty as they relate to standing armies. One of America's most sacred principles has always been that the U.S. military was never to be used for domestic law enforcement. The fear of standing armies ran very deep in the hearts and minds of America's founders. The tyranny and misery inflicted upon the colonies by British troops weighed heavily upon those who drafted our Constitution and Bill of Rights. In their minds, the American people would never again be subjected to the heavy weight of army boots. Furthermore, they insisted that America would have a civilian--not military--government. And after the fiasco of the abuse of federal troops in the South following the War Between the States, the doctrine of Posse Comitatus was enacted into law."

The Posse Comitatus Act prohibits members of the federal uniformed services from exercising state law enforcement police or peace officer powers that maintain 'law and order' on non-federal property. The statute generally prohibits federal military personnel and units of the United States National Guard under federal authority from acting in a law enforcement capacity within the United States, except where expressly authorized by the Constitution or Congress.

The Posse Comitatus Act and the Insurrection Act substantially limit the powers of the federal government to use the military for law enforcement. The Posse Comitatus Act was passed in 1878 and is universally accepted as being a very just--and extremely important--law of the land, to protect freedom and liberty.

Congress renewed the restrictions of the Posse Comitatus Act when it passed the 2008 National Defense Authorization Act against the wishes of Pres. Bush. When President Bush signed the Act into law, he attached an Executive Order against the restrictions of the Posse Comitatus/NDA Act 2008.

Now, just a few months later, President Bush has authorized an Army brigade under his command that is assigned the new role of dealing exclusively with domestic law enforcement and related duties against American Citizens. [Does anyone remember those big empty prison camps Bush created past few years?]

Congress Votes NO Bailout!

For once, Hawaii's Democrat/Socialist Party congress Reps. Waialua Beach Access or Naehu/Simms' Private Land?

For more than 30 years, this little piece of highway shoulder land has been used by fishermen as a Waialua Beach access where two cars can park parallel to highway while diving, fishing, beach recreation. But can a public beach access be private property that can be posted and public excluded?

Yes. In this case, this small triangle of land with the new removable fence posts in the photo above is the parcel used as a Waialua Beach access, tmk# 5703-40 owned by the Arthur Naehu T/E, and now being posted by grandson Simms. Often the fence posts are removed so the parking area is open from the highway. Simms is also building a rock wall on the makai side of the property, and there are a lot of kiawe tree cuttings dumped toward the public beach below his rock wall.


At first, confusion reigned when the Maui County RPT office could not locate this speck of land on their tax maps, but the next day found it and Dawn Matney sent this message: "Our records show parcel 5703-40 as 0.29 ac, as shown on the map, owners Naehu." Based on that, it appears this Waialua public beach access is allowed by Naehu's permission, or access can be denied by Naehu et al.

The recorded size of this land [0.29 ac=12760 sq.ft.] is obviously erroneous, though it may have measured that much sometime before the highway was built.

The investigation started after someone broke part of the cemented rock wall next to the boundary marker near highway, but Simms said it fell down by itself.

State Water Commission Met on Maui, but Molokai Streams Need restoring too

The State Commission on Water Resource Management held its monthly meeting on Wednesday, September 24, 2008, in Ha'iku, Maui, to hear community' recommendations on eight east Maui instream flow standard petitions for: Honopou; Hanehoi and Puolua (Huelo); Pi'ina'au; Palauhulu; Waiokamilo; Kualani; Waikani; and East and West Wailuanui.

The Commission has the responsibility of establishing instream flow standards to protect the public interest in streams statewide, so Molokai residents can start calling for a Molokai meeting to restore our streams being robbed by Molokai Ranch's surface water collection system.

Instream flow standards are essentially the amount of water required to flow in a stream for the protection of native fish and wildlife, recreation, scenic views, and other beneficial stream values which are being violated with MPL taking so much water for their residential/hotel developments at Kaluakoi. The Commission must also balance these instream uses with non-instream uses, such as water for drinking and home use, cultivation of taro, and agriculture.

The streams on Maui that under consideration have been diverted by East Maui Irrigation Company for more than 100 years to provide water for sugar in the central Maui plains, and recently to Upcountry Maui residents for domestic use and to farmers in the Kula Agricultural Park.

Commission staff will present their findings and recommendations at the upcoming meeting. This process is a considerable improvement from previous efforts, and is the first time that such measurable standards have been developed outside of a contested case hearing. "The process we've applied in east Maui provides a framework to consistently and transparently assess and balance competing stream uses," he said.

State Thrill Craft Rules Prohibit Operations around Molokai and Lanai

Jetski aka Thrillcraft rules enforced by DLNR are being called unclear by operators on Molokai who have recently been informed that their jetski operations are prohibited on Molokai and Lanai by the Ocean Recreation Management Area [ORMA] laws. The ORMA areas are ALL ocean waters out to 3000 feet from shore, within which some specific areas are assigned for jetskis/thrill craft.

But most large ORMA areas have NOT been assigned a specific recreational use such as jet skis operations, therefore jetskis are NOT prohibited providing they operate at least 500 feet from shore or outside reef areas whichever is greater distance from shore, or outside of the ORMA area completely.

Molokai and Lanai ORMA waters out to 3000 feet from shore and between the islands carry a total prohibition on all jet ski/thrillcraft operations. Hmm, seems simple to understand.





The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!
