## Three Unanswered Questions:

**Was Barack Obama Born in Kenya?**

**Is He Really a Citizen of Indonesia?**

**Does the Constitution still Matter?**

**Electors are sworn to uphold it** with their vote on December 15<sup>th</sup> in the Electoral College. But they must first know for sure that the candidates meet the Constitutional requirements for the office of President beginning with being a natural born citizen.

That's what Philip J. Berg has asked the United States Supreme Court to verify. The Supreme Court has asked for a response from Senator Barack Obama along with the Democratic National Committee and Federal Elections Commission. And they have until December 1<sup>st</sup> to respond. Other cases have been filed asking for the same thing.

### Not extreme. Not fringe. Just Constitutional.

Obama says he's qualified. But, Berg, multiple legal suits and a growing number of American citizens are saying: "Prove it." A basic, vital and Constitutional request.

### Why won't Obama answer such a simple and essential request?

#### Exhibit A: The Grandmother's tape

Barack Obama's own grandmother said he was born in Kenya. While politicians are known for it, grandmothers seldom lie. It's recorded on tape:

*"I was in the delivery room in [Mombasa,] Kenya, when he was born Aug. 4, 1961." — Sarah Obama, Obama's paternal grandmother*

#### Exhibit B: No Original Birth Certificate

Experts have called the Certification of Live Birth posted online a forgery. Berg reported "It's clearly been altered," which invalidates it, according to the document itself. Add to this the Hawaiian law at the time which allowed people to register for this non-hospital short form certificate (without a doctor's signature) up to one year from the date of the child's birth.

#### Exhibit C: Indonesian citizenship

Only Indonesian citizens could attend Indonesian schools at the time Barack Obama attended the Indonesian school where he was registered as Barry Soetoro. His citizenship was listed as Indonesian, his religion as Islam, and his father as Lolo Soetoro, M.A. There was also no dual citizenship at the time. If he was adopted by his Indonesian stepfather, he would have forfeited any U.S. citizenship he may have had, just as when a child is adopted in America, he or she becomes an American.

#### Exhibit D: U.S. Law

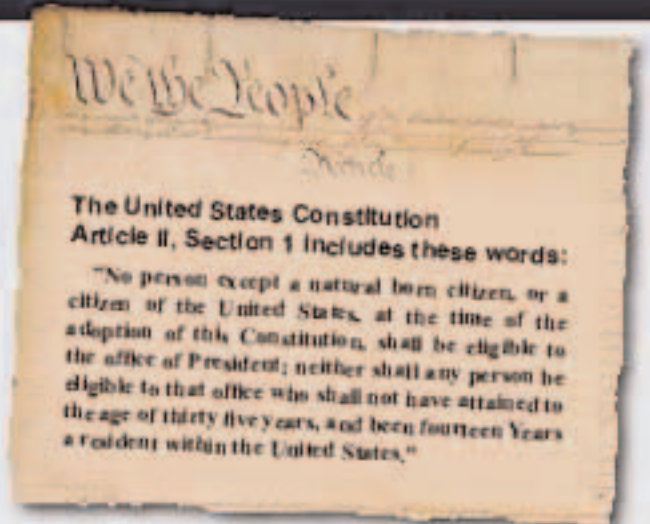
In addition, according to U.S. law pertaining to births abroad, from "Dec. 24, 1952, to Nov. 13, 1986," in order to register the child's birth as a U.S. natural-born citizen at the time of Obama's birth, he or she must be: 1. Born to two U.S. citizen parents; OR 2. If only one parent was a U.S. citizen at the time of the birth, that parent must have resided in the United States for at least 10 years, at least five of which must be after the age of 14.

Since Barack Obama's father was not a U.S. citizen and Obama's mother was only 18 at the time of his birth, she failed to meet the legal requirements of U.S. residency for at least five years after the age of 14.

**Pres. Bush Expected to Pardon His Partners in Crime Soon?**

Harold Nadler Introduces Resolution Opposing Bush Pardons: H.RES.1531.

"Expressing the sense of the House of Representatives that the President of the United States should not issue pardons to senior members of his administration during the final 90 days of his term of office."

Never before has a president pardoned himself or his subordinates for crimes he authorized. The idea that the President's pardon power constitutionally includes such pardons ignores a fundamental of law: no man can sit in judgment of himself. Its the reason James Madison and George Mason argued that we needed the impeachment power because a president might some day try to pardon someone for a crime in which he himself was involved. The problem is the complete elimination of any semblance of the rule of law by pardoning one's own subordinates for crimes he instructed them to commit.

It is absurd that Bush authorized crimes, but Congress is NOT impeaching him, not prosecuting him, not proposing any action with any teeth at all, but now formally objecting to the idea of him issuing pardons of his own subordinates for crimes he authorized. But this is where we are. State, local, civil, foreign, and international prosecutions are likely ways of holding Bush, Cheney, and gang accountable, and pardons can't interfere with them. Pardons can't interfere with impeachment. But if we allow these pardons, we not only guarantee no federal prosecutions, and not only give Congress an excuse to drop its investigations, but we also establish the precedent that from here on out any president can violate any law and then pardon the crime. This is simply to end the idea of law. We cannot allow that.

The American public must be prepared for the appropriate response when the Bush pardons come. The appropriate response will be to demand:

1. Immediate impeachment of Bush and Cheney, even if they are out of office.
2. Overturning of the pardons, as Bush's lawyers told him he could do to Clinton's pardon of Marc Rich.
3. Law banning self-pardons and pardons of crimes authorized a president.
4. Prosecution of Bush, Cheney, and their subordinates for their crimes.
5. After a fair trial, HANG THEM HIGH FOR TREASON.

Obama Personnel Questionnaire Shows Anti-gun Bias

Last week, we reported on the anti-gun legislative agenda proposed by President-elect Barack Obama's transition team, headed by former Clinton administration operatives John Podesta and Rahm Emanuel.

This week, it became clear that the new administration's anti-gun agenda even infects the process of staffing the administration. A widely disseminated questionnaire for those applying for administration jobs asks: "(59) Do you or any members of your immediate family own a gun? If so, provide complete ownership and registration information. Has the registration ever lapsed? Please also describe how and by whom it is used and whether it has been the cause of any personal injuries or property damage."

The NRA has denounced the move: a president can't use an applicant's gun ownership status to deny employment. Obama's transition team declined to go into detail on why they included the question.

 Media reports say President-elect Barack Obama has selected Eric Holder as his Attorney General. Holder, as Deputy Attorney General under Janet Reno during the Clinton Administration, said that the Second Amendment does NOT protect an individual right, but instead protects the right to have a firearm when serving with a militia. After leaving office, Holder stuck to that assertion when he signed Janet Reno's brief to the Supreme Court in the Heller case, which stated, "The Second Amendment does not protect firearms possession or use that is unrelated to participation in a well-regulated militia."

At the Justice Department, Holder advocated a waiting period, limiting gun purchases to one per month, and so-called "gun show loophole" legislation--the fine print of which would have driven gun shows out of business. Holder made it clear that he, Clinton, and Reno were more interested in stopping gun sales than in regulating them. When ABC's George Will asked him about guns being used for self-defense more often than to commit crime, and Right-to-Carry states having lower crime rates than other states, Holder dismissed the facts that Mr. Will raised, with the flippant statement, "I'm not sure that we need more than the 200 million or so guns that we have on the streets."

In the same interview, Holder claimed that gun control was responsible for crime declining in the 1990s, when criminologists, law enforcement professionals, and sociologists attributed the trend to more guns in civilian hands. We wonder what Holder would say today, since the federal ban on "assault weapons" and standard-equipment magazines holding more than 10 rounds has expired, the number of privately owned guns has risen by 35-40 million, and yet, murder and total violent crime have declined even more than before.

After leaving the Justice Department, Holder kept his anti-gun bona fides up-to-date by writing a column in the Washington Post advocating a law that would ban any gun sale without a background check--even between family members and close friends--and also "give the Bureau of Alcohol, Tobacco and Firearms a record of every firearm sale."

Obama's selection of a Clinton Administration veteran with an anti-gun record as long as his own, signals that the new president is just as committed to his promise of respecting the Right to Keep and Bear Arms, as he is to his promise of change: "Yes We Can" get elected by lying to the American people.





The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

# Citizens' Arrest Attempted on Karl Rove in San Francisco

SAN FRANCISCO — An anti-war protester confronted and tried to arrest former Bush aide Karl Rove while he spoke at a mortgage bankers' meeting.

The woman is 58-year-old Janine Boneparth, who tried to handcuff Rove in what she called a citizen's arrest for "treason."

Rove elbowed Boneparth away as federal goons dragged her off the stage. No one was injured and no arrests made.

[Editor's Note: The plain clothes thugs who protect these criminals probably work for one of the mercenary outfits and trust me they will hurt you if you get too close. If Citizens who attempt to arrest federal/state officials are found to have been within their rights to "arrest" the suspect, the thugs/police who stopped the arrest must be guilty of obstructing justice! When George Peabody attempted to make Citizen's arrest of MPD Chief Thomas Phillips during a MPD Commission meeting five years ago, all two dozen police officers in the room formed a protective wall in front of Phillips who threatened Peabody not to touch him or he would be attacked by police FORCE]



At another Mortgage Bankers Convention, four Iowans were arrested Friday, July 25, 2008, while attempting to make a Citizens' Arrest of Karl Rove in Des Moines, Iowa. They cited Iowa Code provisions for making Citizen's Arrests as well as citing Federal Statute violations war crimes and TREASON they claimed Rove had violated, but the four were stopped at the gate of the Wakonda Country Club where Rove was scheduled to speak.

The four arrested are retired Methodist minister and Peace and Justice Advocate, Rev. Chet Guinn, 80, as well as three Des Moines Catholic Workers, Edward Bloomer, 61, Kirk Brown, 25, and Mona Shaw, 57. All four were cited for trespassing and released.

When the four arrested people came before the judge on trespassing charge, he asked them what they had done. They answered that they tried to carry out a citizen's arrest on Karl Rove. The judge responded to by saying "It was about time"

The four maintained that they were acting within the guidelines of Iowa Code that obligate private citizens to make such an arrest if they believe a felony has been committed and turn Rove over to police officials to bring Rove before a judge for formal indictment.

John Bolton, the former US ambassador to the United Nations, has escaped an attempted citizen's arrest by George Monbiot, who tried to make the arrest as Mr Bolton left the stage at the Hay Festival. Mr Monbiot was blocked by two heavily-built security guards before he could serve a "charge sheet" on him.

"This was a serious attempt to bring one of the perpetrators of the Iraq war to justice, for what is described under the Nuremberg Principles as an international crime," said Monbiot.

The former ambassador - a key advisor to President George W Bush who argued strongly in favour of invading Iraq - had been giving a talk on international relations to more than 600 people at the literary festival. During Mr Bolton's talk, to a packed-out audience, Mr Monbiot had asked Mr Bolton what difference there was between him and a Nazi war criminal.
