Five classes were offered for Kupuna from which they could choose two. Each activity encouraged a good sense of confidence and identity, stimulate sen-

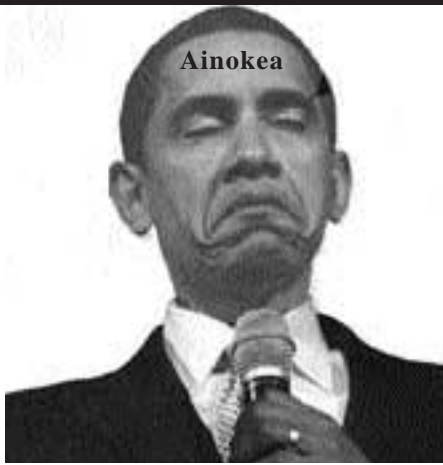

We Don't Need No Stinkin' Permission!

We don't need no stinkin' permission to exercise our rights. We need to exercise our rights whether the government want us to or not.

Ok, so let's start out with the easy stuff, here... I'm a proud tenther. That means I believe that the federal government is authorized to exercise only those powers that we the people delegated to it in the constitution – and nothing more.

The founders created a system, unique in history, where the most difficult and most divisive issues would be kept close to home in our states and our communities. And, there's a good reason for such a system – it's the only kind that can allow people of widely varying political, religious, and economic viewpoints living together in peace. I'm from California. In Florida, you likely don't want California's policies. We shouldn't be required to have Florida's. Maine should be different from Montana, Texas should be different from South Carolina, and so on. This is the system that best advances freedom.

Unfortunately, though, for a long long time, there's been very little that the federal government does that actually IS authorized by the constitution.

QUESTION: WHAT DO WE DO ABOUT IT?

- Do we lobby congress or march on DC and ask that federal politicians limit their own power?
- Do we sue them in court and ask federal judges to limit federal power?
- Do we vote the bums out – and hope that the new bums will reject the power?

Thomas Jefferson and James Madison both warned us that if the federal government ever became the sole and exclusive arbiter of the extent of its own powers – that power would endlessly grow...regardless of elections, separation of powers, courts, or other vaunted parts of our system.

They were right. For over a century, we the people have been suing, and marching, and lobbying, and voting the bums out. But yet...year in and year out, government continues to grow and your liberty continues to diminish. And, it doesn't matter who is the president, or what political party controls congress – the growth of power in the federal government never stops.

Power – the problem we face today is about power – and until we address the absolute fact that the federal government has too much power, and going to the federal government to fix problems caused by federal power – things will never change.

John Adams once gave us a warning that "liberty once lost, is lost forever." He wasn't necessarily saying that there's no hope whatsoever. But instead, it was an important lesson. Whenever government tells us they need more power to deal with an "emergency" – and they always have them for both foreign and domestic issues – that same government will never voluntarily give that power back. They'll never just decide that the newfound power is something they don't want, and that liberty will never be regained without a long, difficult struggle by the people.

WHAT WOULD JEFFERSON DO?

How do we fix this mess? Well, I think I'm in pretty good company if i go with Thomas Jefferson's advice that "whensoever" the federal government exercises "undelegated powers" ... "a nullification of the act is the rightful remedy."

Reading this, you'll notice that Jefferson didn't say that a nullification of the act is a pretty decent remedy. He didn't say that nullification is just a rightful remedy, or even a good idea to try after voting bums out or going to court. He told us that when the feds exercise powers they're not supposed to exercise, We're not supposed to wait for the federal government to correct itself. Jefferson's advice is that we must resist violations of our rights on a state level – every time it happens.

Around the country, there's a lot of talk about nullification – but what is it, really? I can think of no better way to define it than how Tenth Amendment Center research analyst Derek Sheriff has done – by describing what it is not:

Nullification is not secession or insurrection, but neither is it unconditional or unlimited submission. Nullification is not something that requires any decision, statement or action from any branch of the federal government. Nullification is not the result of obtaining a favorable court ruling. Nullification is not the petitioning of the federal government to start doing or to stop doing anything. Nullification doesn't depend on any federal law being repealed. Nullification does not require permission from any person or institution outside of one's own state.

Nullification is something that's already happening around the country – and Derek explains the process:

Nullification begins with a decision made in your state legislature to resist a federal law deemed to be unconstitutional. It usually involves a bill, which is passed by both houses and is signed by your governor. In some cases, it might be approved by the voters of your state directly, in a referendum. It may change your state's statutory law or it might even amend your state constitution. It is a refusal on the part of your state government to cooperate with, or enforce any federal law it deems to be unconstitutional.

At its very core, nullification is any action on a state level that results in some federal law being null and void – and of no effect. It's about "We the People" exercising our rights whether the politicians or judges in Washington D.C want to give us "permission" to exercise those rights or not.

We don't need no stinkin' permission.

Congress! Repeal all 'Stupid' gun laws !

Firearms needed against Congresscrittes to clean up gun laws !
 The U.S. Declaration of Independence states “.... That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed.” Americans do NOT consent to stupid gun laws! The only valid gun law is the 2nd Amendment: “....the right of the People to keep and bear arms shall not be infringed.”

Many modern gun laws are simply stupid, and enforcement of these laws has proven too often be arbitrary, capricious and even vindictive by ATF and cops.

The latest stupidity being exposed is the fact that under federal law, as interpreted by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), millions of law-abiding shotgun owners are committing a serious felony by simply possessing their guns.

So far ATF has wisely refrained from pursuing prosecutions of these millions of illegal gun possessors, but just pretending that a law doesn't exist – especially when ATF has a history of pulling such forgotten laws out of the closet when they need something to pin on someone they've targeted, is suicide.

For instance, the ATF slaughter at Ruby Ridge stemmed from an ATF charge that Randy Weaver cut two shotgun barrels a half inch shorter than the 18 inches the law allows. When Weaver refused to act as an informant against another group, ATF vigorously prosecuted him on the shotguns – even though the agency has declared that shotguns with barrels 17 inches or less were completely legal and not subject to any special controls. His wife, son, dog, friend murdered.

The ATF/FBI/military murderous terror raid on the Branch Davidian church group outside Waco, Texas, also instigated by ATF, started with a botched attempt to serve a search warrant specifying illegal machineguns – or parts with which to convert guns into machineguns. After the 86 women/children murdered, ATF produced the charred and warped remains of a number of guns that they claimed were machineguns, but when a qualified company asked to X-ray these guns, ATF refused. The guns have never been subjected to any outside inspection.

ATF receives a lot of well-deserved criticism, the root of the problem is much deeper than ATF. It is the laws themselves.

Federal gun laws fall into two broad categories: the 1968 Gun Control Act and the 1934 National Firearms Act. GCA deals with "regular" guns that any non-criminal can buy at the local gun shop. NFA covers "special" guns and weapons such as machineguns, sawed-off shotguns, silencers and other, less politically correct guns. Lots of stupid and dangerous ultra vires regulations.

In Steve McQueen's TV show from the late '50s, "Wanted Dead or Alive," McQueen's character carried a chopped down Winchester Model 92 lever-action rifle. That gun almost landed the show's producer in jail and cost the studio over \$1,100 in special taxes because cutting a rifle's barrel down to less than 16 inches or reducing the gun's overall length to less than 26 inches turns that gun into a "Short Barreled Rifle," or SBR, subject to the taxes and rules of NFA.

If you or I were to take a Model 92 today and cut it down to 19 inches like McQueen's gun, we would be subject to up to 10 years in jail and a \$10,000 fine.

That all makes no sense, and clearly violates the 2nd Amendment.
 Stupid and dangerous gun laws and anti-gun rights federal agencies!
