## OverThrow King Obama Trial Update Orly Taitz from the State of Georgia

5. affidavit and testimony by scanning and typesetting expert, Douglas Vogt, that Obama's alleged Hawaii birth certificate on line is a computer generated forgery and not a scan of a single document
6. affidavit and testimony of retired deportation officer John Sampson, testifying to evidence of fraud in Obama's birth certificate and social security number, as well as evidence, that Obama possibly immigrated to US together with his stepfather Lolo Soetoro. Mr. Sampson testified, that in cases like this he would seek a warrant for an arrest and deportation.
7. Orly Taitz also testified: I downloaded Obama's law license application from on line records, which showed him committing perjury and fraud and hiding his prior last names Soetoro and Soebarkah. I testified, that after I complained to IL bar, Obama changed his record from inactive to not eligible to practice law. I presented it to the judge to show a modus operandi. ## Molokai Fire Extinguished After Threat to Kalamaula



The Kalamaula area brushfire was extinguished at 2030 hours last night.

A brush fire scorched 200 acres just west of Kaunakakai Sunday Jan 29. This was a very dangerous situation with large keawi trees near homes, and A Red Flag Warning means that critical fire weather conditions exist. A combination of strong winds, dry weather, and hot temperatures will create rapid fire growth potential. East winds of 20 to 30 mph with gusts up to 40 mph, relative humidity as low as 44 percent and temperatures in the 80s prevailed until evening and wind died.

The fire got within 50 feet from homes in Kalamaula Mauka, just west of Kaunakakai, but no damage reported. 28 fire personnel, with 5 from Lahaina, 2 county tankers, and 1 county loader also assisting with 4 personnel. E-4, E-9, T-4, E-12, 2 Public Works tankers, battled the blaze that was estimated area 200 acres.

Air-2 fire helicopter flew to Molokai with extra fuel and will assist with this brushfire as water dropper. An orange inflatable water tank was established in a vacant field nearby a fire hydrant for refills [see photo]



Fire personnel came across a shipping container on Hoomalu Drive with appliances stored within that sustained approximately \$5,000.00 in damages due to this brushfire. There were reports of a few flare ups, but they were within the burned area. No additional damages reported and no injuries reported. Monday night fire was under control, but a large area (approximate area done from air recon 130 acres) needed mop up to extinguish. E-4, E-9, E-12, T-4, and County tankers remained on scene to monitor and continue mop up operations throughout the night off Hoomalu Drive and nearby areas.

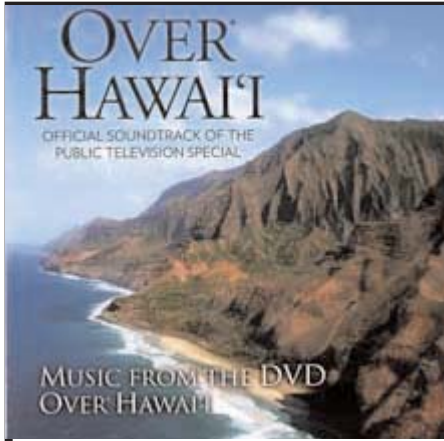
The cause of the fire is currently undetermined.

It's the second straight day of fires on the Friendly Isle. Two brush fires broke out Sunday in Hoolehua.

E9 investigates and finds an incendiary device about 10 feet into the burn off the highway in the Kalae fire. The device was identified as 2 "flower bloom with report" fire works taped together. There were no reported damages or injuries.

Fire Prevention Inspector and MPD investigating.

## Gun Laws Good

House Bill 417, introduced by state House Speaker Calvin Say (D-20), would require county chiefs of police to issue Hawaii Firearm Permits. Senate Bill 835 is the companion measure introduced by state Senator Sam Slom (R-8), who also introduced Senate Bill 836, which would authorize chiefs of police to issue licenses to openly carry firearms. HB 417 has been referred to the House Public Safety and Military Affairs Committee. (2011)

**BAD:** House Bill 441, sponsored by state Representative Blake Oshiro (D-33), is a divisive six-point omnibus gun control measure that would mandate firearms be sold with safety devices, impose ammunition registration, prohibit disclosure of the source of information used to deny a firearm permit to purchase based on the applicant's mental disorder, require the theft of a firearm be reported within 24 hours of the occurrence and prohibit import, sale and transfer of .50 BMG's or cartridges.

## Oceanic Time Warner Cable Internet Service Sucks:

Oceanic Time Warner Cable does not offer RoadRunner Internet service on Molokai. The Molokai offering, WAVE, is a substandard service of very low dependability. The only thing the Molokai WAVE service has in common with the RoadRunner service on other islands is monthly cost. A Broadband alternative to Oceanic WAVE service is unavailable to many Molokai customers. Oceanic is abusing its monopoly position charging RoadRunner rates for substandard WAVE service on Molokai.

We pay the RoadRunner Internet rate for WAVE Plus but receive only half the "Up To" speeds of RoadRunner.

RoadRunner: 10 Mbps download and 1 Mbps upload speeds  
WAVE Plus: 5 Mbps download and 0.35 Mbps upload speeds

The "Up To" speeds are available only at times of low demand. The service deteriorates during the day. In the evenings, download speeds from the San Jose <<http://SpeedTest.net/>>SpeedTest.net site the Oceanic Technicians use on Service Calls frequently drops to download speeds in the low 1Mbps. When I call Tech Support, they agree all my stuff is working fine. The problem is a known issue, limited bandwidth for the Molokai customers currently using the system. When asked if the problem is being addressed, I get the response they are looking into it and could do something this year. They can adjust the bill for the poor service but seem little interested in fixing the problem.

A February 2011 letter from Oceanic stated service in Hawaii would be upgraded to 10 Mbps download and 1 Mbps upload speeds during the year. Also, a rate increase was granted for the upgrade of service. Rates for Molokai Internet service increased \$5/mo March 2011. Another rate increase is just months away.

WAVE service on Molokai was not upgraded and is not scheduled for upgrade. Customers using WAVE on Molokai should not pay for an upgrade they did not and will not receive.

So that's the skinny - WAVE on Molokai is substandard, they know it is substandard but happily charge RoadRunner rates. They may formulate a plan for upgrade before Global Warming raises the sea level sufficiently to inundate the island and make the effort unnecessary.

Rip Off comes to my mind. How about you?

## Molokai to be a County Town? Legislature Considers Constitutional Amendment to Allow County-Town Independence

SB 2036 County Townships Constitutional Amend Proposal Counties; Townships

Description:

Enables counties to create townships. Specifies that counties may create townships within the county by an initiative created by registered voters within the proposed township area, and upon approval of the initiative by a vote. Specifies that a township shall have powers as provided in county charter and ordinances, that may include electing a local governing body and a manager, adopting township ordinances, providing for public services, taxing real property located within the township, and assessing fees for public services. Requires an equitable distribution of population and economic wealth among townships within a county.

Requires a township to consist of contiguous land and to conduct elections independently of administration and financing by the State.

More on what is are "TOWNSHIPS

Section 1A. A county shall have the power to create townships by an initiative conducted upon a petition of registered voters within the proposed township area or a percentage of registered voters within the proposed township area, whichever is less, and approved by a vote of the residents of any discreet geographic area within the county comprising the proposed township. A township shall have powers, duties, and requirements as provided by law."

### SECTION 3. The question to be printed on the ballot shall be as follows:

"Shall the counties have the power to create townships, which shall have powers, duties, and requirements as provided by law, by an initiative created by registered voters within the proposed township area and approved by a vote of the residents of any discreet geographic area within the county comprising the proposed township?"

# Congress and the Constitution's 225th Anniversary

There's a major political event approaching this fall, and though I have no doubt it will be overshadowed by the elections, I hope you'll carve out some time for it anyway. On September 17th, we'll observe the 225th anniversary of the signing of the United States Constitution.

It's the document that set everything in motion, of course, creating the carefully balanced, three-branch representative government that we've come to take for granted. But 225 years is a long time, and it's instructive to reflect on what's happened since that piece of parchment was signed.

I'm thinking in particular of Congress, which the Framers considered to be so important they put it first, beginning with Article I, Section 1: "All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives."

The Framers wanted Congress to be the engine of law and policy in the United States. Fearful of replicating the monarchy from which they'd won their freedom, they wanted to keep the presidency from becoming too powerful, and so they created a powerful Congress with authority to declare war, enact taxes, and budget.

They wanted to be certain that the voices of the American people had a prominent place in the legislature's deliberations, and that debate, consultation, and a thorough airing of views were part and parcel of what Congress did. Congress was the keystone of republican government and the fount of policy leadership; the president, as George Washington insisted, was there to carry out legislative intention.

For periods in our country's history, especially in its early years and in the years leading up to the Civil War, Congress did, indeed, play the leading role the Framers envisioned. Congress today — the "broken branch," as two prominent congressional scholars called it a few years ago — doesn't even come close.

It is now a reactive body, hampered by partisanship and ideology, lacking creativity, focused less on policy leadership than on catering to constituents and to those who can help its members get re-elected. The central actor in American government today is the president.

Everyone understands that 2012 is not 1787. Yet I fail to see how the Framers' reasoning — that in a diverse democracy, power ought to rest with the representatives closest to the people — is out of date.

Quite the contrary. By any measure, our nation is poorer because Congress is not functioning as the strong, co-equal branch of government the Constitution envisioned. As we observe this milestone anniversary, it's worth a pause to honor the Framers' insight and wisdom, and to regret Congress's inability to live up to their ideals.

Upon deplaning Air Force One for his fifth official visit to Arizona, Barack Obama was greeted by Governor Jan Brewer.

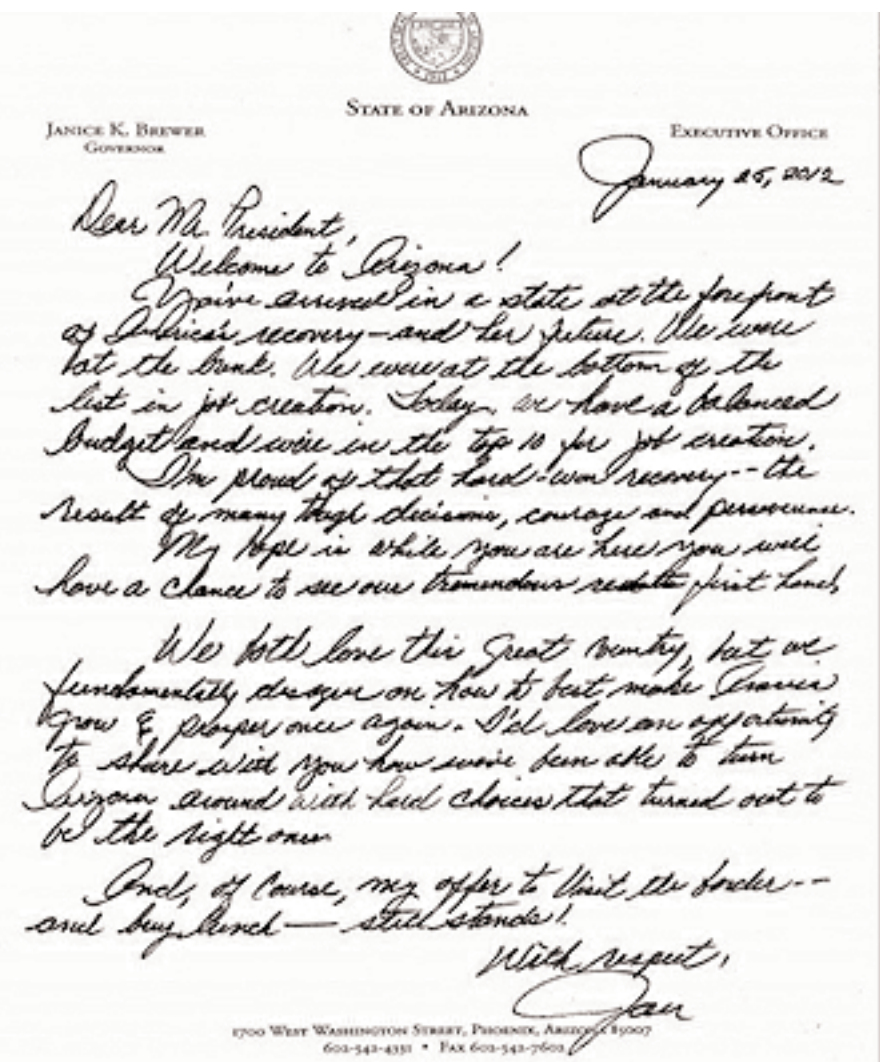

## Romney Backed by Goldman Sachs, Bailout Banks

The top donor to former Massachusetts Gov. Mitt Romney's presidential campaign, investment banking and securities firm Goldman Sachs, received over \$10 billion in emergency lending and bailouts from the Federal Reserve after the 2008 financial meltdown, according to public sources and published reports.

And nine of Romney's top 20 campaign contributors are big Wall Street Banks like Goldman. But Goldman leads all Romney contributors, having donated \$367,200 to his campaign, according to the Center for Responsive Politics.

Six of those nine top contributors received over \$161 billion in taxpayer bailouts, reports ProPublica, the independent, Pulitzer Prize-winning investigative organization.



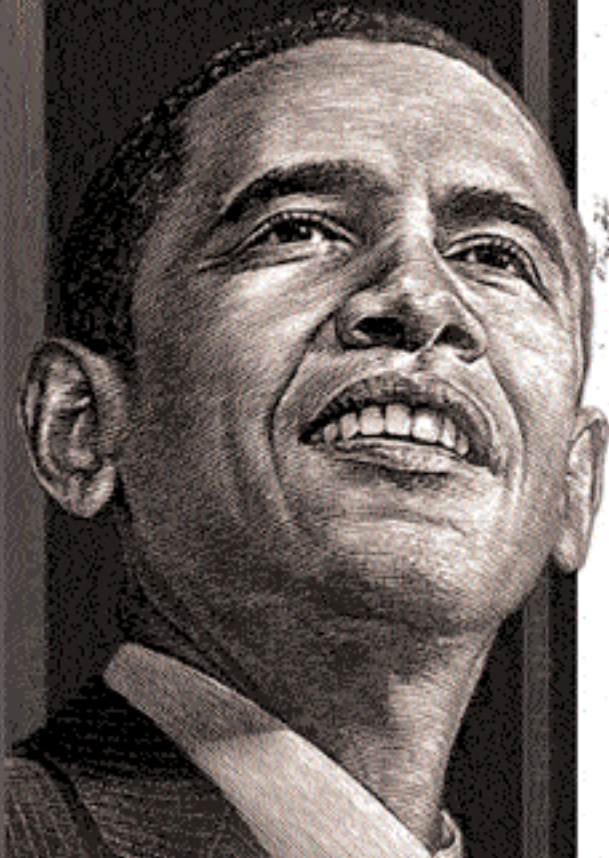
