“Puna” saved my life!

Mona Wampler is alive today because of her three loyal dogs who barked warnings to her about the fire that had started at a new gasoline generator that was running in her garage at her Hawaiian Homestead farm in Hoolehua. She was unable to extinguish the fire, called 911, and fled outside where she collapsed just outside the door because of a medical condition. Mona remembers hearing a big explosion, likely one of the 55 gal gasoline barrels, and being hit by something. Next she remembers being awakened by her loyal dog “Puna”, who was licking her face and pushing her to roll away from the now raging fire. She rolled a few feet, but fainted again. “Puna” persisted in licking Mona’s face and pushing her until she was nearly 75 feet away from the burning house. Neither Mona nor her life saving dog “Puna” suffered any serious physical injuries. Unfortunately, her two chijuaejas died from smoke inhalation. “Puna protected all the animals,” said Mona and her daughter Donna hope to build a new house. Mahalo to Kawila for her kokua!

Airline I.D. Checks Upheld by Federal Appeals Court

A federal appeals court on Thursday rejected the constitutional arguments of a Citizen who had refused to show identification or undergo an especially rigorous search before boarding an airplane.

John Gilmore of San Francisco declined to show ID or submit to a more intense search than other passengers when trying to board a Southwest Airlines flight July 4, 2002, from Oakland International Airport to Washington, D.C. When barred from the flight, he tried to take a United Airlines flight the same day from San Francisco International Airport, with the same result.

The regulation requiring ID at airports is deemed "Sensitive Security Information," the government contends, so Gilmore has never been able to see a copy. TSA denied this American Citizen the right to see the law that is being enforced against him!!!! MAKAAALA!

His lawsuit claimed the government's refusal to disclose its identification policy's content means the policy is vague and violates his constitutional right to due process of law. And by being kept off his flight, he claimed, the government and the two airlines violated his rights to travel, be free from unreasonable searches and seizures, freely associate, and petition the government for

redress of grievances.

But 9th U.S. Circuit Court of Appeals Judge Richard Paez ruled the identification policy imposes no criminal sanctions on those who don't comply; it just keeps them from boarding commercial flights. That negates Gilmore's due-process claim, Paez wrote.

Conviction overturned in airport "threat" case

"The state Supreme Court has overturned the conviction of a man found guilty of threatening to bomb Seattle-Tacoma International Airport in 2001, saying the jury that heard his case was given incomplete instructions. Tracey Johnston appealed his conviction, contending the jury that heard his case wasn't offered the legal definition of a 'true threat.' The Supreme Court, in a ruling released Thursday, noted that the state statute that covers bomb threats applies only to true threats -- those likely to be carried out." Deputy King County Prosecutor Jim Whisman said Johnston, who served nine months in jail after his conviction, will be retried.

The case stems from an incident on May 2, 2001,

when Johnston and another man were drinking alcohol they had brought aboard an Alaska Airlines flight. A flight attendant told them that personal alcohol wasn't permitted on the flight and confiscated an alcoholic beverage from the men. A Seattle police officer who met the flight arrested Johnston. During his arrest, Johnston said he would return to the airport with "a Ryder truck and some nitro diesel fuel," court papers said.

The Supreme Court said in its reversal of conviction, a true threat is a serious threat, not one said in jest, idle talk, or political argument.

"We have adopted an objective standard for determining what constitutes a true threat: A true threat is a statement in a context or under such circumstances wherein a reasonable person would foresee that the statement would be interpreted ... as a serious expression of an intention to inflict bodily harm upon or to take the life ...," according to the court. Otherwise, it would be overly broad and could criminalize free speech."

New Book Release:

BROKEN TRUST

*Greed, Mismanagement, and Political Manipulation at
America's Largest Charitable Trust*

Authors: Samuel P. King & Randall W. Roth

Princess Bernice Pauahi Bishop was the richest woman in the Hawaiian kingdom. Upon her death in 1884, she entrusted her property -- known as Bishop Estate-- to five trustees in order to create and maintain an institution that would benefit the children of Hawai'i; Kamehameha Schools. A century later, Bishop Estate controlled nearly one out



of every nine acres in the state, a concentration of private land ownership rarely seen anywhere in the world. In 1995 the Wall Street Journal called it the nation's wealthiest charity, with an endowment estimated at 410 billion -- greater than that of Harvard and Yale combined. In August 1997 the unthinkable happened: Four *kupuna* revered in the native Hawaiian community and a professor of trust law publicly charged Bishop Estate's trustees with gross incompetence and massive trust abuse. Titled "Broken Trust," the statement provided devastating details of rigged appointments, violated trusts, and the shameful involvement of many of Hawaii's powerful.

This book brings to light information that has never before been made public, including accounts of secret meetings and communications involving Supreme Court justices. The authors also show in vivid detail, how the scandal was swept under the rug by a judiciary that did not want a public airing of its dirty laundry, how Princess Pauahi's will has been systematically violated, and why the violations may continue. The book throws a spotlight on the legislature, the courts, the legal profession, the native Hawaiian community, and the media, showing how each functioned--or failed to function-- during the two-year crisis and its aftermath. **BROKEN TRUST** offers readers the opportunity to reexamine the fundamental questions about unchecked power and civic responsibility that resonate far beyond Hawaii.

USA Run by Criminal SYNDICATE

U.S. Rep. Cynthia McKinney said that it was doing the government a favor to describe them as a "criminal syndicate." "It appears to me that our country is literally being hollowed out....our economy is being hollowed out," said McKinney.

McKinney shared Alex Jones' fears and those previously voiced by Republican Congressman Ron Paul, that Americans may be arrested and taken to forced labor camps in light of recent developments confirming Kellogg Brown and Root have secured a government contract to build the camps.

Regarding 9/11, McKinney lent credibility to the 9/11 truth scholars who recently came forth with empirical evidence proving that the official story is a fallacy.

"It's clear that something was terribly amiss on that day with our people who were in charge....they didn't even follow standard operating procedure," said McKinney and the Congresswoman agreed that US authorities stood down on 9/11.

Covering the subject of worldwide human trafficking and sex slavery, a practice embraced by Dyncorp and lobbied for by Halliburton subsidiary representatives, McKinney responded by saying, "they steal elections with the same ease that they steal women and little girls."

McKinney highlighted the MK Ultra program as a past example of where the US government had experimented with turning US soldiers into killing machines and expressed her sadness that some troops were apparently under a similar influence in light of the alarming incidents at Fort Bragg.

McKinney is spearheading a movement to have all records pertaining to the death of Martin Luther King released. McKinney said that King was clearly murdered.

"A jury said in 1999 that it was a US government conspiracy, including the highest individuals at the highest levels of the United States government. I have no reason to disbelieve them."

"If they would do that then to Martin Luther King Jr. at a stage now where we have a law that defines enemy combatants, we all could be enemy combatants just by dissenting from what this administration does and they could do the same thing to us."

McKinney scorned the federal government for their actions following Hurricane Katrina.

"The American people were once again abandoned, they were abandoned by their own government and Secretary Michael Chertoff has gotten off scott free on this."

"They needed food and water and instead they were sent men with guns and Blackwater mercenaries were hired to patrol the streets of New Orleans. This is criminal! How can we have mercenaries patrolling the streets of America?"
