## Federal Supremacy Clause Smackdown

When Idaho Governor C.L. ## Hanamatsuri Celebrated At Molokai Biddhist Temple

Sunday, March 28, Molokai Buddhists celebrated Buddha Day, also called "Hanamatsuri" or "flower festival". The legend tells of the events at the time of Prince Siddhartha's birth now celebrated around the world on April 8. The Hanamido or miniature floral altar of bright flowers signifies the Lumbini Garden where the Buddha was born. The statue of the baby Buddha with one arm pointing to heaven and one to earth illustrates the merits of Buddha reaching out to all beings. The pouring of sweet tea on the statue represents the gentle rain that fell in Lumbini Garden and bathed the baby Buddha. For over 2,500 years, Buddhists around the world have celebrated the birth of Buddha who, guided by wisdom and vitalized by compassion continues to inspire to the ultimate meaning of life.



Reverend R. Kokuzo, from the Waipahu Soto Mussion first led everyone in the singing of "Happy Birthday, dear Buddha". He told the story of Hanamatsuri and also gave the message of Spring Ohigan, the changing of the seasons and the six Paramitas. The service was emceed by Trevor and Trenton Takata, sons of Guy and Lisa Takata. Refreshments were followed by Buddha Bingo!

Though celebrated early here, Hanamatsuri will be celebrated by all the Buddhist sects in Honolulu on April 4 at Honpa Hongwanji Betsuin at Pali Hwy.

## State Sovereignty vs. Obama's Socialism Federal Supremacy Clause Smackdown

Idaho and the thirty seven other States considering similar legislation have a strong case based on the original intent of the powers of the federal government vis-à-vis the States.

The so-called "supremacy clause" of the Constitution, found in Article 6, states, "This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding."

The key, of course, is the federal laws trump state powers IF the federal laws are made in pursuance of the Constitution, or the law is clearly enumerated as a federal power. In other words, the federal government is supreme in all areas clearly listed in the Constitution for the United States of America.

A quick reading of the Constitution illustrates that national healthcare is not one of the enumerated powers of the federal government. DUH !!

The inclusion of such a clause in the Constitution was first debated at the Constitutional Convention on 31 May 1787. In order to avoid taking away the powers of the states... James Madison, the author of the Virginia Plan, wished the national legislature to be supreme in all cases. But he was not in the majority. To most of the assembled delegates, the national government was not the benign center of the political universe, more of a threat to freedom as was Britain, and the States retained their sovereignty. Hugh Williamson of North Carolina emphatically stated he "was against giving a power that might restrain the states from regulating their internal police."

Thus, the federal government was Constitutionally allowed to be supreme only in its enumerated powers defined there in, and it did not have a negative over State law. Federal Supremacy was given its limits. If Congress, under pretence of executing one power, should, in fact, usurp another, they will violate the Constitution and the new law will be void. [e.g., ObamaCARE; gun control, etc]

But many felt the Constitution still vested too much power in the central authority. The States demanded an amendment to the Constitution that expressly maintained the sovereignty of the States and placed limits on federal power. Even several moderate supporters of the Constitution embraced this idea.

Ultimately, the three most powerful States in the Union, New York, Massachusetts, and Virginia, demanded that a bill of rights be immediately added to the Constitution; near the top of those recommended amendments on every list, a State sovereignty resolution. These ultimately became the Tenth Amendment to the Constitution, which reads, "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people."

Clearly the intent of this amendment was to mitigate any design the federal government had on enlarging its powers through the "supremacy clause." If the power was not enumerated in the Constitution and the States were not prohibited by the Constitution from exercising said power, then that power was reserved to the States or to The People United States Citizens.

Today, socialist Duke Law Professor Neil Siegel said, "Any talk of nullification [against ObamaCARE etc] bothers me because it's talk of lawlessness."

I guess Mr. Siegel has failed to consider that Idaho bill HO391 was passed by a legitimate legislative body elected by the people of the State. That would make it lawful. [And Hawaii should be expediting such nullification laws, too !]

The original intent of both the "supremacy clause" and the Tenth Amendment indicate that Idaho and the other States challenging Obamacare are justified and correct and that the legal professionals are either in the tank for the federal government, as usual, or have not read either the debates of the Constitutional Convention and/or the State ratifying debates. This should make people like Engstrom and Siegel, rather than legitimate State law directed at unconstitutional authority, irrelevant. **[OBAMA: Huka wai i ke pili !]**
