Sign Behind the Machine Says Sunday Mass, But The St. Sophia Church Building Was Removed April 6, 2010

Built in 1937, Kaunakakai's St. Sophia Church building was damaged in February by a fire of unknown origin during the planning phase for demolition and replacement with a new much larger church. Suddenly, by noon April 6, the lot was vacant. It was a shocking sight, leaving some people crying at the loss of their beloved house of worship, others happy the new church building can move forward, and some head shaking poho that recycling of so much heavy lumber in good condition was just destroyed instead of carefully removed for recycling, maybe as a fundraiser to help finance the construction of the new church building.

The Sunday Mass sign behind the machine means services may be held in the adjacent building also owned by the local parish.

Saint Sophia church was the largest of four Catholic churches on Molokai's "topside" said Patrick Downes, spokesman for the Diocese of Honolulu. "It's an old parish church like many we have in the Islands," Downes said. The Blessed Damien Catholic Parish plans a new, larger church be built later this year.

State DHS Offices to be Closed

The Department of Human Services announced on Monday that it will lay off 228 workers, close all but two offices on all islands, and automate the system for processing applications and renewals for welfare and Medicaid and the Food Stamp Program.

A manifestation of the Clinton/Bush/Obama Economy, the current recession has caused the demand for public assistance welfare has climbed, and DHS officials say the automation of the process will result in faster benefit help and costsaving efficiency.

Specifically, the DHS plans to close 31 offices statewide and consolidate the jobs into two facilities in Honolulu and Hilo that will be called the Eligibility Processing and Operations Division. The layoffs will begin on June 30.

"We wish it was not necessary to layoff any of our employees, but we can't expect taxpayers to continue supporting our current eligibility processing system that is disbursed throughout 31 different offices. The current system is antiquated, inefficient, intensive, costly and slow," DHS Director Lilian Koller wrote.

People in need of financial assistance will be able to apply for benefits online and over the phone using the new system. The move will save the state \$8 million annually, officials said.

But, Federal officials say they are worried about fraud and the accuracy of eligibility determinations under the phone/computer system. In a letter to the state earlier this month, an official with the federal food stamps program voiced those concerns and also quoted federal regulations which require face-to-face interviews with any household that requests one. And he wanted to know how the state will meet this requirement, since it's keeping just one office open on Oahu and the Big Island and closing 31 offices at all the other neighbor island and Oahu locations.

Interdisciplinary Therapeutic Activities Class

A new program, Interdisciplinary Therapeutic Activities Class (ITAC) in its first semester at the Molokai Education Center recently heard about the Maui County Commission on Disabilities. Molokai Commissioner, Linda Liddell was a guest speaker at one of the class sessions. She and Charlotte Seals, are the two Molokai representatives who attend monthly meetings on Maui. Linda described the work of the Commission who advocates for barrier-free accessible public facilities for the disabled, such as wheelchair ramps, automatic doors and sidewalks. She said the Parks and Recreation Department has been actively improving sites, enabling access for disabled with new walkways such as at the Kalaupapa Lookout.

The seventeen students in the class, some who are Certified Nurse Assistants, others in training and others interested in working especially in future positions as Therapeutic Aides were also interested in the medical history and coping with her disability that Linda shared during her short talk.

The ITAC program is coordinated by Jodie Diener and her assistant Nahiwa Naki at the Molokai



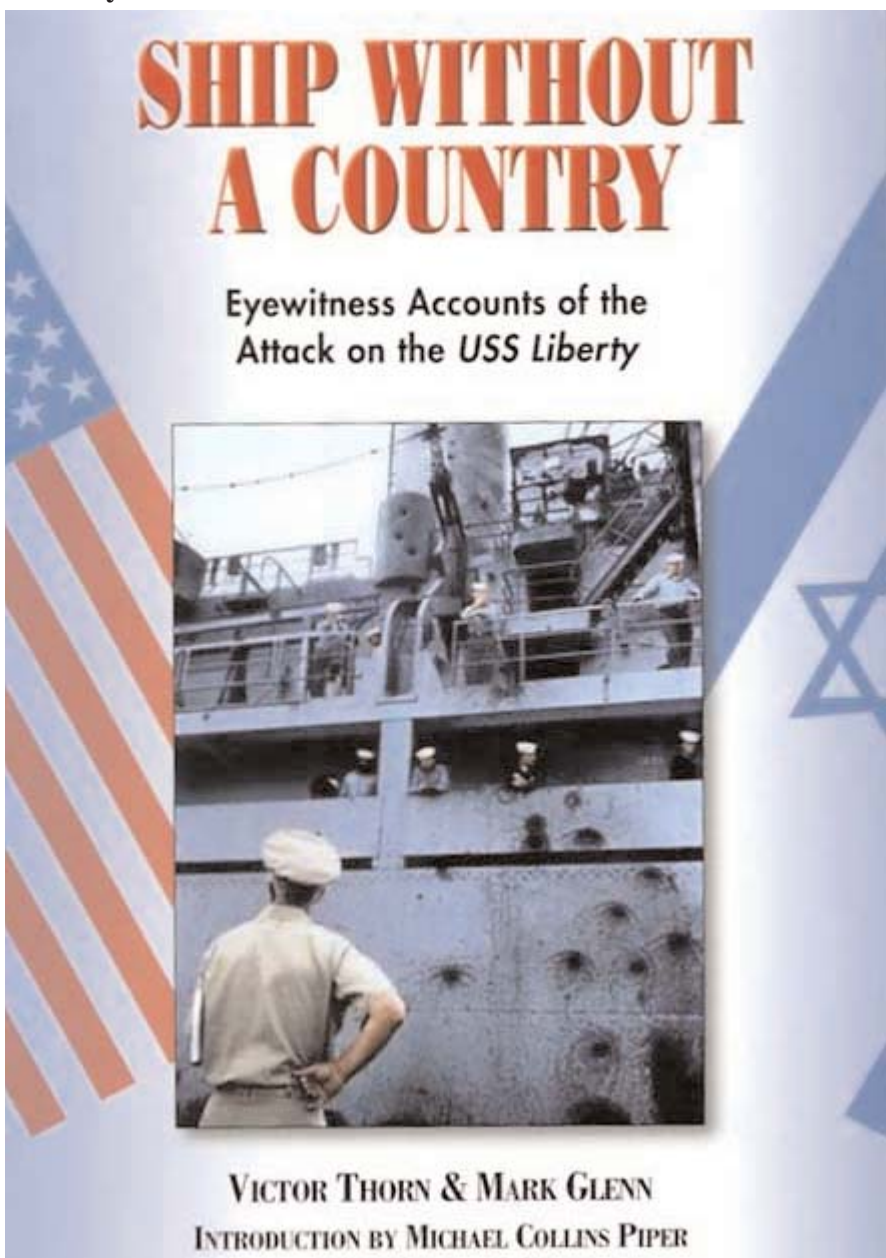

Community Rural Health Association also known as Waiola o Hina. MCC - Molokai Education Center is the education component of this program which includes a psychology and sociology course taught this first semester with Dr. Nita Bogart and Dr. Richard Rodriguez. The ITAC class is taught by Susan Peabody, and Frances Nishioka, Occupational Therapists. This summer, an Anatomy and Physiology course taught for the first time on the island, will prepare the students for more medically focused training as Therapy Aides. Physical Therapy and Speech Language Pathology classes will follow in future semesters.

Look for these ITAC students at the April 16 Senior Fair and at the Na Pu'uwai 10K Run in May.

The republicbroadcasting.org news says Israeli warplanes carried out at least 13 overnight air strikes on Palistinians' Gaza Strip, injuring three children on Good Friday. The US supplied F16 fighter jets were hovered over the enclave, launching a series of successive strikes in southern Gaza Strip towns of Rafah and Khan Younis and in Gaza City.

Four of the strikes took place near the town of Khan Younis, BBC reported.

Israeli fighter jets regularly launch attacks on the beleaguered Gaza Strip, which has been blockaded since mid-June 2007.

On Tuesday, the Israeli army tanks crossed into the coastal sliver's southern Qarara region, before invading Dair al-Balah in central Gaza and being confronted by rock throwing Palistinians.

The Israeli strikes are at their highest level in more than a year.

U.C. Berkeley Students Stop Financial Support of Jewish War Crimes

On March 18, continuing a long tradition of pioneering human rights campaigns, the Students of U.C, Berkeley passed "A Bill In Support of UC DIVESTMENT FROM WAR CRIMES." The historic bill resolves to divest ASUC's assets from two American companies, General Electric and United Technologies, that are "materially and militarily supporting the Israeli government's occupation of the Palestinian territories"—and to advocate that the UC, with about \$135 million invested in companies that profit from Israel's illegal actions in the Occupied Territories, follow suit.

Hawaii Legislature on Gun Confiscation: SB358 now Is Time to Approve it !

Hawaii Must Recognize the "Right to Bear Arms"—Always
Hawaii Legislators now have to decide on this GREAT BILL:

SECTION 1. Chapter 134, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

"§134- Prohibition against seizure of firearms or ammunition during emergency or disaster; suspension of permit or license. (a) Notwithstanding any provision of chapter 128 or any other law to the contrary, no person or government entity shall seize or confiscate, under any civil defense, emergency, or disaster relief powers or functions conferred, or during any civil defense emergency period, as defined in section 128-2, or during any time of national emergency or crisis, as defined in section 134-34, any firearm or ammunition from any individual who is lawfully permitted to carry or possess the firearm or ammunition under part I of this chapter and who carries, possesses, or uses the firearm or ammunition in a lawful manner and in accordance with the criminal laws of this state.

(b) Notwithstanding any provision of chapter 128 or any other law to the contrary, no person or government entity shall suspend, revoke, or limit, under any civil defense, emergency, or disaster relief powers or functions conferred, any lawfully acquired and maintained permit or license obtained under and in accordance with part I of this chapter.

(c) For purposes of this section, "government entity" means any unit of government in this state, including the State and any county or combination of counties, department, agency, institution, board, commission, district, council, bureau, office, governing authority, or other instrumentality of state or county government, or corporation or other establishment owned, operated, or managed by or on behalf of this state or any county."

The Congress in 2006 passed Public Law 109-295 sec 706 called the Prohibition on Confiscation of Firearms by federal agencies...etc, so that is good.

Sounds great! Hope Hawaii approves that bill, because, by the end of June, the U.S. Supreme Court is expected to decide, in McDonald v. Chicago, whether the Fourteenth Amendment prohibits state governments and their subdivisions from encroaching on the "right to keep and bear arms" that the Second Amendment guarantees to United States Citizens. The origin and purpose of the Fourteenth Amendment and its relationship to the Second Amendment is clearly this: Securing the Right to Keep and Bear Arms.

Drawing upon legislative debates, Congressional hearings, and newspapers and law books from the years following the Civil War, shows that both supporters and opponents of the Fourteenth Amendment (1868) believed that it protected all Bill of Rights guarantees--especially the Second Amendment--from infringement by the states. From the Freedmen's Bureau Act of 1866 to the Supreme Court's decision in United States v. Cruikshank (1876) and beyond, history is proof that the Constitution for the United States of America is intended to guarantee and perpetuate and enforce our right to keep and bear arms.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

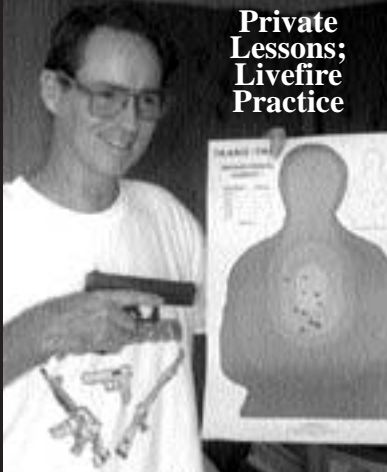

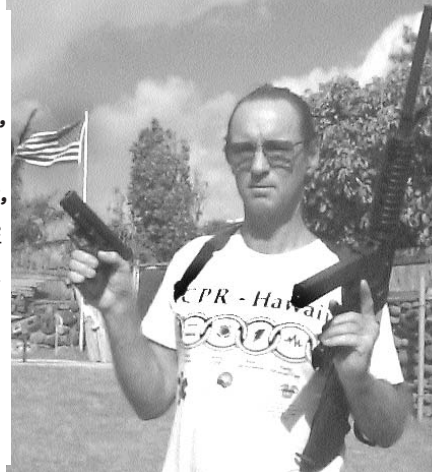

NOAA's Hawaiian Islands Humpback Whale National Marine Sanctuary will host public meetings to launch the public engagement segment of the sanctuary's management plan review. The Molokai meeting is May 14, 2010, at Mitchell Pauole Center, starting at 6 pm.

The public will have the opportunity to comment on sanctuary management and issues and suggest new directions for the sanctuary. "The public is encouraged to participate in these meetings that will help inform them about current sanctuary activities, the process of management plan review and how public input is integrated into design of the sanctuary management plan," said Naomi McIntosh, sanctuary superintendent.
