Obama's War on Drugs

Police in Columbia are reporting death threats as the video goes viral and Internet message boards grow bloated with angry, outraged comments. As of Friday morning, the YouTube video had been watched more than 500,000 times. A whopping 593 comments Thursday night, the vast majority critical of police, many downright hostile, and for good reason: Police abuse of authority in USA.

The SWAT team hit the home of Jonathan Whitworth, 25, with a search warrant alleging he was holding a major amount of marijuana and was a drug dealer. They found a pipe, a grinder, and a small amount of marijuana. Along the way, they shot their dogs, killing one of them, shouted profanities at the frightened family, and generally behaved as if they were raiding a murderous gang of illegal aliens.

Of course, the Police claimed they shot and killed a pit bull because it was "acting in an uncontrollably aggressive manner," but while the video shows barking, it shows no growling. No reason was given for shooting and wounding the second dog, a little Corgi. And, police said they were unaware that a child resided at the home. Between the bad intelligence indicating they had a major drug bust and the bad intelligence regarding who lived at the target residence, the police actions exemplify a fascist trend in its procedures and a local judiciary inclined to rubber stamp search warrant applications. [This is why the 2nd Amendment right to keep and bear arms was included in the Bill of Rights: shoot fascist INTRUDERS !]

Jonathan Whitworth was arrested on minor marijuana possession and drug paraphernalia charges. His wife and son are traumatized for life, his dogs are dead and maimed, his life ruined. Why?

Remember, back in 2004, Columbia voted to make adult marijuana law offenses the lowest law enforcement priority. Somebody should mention that to the Columbia police department and its out-of-control SWAT team.

In contrast, the Washington, D.C. city council approved legislation to allow medical marijuana use their city, though with very strict controls. And, International Marijuana Marches take place May 8, from Auckland to Austin and from Madison to Missoula, marijuana supporters call for legalization. Cures Not Wars activists in more than 320 cities across the planet take the local initiative in their own communities. In some places, particularly Canada and New Zealand, marchers come out in the thousands. Reports from Europe and Latin America are that most marches there will take place the following weekend, with large crowds expected in Buenos Aires and Mexico City.

Back in Obama's Police State Amerika, a leaked copy of Obama's new drug policy 2010 from the Office of National Drug Control Policy aka the drug czar's office, repeatedly stresses the importance of reducing supply of drugs into the United States through crop eradication and interdiction efforts, international collaboration, etc. The bottom line here is that Obama's 'non war on drugs' will still look and feel like a war on drugs under Barack Obama.

"There is no recognition that they aren't very effective and do more harm than good. Coming only a couple of weeks after the drug czar testified under oath that eradication had no impact on the availability of drugs in the US, to then put out a strategy embracing what he said was least effective is quite disturbing."

Akaka Tribe: 73% of Hawaiians NOT "Qualified" for membership

You may be Hawaiian—but chances are you are not "Qualified" to become a member of the allegedly "Hawaiian" Indian Tribe proposed under Neil Abercrombie and Dan Akaka.

If created under US law, the Akaka Tribe will negotiate to take control of land and other assets in Hawaii which are supposedly the property of all native Hawaiian people—but the majority of native Hawaiians will be excluded from participating in the organization of the Native Hawaiian Interim Governing Council. They could remain excluded from the Tribe that the Interim Governing Council organizes.

On one hand, Section 4(a)(4) of the Senate Akaka Bill states: "Native Hawaiians have an inherent right to autonomy in their internal affairs (and) inherent right of self-determination and self-governance the right to reorganize a Native Hawaiian governing entity...."

But Section 8(a) recognizes only: "The right of the qualified Native Hawaiian constituents to reorganize the single Native Hawaiian governing entity...."

Who are allowed to become "Qualified Native Hawaiian Constituents" will be determined by a "commission" of nine members. FYI: There are exactly nine OHA Trustees.

"Qualified Native Hawaiian Constituents" is a brand new classification which has not been used in any previous version of the Akaka Bill. Only these so-called "Qualified Hawaiians" may participate in electing the Native Hawaiian Interim Governing Council. This Interim Council will propose rules for the Tribe as a whole, -- including rules about who may or may not become members. Since a smaller Tribe means more money for each individual member and easier control by political cronies a bias will exist in favor of keeping as many Hawaiians as possible out of the tribe. Many mainland Indian tribes have cut down their tribal rolls by changing the rules of membership in order to grab a larger share of gaming revenues for each of the remaining members.

The Interim Council is itself considered an Indian Tribe according to Section 10(c) and so it operates under the same Federal Indian Laws which have allowed several California gaming tribes to expel hundreds of members in a grab for gambling profits.

Under the conditions set forth in S1011, Section 3(12), for an Hawaiian to become a "Qualified Native Hawaiian Constituent" all five of the following conditions must be met:

(A) Must be direct lineal descendant of

indigenous people living in Hawaii on or before January 1, 1893 or of a person eligible in 1921 for Hawaiian Homelands.

(B) Wishes to participate in the reorganization of the Native Hawaiian governing entity

(C) is 18 years of age or older;

(D) is a citizen of the United States; and

(E) maintains a significant cultural, social, or civic connection to the Native Hawaiian community, as evidenced by satisfying 2 or more of 10 criteria

Part (B) most likely means excluding all persons who do not sign up for Kau Inoa. The December, 2009 Kau Inoa News proudly announces: "Those who register in Kau Inoa will help shape the Hawaiian nation to come."

The 2000 US Census counted over 401,000 Hawaiians in the US. The Kau Inoa number is less than 27% of all Native Hawaiians, but it gets worse.

Rule (E) excludes many of the roughly 122,000 Hawaiians living outside of Hawaii. Exceptions are made for college students, military personnel, federal employees (such as Congressional staffers) and their dependents, Hawaiian Homelands beneficiaries, their children and grandchildren.

Qualification in Part (E) is membership in a Native Hawaiian Membership Organization, but does not contain a list of such organizations.

The last rule could "Qualify" people who have no Hawaiian ancestry: (x) If regarded as a Native Hawaiian and whose mother or father was regarded as a Native Hawaiian by the Native Hawaiian community, as evidenced by sworn affidavits from 2 or more qualified Native Hawaiian constituents certified by the Commission.....". These rules are allegedly designed to avoid creation of a Tribe whose membership is designated simply by race--without regard for any affirmative affiliation to the tribe.

The Akaka Tribe as proposed will be dominated by the corrupt political operators who looted Kamehameha Schools and much of Hawaii's corrupt political and business dealings.

The so-called Sovereignty movement has absolutely no continuity with the Hawaiian Kingdom whose political resistance ended with the disintegration of the Home Rule Party after Prince Jonah Kuhio Kalaniana'ole agreed in 1902 to represent the Territory of Hawaii as a Republican in the US Congress.

Black Patriot Loves His Guns, Hates Obama



Black United States Citizen Patriot Chris Broughton loves his guns and hates President Obama — so much, in fact, that he believes the president belongs in hell. He's not too fond of George W. Bush, either.

Broughton made headlines in August 2009 when he showed up outside an Obama rally in Phoenix with an AR-15 assault rifle slung over his shoulder and a pistol holstered on his waist, becoming a hero to many in the "Patriot" movement in the process. He said he carries his guns habitually.

Broughton, apparently assuming that the Obama Administration planned gun control measures, said he wanted to make a point about the right to own guns. "The overwhelming statement I was trying to make was whether you like it or not, my guns aren't going away," said the Phoenix machinist. "They're going to be here until you kill me and take them away."

He claims that some news broadcasters edited video footage of the scene to hide his race (he's black) when reporting on the racist backlash to Obama's election. Presumably, he felt that was part of an effort to paint Obama's critics as racist.

Broughton is a member of We the People, a Patriot tax protest group that has played a central role in the resurgence of the militia movement. He also belongs to the Faithful Word Baptist Church in Tempe. That's the church where pastor Steven Anderson told the congregation in August 2009 he would pray that Obama dies and goes to hell. Broughton said he believes there is a hell, and that it was made for evil people – folks like Obama, both former Bush presidents, House Speaker Nancy Pelosi and leaders of the Southern Poverty Law Center.

"Barack Obama is responsible for more death than my guns ever will be," Broughton said. "He could end so much suffering immediately, and instead he uses his power to force his agenda. I do hate him."

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

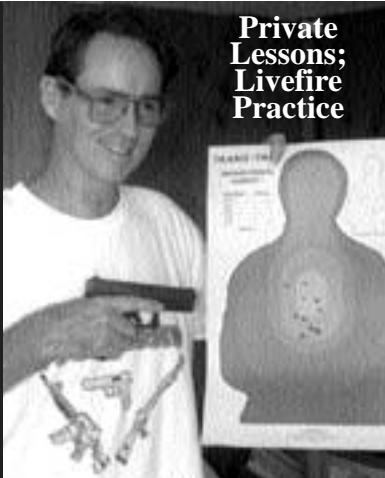

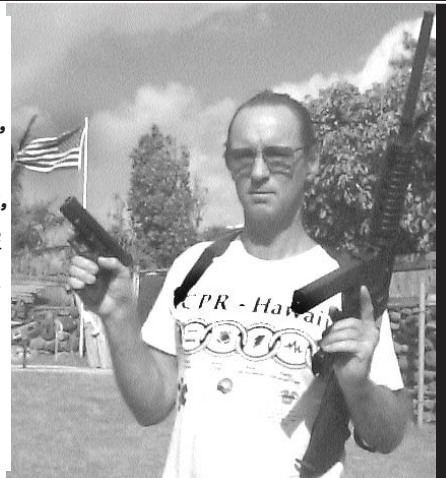

Maui County Real Property Tax Sale Auction May 25

WAILUKU, Maui, Hawaii-- The County of Maui, Department of Finance, Real Property Tax Division announced it will hold a real property tax sale auction for parcels with delinquent accounts. The properties on the tax sale list owe a combined total of \$420,646 in delinquent taxes, penalties, interest and administrative costs. Properties being sold have been delinquent for three or more years and have received a final notice of tax sale.

The tax sale will be held at the Kihei Community Center located at 303 E. Lipoa Street in Kihei, on Tuesday May 25, 2010 and will continue on May 26, 2010 if necessary. Doors will open at 8:30 a.m. with opening remarks at 9:00 a.m. and the auction beginning at 9:30 a.m.

As of May 5, 2010, 24 properties have been scheduled to be sold at the tax sale auction. Properties will be removed from the tax sale list if all taxes, penalties, interest and costs have been paid in full prior to the date of the sale. In some cases, a payment plan agreement may be granted.

Information on the tax sale including a list of the properties being sold and frequently asked questions can be found on the County of Maui website at www.mauicounty.gov/finance. The tax sale list and frequently asked questions have also been posted at the Real Property Tax Division office located at the Maui Mall Service Center, Kalana O Maui (County building), Hoapili Hale (Judiciary building), Molokai Real Property Tax Office (Mitchell Pauole Center in Kaunakakai, Molokai) and the Lanai Senior Center (309 7th Street, Lanai City).
