## Jews Demand Compensation from Palestinians ? !

Embattled and increasingly isolated after the murderous attack on unarmed passengers of the Humanitarian Flotilla to Gaza by the Jews Military from Israel, a group of politicians are now proposing a bill that would outlaw boycotts against the Jewish State, and force oppressed and starving Palestinians to pay.

"The Land of Israel", a right-wing parliamentary lobby group committed to Jewish settlement of the West Bank, submitted the bill with the support of 25 politicians from right wing and centrist parties. If approved, it could force the Palestinian Authority (PA) to pay thousands of dollars in compensation to Jewish businesses affected by the Fayyad-led boycott campaign. The boycott calls for Palestinians to shun all products made in the Jewish settlements, most of which sit on expropriated Palestinian farmland and are regarded as illegal.

The move comes amid a growing global backlash against Israeli policies, which has intensified since Israel launched its bloody raid on a Turkish-led humanitarian convoy trying to breach the blockade of the Gaza Strip two weeks ago.

Even before the flotilla affair, a campaign to persuade artists and authors to protest what they describe as an illegal and oppressive military occupation of the Palestinian territories was gaining ground. "Merely having your name added to a concert may be interpreted as a political act... and it may be assumed that one has no mind for the suffering of the innocent," Costello said prior to the raid.

After last week's deadly raid on the flotilla, US rock band The Pixies cancelled their gig set up by the Jews. Several other bands have followed suit, prompting Israeli music promoter Shuki Weiss to complain that performers are waging a form of "cultural terrorism".

Human rights activists, meanwhile, decried efforts by politicians to alienate those critical of Israel with new legislation. "We have wild right-wing politicians presenting wild demagogic bills ... which create a very nasty public atmosphere," said Adam Keller, spokesman for Gush Shalom, an Israeli NGO that has joined calls for a boycott of Jewish settler-made goods. "If this is passed into law, it would mean a total breakdown between Israel and the PA."

Israel has condemned Mr Fayyad's boycott campaign as harmful to the fragile peace process, and Israeli settler leaders have urged the government to respond with harsh retaliatory measures against supporters.

Should the proposal gain traction in its current form, it would force boycotters to pay compensation to settlers who claim their business had suffered. It would also affect foreign citizens calling for a boycott of Israel, potentially barring them from Israel for 10 years.

But activists said attempts to muzzle peace activists would make the movement stronger. "No Knesset laws can stop this tide of non-violent, morally consistent struggle for justice, self determination, equality and freedom," political activist Omar Barghouti said in a statement.

Fayyad, an economist, has provided the boycott campaign with fresh impetus in recent weeks, putting it at the heart of a peaceful resistance movement aimed at winning over international support. The boycott calls for Palestinians to shun all products made in the Jewish settlements, most of which sit on expropriated Palestinian farmland and are regarded as illegal under international law.

The PA has also barred Palestinians from working in the settlements as of the end of this year, an unpopular move only slightly eased by the promise of a \$50m "dignity" fund designed to help workers make the transition. The PA has threatened those who fail to comply with fines.

The Jewish settlements, which sit atop the West Bank hills, have long been a thorn in the side of the peace process. Palestinians have maintained that as long as Jews are grabbing Palestinian land in the West Bank, Israel cannot be committed to a two-state solution.

"If I were a Palestinian, I would certainly join the boycott that is being imposed on the settlements and their products," wrote Yossi Sarid, a commentator in liberal Israeli newspaper Ha'aretz. "After all, it would not be human to expect me to buy my tombstone from people who were determined to bury my hopes for a good life and independence."

Israeli Minister of Minority Affairs, Avishay Braverman, who is responsible for Israel's Arab population, said the boycott was a diversion from the pressing need for direct peace talks between the Israelis and Palestinians. US-sponsored efforts have brought both sides back to talks, but not in the same room.

"This boycott will have no real impact on Israel, but will harm Palestinian workers," said Mr Braverman, a former World Bank economist.

It may be hard to find Israel-made products in Hawaii to boycott. One obvious target, not here yet, will be one of the darling electric vehicle projects embraced by Zionist Linda Lingle and DBEDT. "Better Place" is an Israeli company that Lingle wants to manufacture electric vehicles and charging stations to be used in Hawaii. Jewish owned "Better Place" has installed charging stations at illegal settlements in the West Bank. Palestinians themselves are not allowed to use those roads. Highway 443, is a road used by thousands of Jewish commuters daily and through the occupied West Bank, but the Jews have banned Palestinians whose land and villages the road traverses from accessing it, reserving it effectively for Jews only. Prior to Israel's seizure of the road, it had been a main artery for Palestinian traffic south of Ramallah.

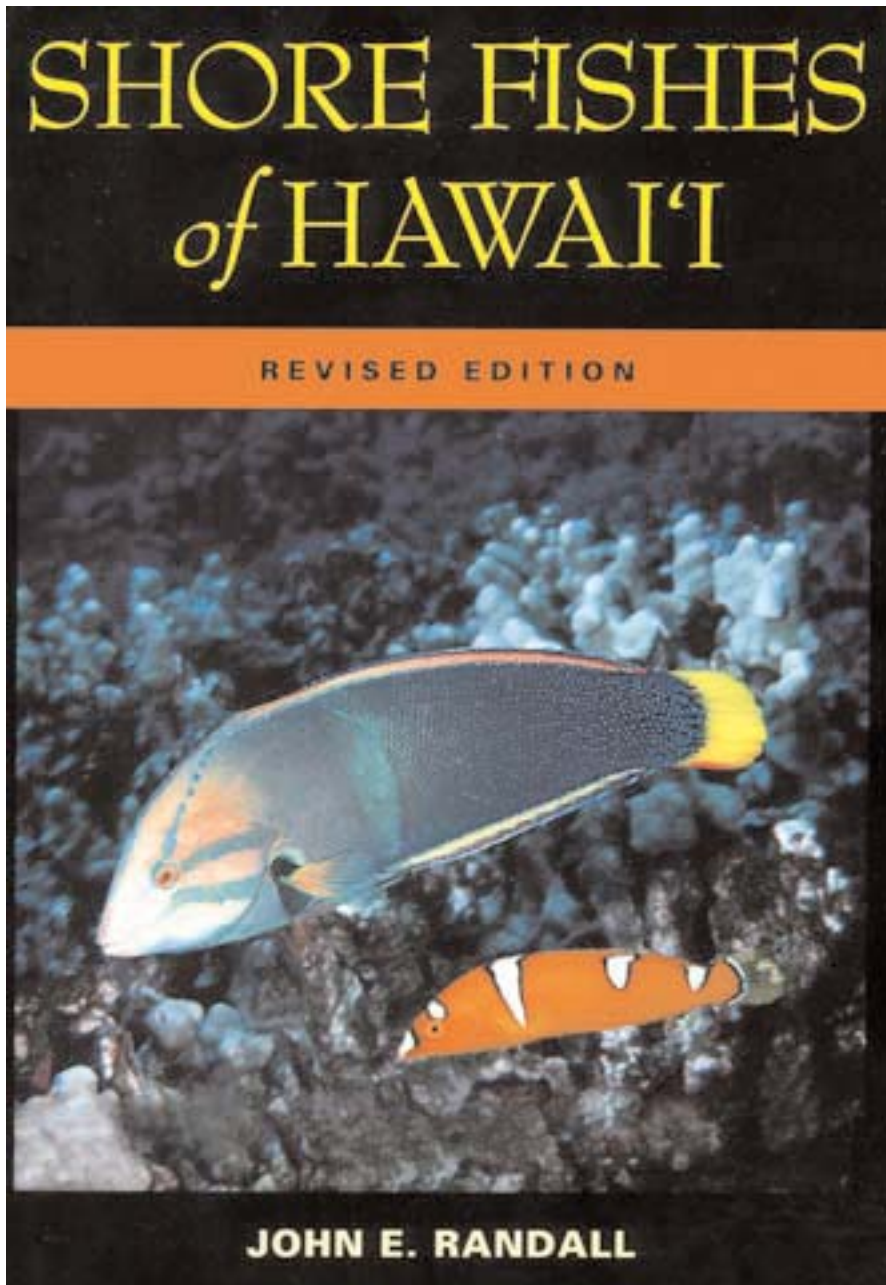

## Shore Fishes of Hawai'i

Revised Edition

Author: John E. Randall

This new edition of Shore Fishes of Hawai'i updates our knowledge of Hawaiian fishes and has been expanded to include 372 species. All are illustrated by the author's 475 superb photographs. The most important characteristics to identify a fish are given as well as the size attained and its distribution. Each species account begins with the American common name, followed by the Hawaiian name (when known), and the scientific name in italics. Because it is necessary to use some scientific terminology when giving the principal diagnostic characteristics of families or species of fishes and what they eat, a handy glossary appears at the back of the book before the Index.

Sharks, rays, eels, bonefish, squirrel fish, gobies, wrasses, dragonets, blennies, butterfly fishes, sea chubs, goat fishes, angle fishes, surgeon fishes, barracudas, armorheads, knifejaws, parrot fishes, damsel fishes, flounders, Hawaii's fishes are some of the wide variety of forms, sizes. The foremost authority on tropical fishes, Dr. Randall has organized this scholarly text for ocean lovers, fishermen and outdoor explorers. This is a resource book for every home library. ## Jews force reporter Helen Thomas to Resign



The "grande dame" of the White House press corps -- the almost 90-year-old Helen Thomas of Hearst Newspapers -- was caught by Rabbi David Nesenoff on video stating Israelis should "get the hell out of Palestine" and "go home ... to Poland, Germany and America and everywhere else," in response to his request of her to offer her thoughts on Israel. ## Legislature Passes Law Prohibiting Gun Seizures When Emergency Powers are Declared by governor

A bill preventing the government from seizing legal firearms during an emergency has been passed by the Hawaii Legislature. The full Senate voted 21-0 to approve the measure after it already passed the House. The proposal prohibits the seizure of firearms or ammunition when the government invokes emergency powers during a disaster.

It gained momentum after February's tsunami warning, when lawmakers said their constituents asked if their weapons could be taken in an emergency situation.

Gun-rights activists have pursued this kind of law since Hurricane Katrina, when New Orleans police confiscated guns in an attempt to restore order.

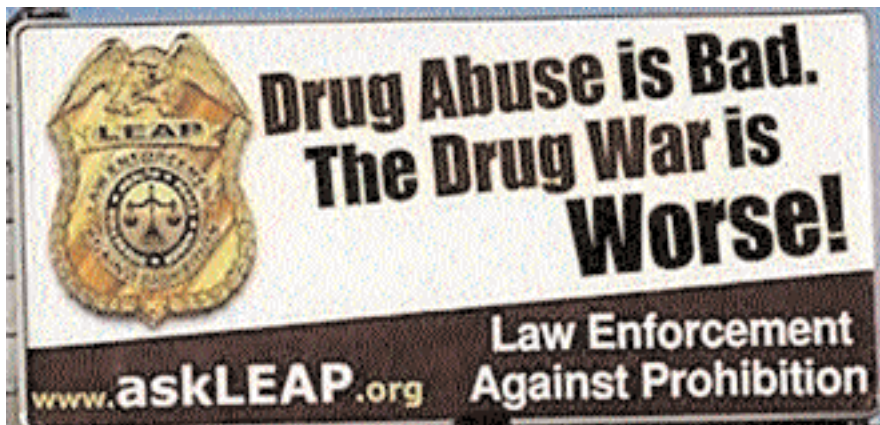
