## 8-attacks on Natural Born Constitutional Requirement. Why? Paving the Way for Obama-TREASON!

There were eight attempts by members of Congress during the years 2003 and 2008 when socialist community organizer Barry "Barack" Obama was developing his power base in his home state of Illinois, to remove the Constitution's requirement that a president be a "natural-born citizen." Why? Clearly, the evidence suggests an organized strategy to pave the way to the Office of President of the United States for someone who is not a Natural Born American citizen.

Evidence shows that Barry Sotero aka Barack Obama, Jr., was born 1961 in Kenya, Africa to an underage white American mother and his black Kenyan father Barack Obama who had knocked her up at U.H. Manoa East West Center where they met about 9-months earlier before returning to Kenya. Documentation for his video comes from a variety of congressional records showing that beginning June 11, 2003, and continuing through the most recent effort, Feb. 28, 2008, there were eight congressional proposals targeting that constitutional requirement for Natural Born American Citizenship for POTUS.

June 11, 2003, Rep. Vic Snyder, brought HJR 59. It was intended to "permit persons who are not natural born citizens of the United States, but who have been citizens of the United States for at least 35 years, to be eligible to hold the offices of president and vice president." Why would he do such a thing?

Sept. 3, 2003, Rep. John Conyers, brought HJR67, which would have done the same as Snyder's, but with residence requirement lowered to 20 years. Why?

Feb. 25, 2004, Sen. Don Nickles, brought S.B. 2128 to "try to counter the growing Democrat onslaught aimed at removing the natural born citizen requirement." But he defined Natural Born Citizen only as someone who was born in and subject to the United States, instead of born to parents who are Citizens.

Sept. 15, 2004, Rep. Dana Rohrabacher, brought HJR 104, "to make eligible for the office of president a person who is not a natural born citizen of the United States but has been a United States citizen for at least 20 years." WHY?

Jan. 4, 2005, Conyers, again, HJR2, the same as Rohrabacher's. WHY?

Feb. 1, 2005, HJR15, Rohrabacher, again, to require only 20 years citizenship to be eligible for the office of president. **WHY? WHY?**

April 14, 2005, Snyder, HJR42, requiring 35 years' citizenship. Why?

Feb. 28, 2008, Sen. Claire McCaskill, tried to attach to SB 2678, Children of Military Families Natural Born Citizen Act, an amendment confusing "natural-born citizen". Sen. Obama and Sen. Hillary Clinton, were sponsors.

In 2006, just two years after Obama was elected Senator, attorney Sarah Herlihy of Obama's Chicago-based finance committee advocated elimination of the Constitutional Natural Born Citizen requirement for POTUS just months before Obama announced in 2007 his candidacy for POTUS. She called the requirement "stupid" and outdated and undemocratic. Apparently she knew Obama is not a Constitutionally qualified Natural Born American Citizen.

April 10, 2008, "unable to alter or remove" the requirement, the U.S. Senate changed the focus of the issue, with Senate Resolution 511, about Sen. John McCain's qualifications as a "natural-born citizen."

**Obama's qualifications for POTUS never were reviewed. WHY?**

After his election to POTUS, Obama held a closed unlawful meeting with eight of the nine justices of the U.S. Supreme Court. The unlawful ex parte meeting was held in spite of legal challenges in which Obama is a defendant pending before the Supreme Court. The attorneys for the plaintiffs were excluded, too.

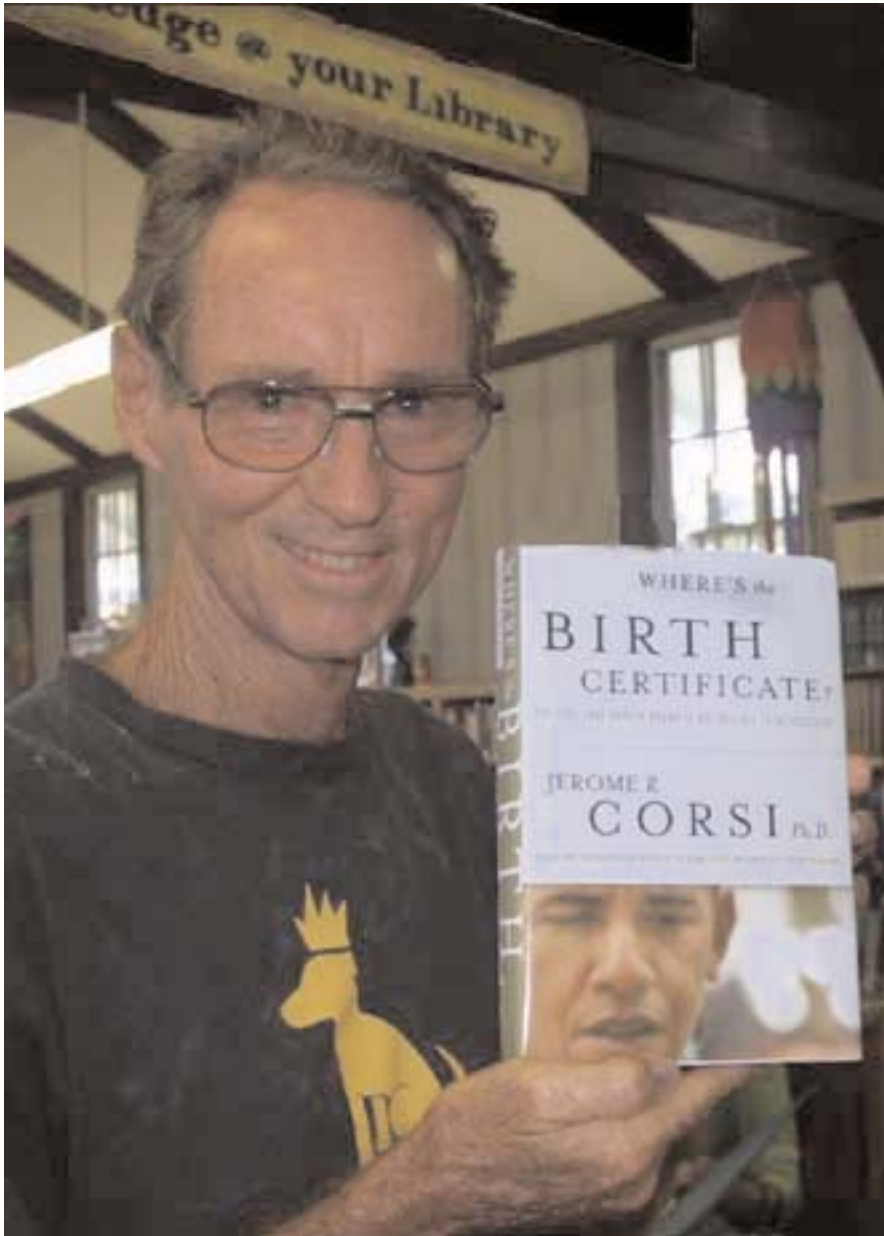

# Molokai Library Book Explains Why Millions Suspect Obama Not A Natural Born Citizen, not Eligible to be President of United States

When Obama released the purported long-form certificate, officials in the Hawaii Department of Health and governor's office refused to simply confirm to WND that the image being presented by Obama was an accurate representation of the records maintained by the state.

Valley said the document should "thoroughly be analyzed by FBI officials and analysts to determine if in fact and validate whether it's forged or real."

"One of the apparent flaws in that document was they listed Kenya as the place of birth of Obama's father, but Kenya was not an established country by that name at that time," he noted.

"There's still a lot of controversy about it, and some of us would just like to have this thing clearly authenticated. Let the truth be known to Americans."

He also cited one of the many issues raised by document experts who have challenged the birth certificate's authenticity — the layering in the Adobe computer file Obama posted online purporting to be a copy of his real birth record.

"That's true, because they don't believe he is eligible. You have a fairly growing contingent out there."

Valley also made similar statements in an online radio program in which he supported Lakin, the Army doctor who refused orders because neither the military nor the White House would document Obama's eligibility. He spent five months in Fort Leavenworth and only recently was released.

"Obama's birth certificate — I've had retired CIA agents and other investigators go over the birth certificate that was produced and by far, 10 out of 10 have said it's a forgery. So we still have that corruptness going on in the White House. There's a great number of organizations and people still trying to find out who Barack H. Obama is, where he was born, does he qualify as president of the United States. We know for sure that the Constitution has been violated in Article 2, particularly when you look at the natural-born status requirement."

**Crimes of Politicians Must Be Stopped by The People (You are The Militia)**



## Perspective: killing cops or criminals? In Bolivia, the Indians know how to defend their homeland from Tyrants and other "Theives in Disguise" criminals

Members of an indigenous community in Bolivia say they have lynched four policemen they called "Theives in Disguise" in the province of Potosi, after they accused the policemen, who belonged to a unit tackling car theft, and extortion.

In a public meeting, five groups of Aymara and Quechua Indians, known as the Warrior Clans, said they had killed the four officers on Sunday.

"Brothers, we did not kill police officers, we killed thieves disguised as police officers," one local leader is reported as telling the gathering.

Clan members said the police had been charging between \$200 and \$1,000 in exchange for turning a blind eye to the smuggling of cars from Chile.

Those gathered voted not to return the bodies of the officers until police hand over seven cars they say were stolen from them by these "Theives in Disguise".

A police chief said the group had threatened to kill anyone trying to retrieve the bodies of the convicted and now executed Theives in Disguise.

They also demanded an investigation into the deaths of four of their members, who they believe were killed by police.

Potosi Police Chief Orlando Avila told BBC Mundo his officers could not enter the area because "there were sharp shooters stationed all along the highway".

The area where the lynchings took place is home to five indigenous communities, each with around 8,000-10,000 inhabitants.

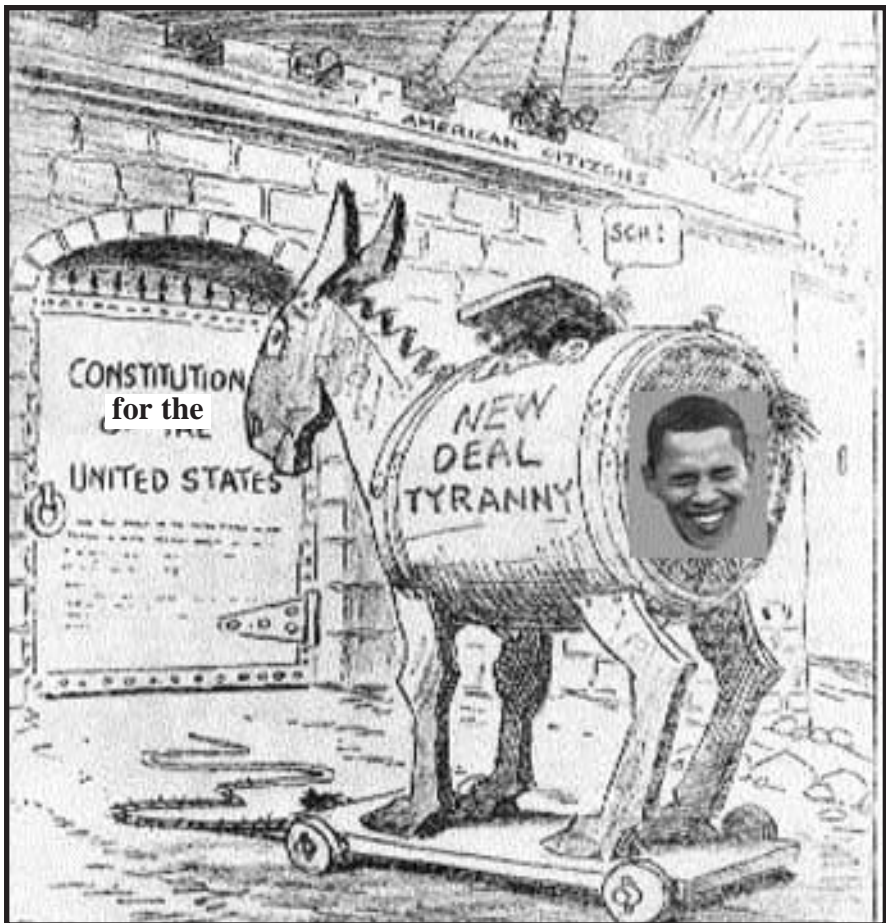

# Contest and Summer Reading List



## Krazy for Kolea Kontest

The kolea, Pacific Golden Plover (*Pluvialis fulva*), is revered in Hawaiian mythology as Koleamoku, a messenger of high chiefs, and was considered to be the embodiment of the god of healing. Kolea on their northern migration may have aided ancient navigators with the discovery of the Hawaiian Islands. Within a few weeks the kolea will make a transoceanic southbound migration between breeding grounds in Alaska to wintering locals as far away as Madagascar. Last year in Hawaii twenty kolea were captured and fitted with light level (daylight measuring) geolocators (data loggers): Birds were tracked at speeds from 36 to 118 miles per hour, and with an average flight between Hawaii and Alaska taking 40 hours.

Earliest returnees to Hawaii are typically females that may have experienced a failed nesting attempt or perhaps did not bond with a mate for the breeding season. Adult males normally appear by the end of August, followed by juveniles in October. The kolea is easily recognized by its bold black & white breeding plumage called 'alternate', however, this is lost by winter. Kolea are long-lived (20-plus years), territorial and annually return to the same location. This returning behavior was first recognized by Max Schlemmer on Laysan Island, whose 'Old Stump Leg', a one-legged kolea, returned annually ca. 1900. Many Molokai residents have named their distinguished winter residents and note arrival and departure dates on calendars.

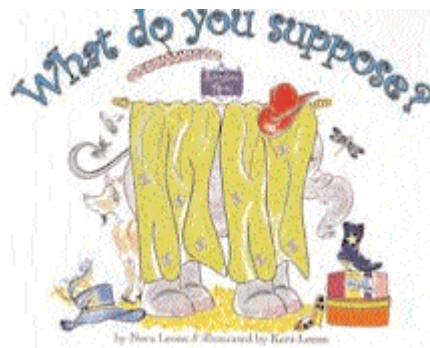
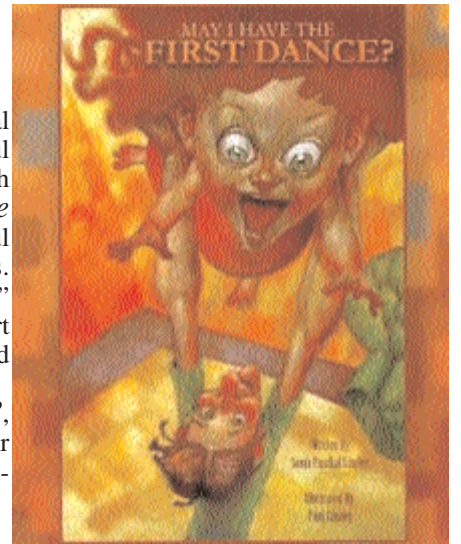

## No Way, Not Me

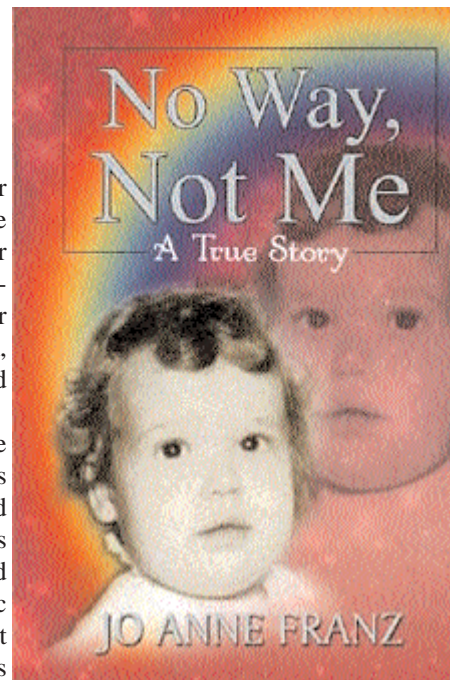
