Molokai Streams Need Water, too!

State Water Commission Abdicates to Plantation Water Demands, Maui Streams Cut to Minimums

With the severe draught on Molokai adding to the diversion of stream flows on Molokai by Molokai Ranch from Central forest, and Kip Dunbar at Kainalu Ranch in the eastend water shed forest, Molokai farmers and businesses and residents are vulnerable to the increasing salt levels in our ground water and shortages. Local people will be denied sufficient water if big landowners and developers are allowed to continue to divert streams like they do on Maui. **MAKAALA !**

At meeting on Maui, the State Commission on Water Resource Management issued its final ruling in the long-running battle to restore water flow to four major streams on Maui known as Nā Wai 'Ehā, or "The Four Great Waters" of Waihe'e River and Waiehu, Iao, and Waikapu Streams. The final decision was issued more than a year after a proposed decision in April 2009 recommended restoration of 34.5 million gallons a day (mgd) to the streams, or about half of the total stream flow of 60 to 70 mgd. In the final decision, a majority of the Commission, with one Commissioner dissenting, decided to reduce the amount of restoration to only 12.5 mgd and left two of the four streams, Iao and Waikapu, in their completely dewatered state, without restoration of any flow. This 12.5 mgd is even less than the 16 mgd one of the diverters, Hawaiian Commercial & Sugar (HC&S), a division of Alexander & Baldwin, Inc. (A&B), had argued as a last-ditch alternative to the initial recommendation.

"This is a miscarriage of justice and it will not stand," said Earthjustice attorney Isaac Moriwake, "In the 21st century, the Commission majority is still letting plantation politics, rather than the law, rule our most precious resource." Earthjustice represents Maui community groups Hui o Nā Wai 'Ehā and Maui Tomorrow Foundation, who initiated this legal action six years ago, in June 2004, to restore flow to Nā Wai 'Ehā streams to support native stream and nearshore resources and community uses such as traditional wetland kalo farming.

The dissenting Commissioner, Lawrence Miike, J.D., M.D., issued a strongly worded opinion, criticizing the majority for turning the Commission's public trust responsibilities "on their heads," leaving the streams mere "leftovers," and treating streams as "reservoirs for future offstream uses." "By this decision, the majority has failed in its duties under the Constitution and the State Water Code as trustee of the state's public water resources," he concluded. [Miike served as the Hearings Officer in this case and presided over the administrative trial that involved dozens of witnesses and hundreds of pages of exhibits and briefs. He also cited the Waihole Ditch case on O'ahu, in which the Hawai'i Supreme Court strongly reaffirmed that flowing streams are a public trust resource and reversed the Commission twice for failing to provide sufficient protection for instream flows.

John Duey, President of Hui o Nā Wai 'Ehā explained that "Hui members are shocked that the Commission majority re-wrote the final decision based on politics, not the law, and over the strong objection of the only Commissioner to sit through months of proceedings and review all of the evidence. Even though the Commission majority was swayed by plantation pressure, we believe the law and history will vindicate us."

Two private companies drain the streams dry: (1) HC&S, and (2) Wailuku Water Company which sold all its former farmlands for development and is now pursuing the business of selling the diverted stream water for urban development. During closing arguments on the Commission's proposed decision in October 2009, HC&S dispensed with any legal argument and instead had its manager and A&B's Chief Financial Officer, Chris Benjamin, threatened the shutdown of the plantation and layoffs of all its workers. [Sounds just like Molokai Ranch, to me !]

"Ten years after the Waihole case, the majority of the Commission hasn't learned a thing, except to find new ways to short-change communities fighting for public rights to water." said Moriwake. "In the end, political influence and expediency cannot prevail for present and future generations. [Wake up Molokai !!!]

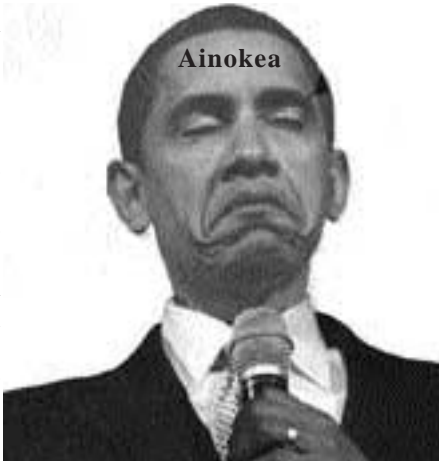

Molokai High Dress Code-Uniform Policy

"Fundamental" Right to Guns

Gun ownership rights of the People as stated in the 2nd Amendment were upheld again in Monday's U.S. Supreme Court Ruling, and supporters of the Constitution for the United States of America have hailed the ruling as a victory. This is the first time the US Supreme Court has offered a clear definition of national significance of the 2nd Amendment's guarantee that right of the People to keep and bear arms shall not be infringed, and orders the lower federal appeals court to reconsider its ruling - leaving little doubt that the Chicago laws will eventually be overturned, and Hawaii's chapter 134 HRS challenged.

In McDonald, v. Chicago, (08-1521) the ruling makes it clear that this does not mean that all laws governing gun ownership in America are immediately void. But Justice Samuel A. Alito, Jr., in the Court's main opinion did make unmistakably clear to lower court judges that the right to have a gun for self-defense in the home is a "fundamental" constitutional right; and that the Second Amendment right of the People to keep and bear arms shall not be infringed applies equally against the federal government and against the states.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

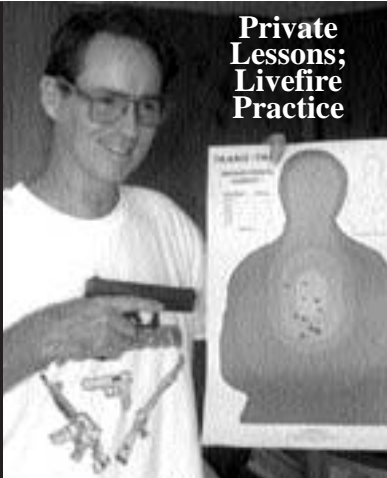

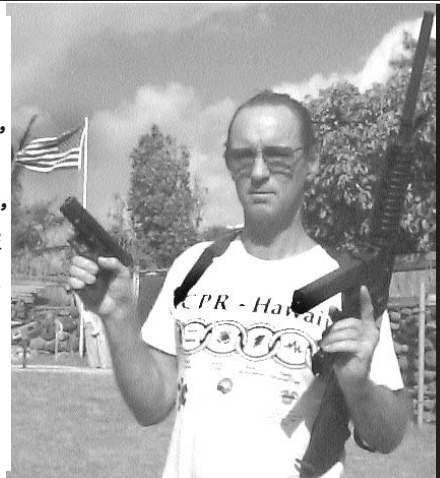

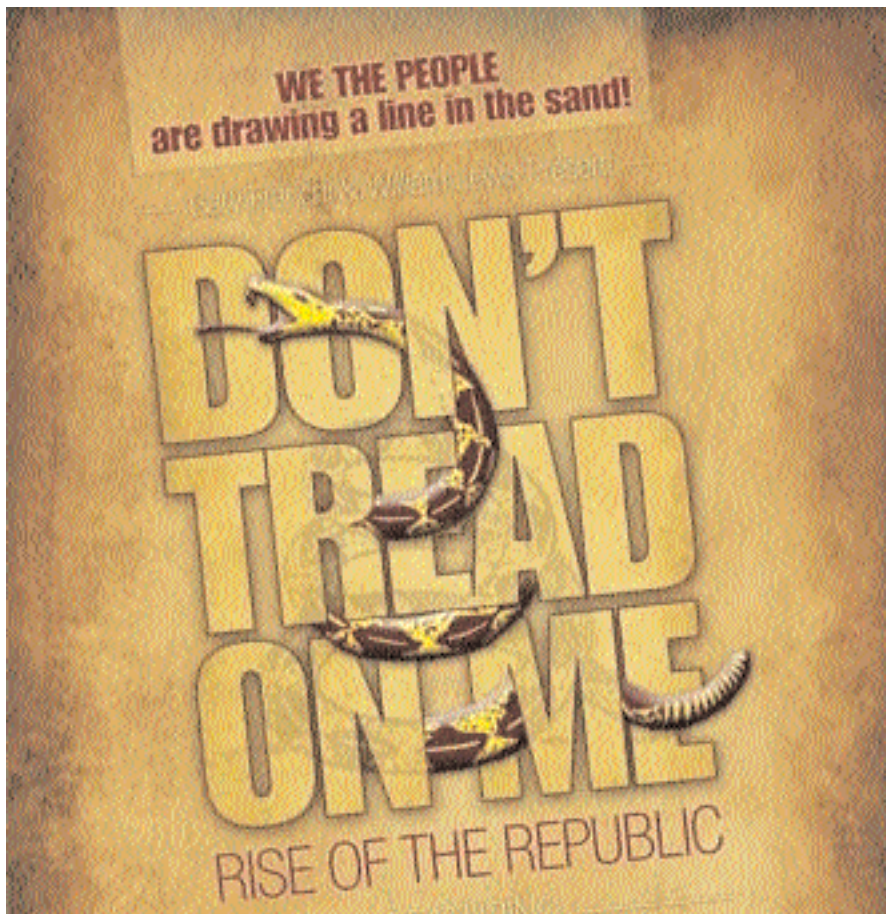

Aliens Illegally Claim Babies US Citizens

The State of Utah residents are complaining that Mexican Nationals and others who illegally reside in their state should not be allowed to claim US Citizenship by birth for their babies. There is a plethora of evidence that pregnant women come across the Mexican border into the USA purposefully to have "anchor babies" so they can claim natural born citizenship and obtain welfare and other benefits. Others get pregnant while in the US, for same purpose.

A list of over 1200 names of suspected illegal immigrants was leaked in Utah to wake up Immigration Authorities. The list includes numerous women who are pregnant, and includes the recommendation that these women be deported immediately to avoid the "anchor baby" claim and privileges paid for by Utah taxpayers. Being on that list is terrifying to illegals fearing deportation.

Anchorbabyism relies on the erroneous interpretation of the 14th Amendment that was ratified in 1868 for the purpose of assuring citizenship rights to the native-born African-Americans whose rights were being challenged because they were recently freed slaves. Obviously, the ongoing anchorbaby citizenship claims by nearly 400,000 Mexicans each year and others entering unlawfully across the Mexican border and residing in Utah and other states is not a valid claim, and Obama Regime should put an immediate stop to it.

Some Obama supporters might say that deporting pregnant women illegally in the USA for the purpose of delivering their anchor baby, and/or for failing to have proof of legal residence and assimilation into American culture/language, is an inhumane manifestation of intolerance, hate, racism. But Utah and Arizona residents lawful treatment of illegals is benign compared with Mexican laws regulations and restrictions and punishments on foreigners.

The Mexican President Felipe Calderon, a good buddy with Obama, will use his laws to bar foreigners if their presence might upset "the equilibrium of the national demographics." Now that is a clearly defined case of racial and ethnic profiling if I ever saw one. But there is more: If outsiders do not enhance Mexico's "economic or national interests" or are "not found to be physically or mentally healthy," they are not welcome in Mexico. Neither are those who show "contempt against national sovereignty or security." They must not be an economic burden on Mexican society and must have a clean criminal histories. Those seeking to obtain Mexican citizenship must show birth certificate, provide a bank statement proving economic independence, pass an exam and prove they can provide their own healthcare. Furthermore, Illegal entry into Mexico is a felony punishable by two years imprisonment in one of Mexico's notorious hells. And document fraud [rampant in USA by Mexicans] is also a prison crime, and so is marriage to an alien for purpose of obtaining citizenship. Evading deportation is also a serious crime, and re-entry illegally after deportation gets a ten years sentence in prison. And, ALL Mexican law enforcement agents are required to enforce immigration laws against illegal aliens. A National Population Registry tracks the identity of every resident of Mexico who must carry a citizen's I.D. card, or they are subject to summary arrest and jailed. And, if a US citizen in Mexico is arrested, remember, protests related to immigration reform in Mexico or pro-illegal aliens speech is prohibited in Mexico. Yet, Calderon demands Obama grant amnesty to 20 million Mexican illegals here!

Consider: Open borders protesters in Arizona marched freely at the state's Capital building, compared governor Jan Brewer to Hitler, waving Mexican flags and advocating Smash the State of Arizona, and Arizona is Our Land, etc. without any police interference. Never happen in Mexico, Senor, as the Mexican constitution prohibits political speech by foreigners and they cannot "in any way participate in the political affairs of Mexico." Don't even mention gun rights!

Obama's illegal alien aunt, a fugitive from deportation for eight years is certainly being treated well in USA, as she awaits a second appeal on her previously rejected asylum claim to stay in American with Barry Barack Obama.
