## Who Protects Maui Boy[11] from Abuser?

RE: Samuel Robinson

Dear Ms. Koller,

It has come to our attention that DHS is once again not supporting 11-year old Samuel Robinson, though his statements have been consistent for over two years, and he recently RAN AWAY from his Abuser. "Professionals" (including CWS) in the case were witness to Samuel curling up in a fetal position, pulling his tshirt over his head, sobbing uncontrollably, and calling repeatedly for his mom. He was inconsolable.

I'm hoping you can answer a few questions that are in the public mind:

1. How does Samuel's severe emotional distress NOT show that something is happening to Samuel in his father's care?

2. How are the eyewitness statements of FIVE SUPERVISORS NOT relevant to what is happening to Samuel?

3. Why were these supervisors NEVER contacted by CWS or DHS?

4. Why did CWS/Maui NEVER contact the Mother before he ran away ?

5. Why is Samuel running away (TWICE) considered irrelevant?

6. Why is Samuel being ISOLATED (no friends) for almost 2-years not an indicator that something is terribly wrong?

7. Why is Samuel saying he is FORCED TO SLEEP IN THE SAME BED with his alleged abuser (and the Abuser admitting to same under oath), not an indicator that something is terribly wrong?

8. Why are Samuel's reports of having NO FOOD in the house, and his Abuser's admission to this in court, acceptable? Having only microwave popcorn for 3-days is obvious neglect.

9. Why is Dr. Margaret Goldberg being consulted when she has had NO contact with Mother for over 2-years, and is involved in illegal billing practices and fraudulent reporting to the court – Conflict of Interest, Violation of Ethics and therapeutic standards, & felonious activity.

10. Why is Dr. Goldberg consulted when she is court ordered to see Samuel ALONE for "individual counseling" but sees Samuel ONLY with his alleged abuser in the room?

11. Why was Mother's therapist NEVER consulted to see if Mother presents harm to Samuel?

12. Why do CWS and DHS say they don't "pick sides" but they have completely ELIMINATED one side, in this case.

13. Why is Mr. Robinson's HISTORY of being in supervised visits for OVER TEN YEARS, with his two estranged children tossed aside?

14. Why is the fact that this SUPERVISED VISITATION was based on sexual abuse, abuse, and neglect allegations by the two children, their therapists, and MULTIPLE evaluations (for which Mr. Robinson was found to be suffering from Narcissistic and Histrionic Disorders, "not therapeutically workable", and therapists cautioned to approach with "great care"), being OMMITED from consideration?

15. How is it that a TOTAL OF THREE children are found "NOT CREDIBLE" by CWS and DHS when the allegations involve only Mr. Robinson?

16. Why is it that Mr. Robinson's CONVICTION on two TRO violations and ADMISSION of guilt on GUN CHARGES (in violation of TRO) does not weigh into the equation when considering Samuel's threats against his Abuser; that he intends to KILL his Abuser (and others).

17. Why are Samuel's statements that he has heard his father say he wants to "KILL" Mother, maternal grandmother and Samuel's pets, pushed aside?

18. Why did Mr. Robinson (the alleged perpetrator) have FOREKNOWLEDGE of internal meetings?

19. Why did Mr. Robinson state assuredly that CWS would take "no further action" and that the "case would be closed", BEFORE Samuel was even returned to him from foster care.

20. Why was Samuel's case NEVER brought before the Court after he ran away, even though Court review is standard procedure?

21. Why was the opinion of Samuel's foster mom (who was DHS's 2009 FOSTER MOM OF THE YEAR), ignored when she said Samuel should be NOWHERE around his father?

22. Why are laws regarding "reunification" with Mother being IGNORED despite Samuel's emotional distress over the prolonged separation from his Protective Parent?

23. Why is Mr. Robinson's ADDICTION to a Class II Narcotic, marijuana and alcohol – all of which are used in front of SAMUEL – being disregarded, especially when Samuel demonstrates and says that his father "crushes and sniffs" his Class II Opiate?

24. Why is Samuel's EXTREME FEAR ABOUT HIS PETS being killed by Mr. Robinson (when in state care), not factored in, when this is one of the obvious indicators of Family Violence?

25. Why is the DRUGGING of Samuel (for extreme emotional distress) by Mr. Robinson (with the assistance of Dr. Goldberg), not factored in?

26. How is Samuel's chore of watering his father's marijuana plants in compliance with state laws?

27. Why was Samuel returned BEFORE an investigation was completed?

We think all the above clearly indicates that SAMUEL IS IN JEOPARDY.

## Streams Must Be restored Now, as Plantations fade out

CITIZENS APPEAL MAUI STREAMWATERS DECISION TO COURTS

Maui community groups Hui o Nā Wai 'Ehā and Maui Tomorrow, represented by Earthjustice, appealed the state water commission's ruling which left Nā Wai 'Ehā, or "The Four Great Waters" of Waihe'e River and Waiehu, 'Īao, and Waikapū Streams on Maui mostly dry. The groups' six-year effort to restore these waters now turns to the Hawai'i appeals courts.

On June 10, a majority of the water commission voted to restore less than a fifth of the streamflows to Waihe'e and Waiehu and leave 'Īao and Waikapū dry. This decision contradicted a proposal from the commission's hearings officer to return about half of the streamflows to the four waters.

The amount restored, 12.5 million gallons per day (mgd), is even less than the 16.5 mgd figure that one of the major private diverters, Hawaiian Commercial & Sugar (HC&S), a division of Alexander & Baldwin, Inc. (A&B), had thrown out as a last-ditch alternative to the proposed decision.

Commissioner Lawrence Miike, who presided as hearings officer over the extensive proceedings, criticized the majority for turning the state's public trust responsibilities "on their heads" and leaving Nā Wai 'Ehā with "leftovers" and "the least protection feasible or no protection at all."

"The commission fudged its decision based on plantation politics, instead of following the law," said Hui o Nā Wai 'Ehā President John Duey. "Now, we must turn to the courts to uphold the law that flowing rivers and streams are a public trust, not a plantation plumbing system."

"The commission failed the public trust and violated the Hawai'i Constitution and Water Code, and we look forward to our day in court," stated Irene Bowie, Executive Director of Maui Tomorrow.

Nā Wai 'Ehā include two of the largest rivers on Maui, Waihe'e and 'Īao, and are legendary in Native Hawaiian culture for traditionally supporting a rich native aquatic ecosystem and the largest continuous area of wetland kalo or taro fields in the Hawaiian Islands. Currently, two private companies drain the streams dry: Hawaiian Commercial & Sugar (HC&S), a sugar plantation owned by Alexander & Baldwin, Inc. (A&B); and Wailuku Water Company (WWC), the remnant of C. Brewer & Co.'s former Wailuku Sugar plantation. Wailuku Sugar sold all its former farmlands for development and is now pursuing the business of selling the diverted stream water to the public.

The community groups initiated this legal action to restore streamflows to Nā Wai 'Ehā more than six years ago, in June 2004. The community groups have sought to enforce the legal mandates the Hawai'i Supreme Court established in its landmark Waiāhole decision in 2000 in which the court strongly reaffirmed that flowing streams are a public trust, and that private diverters have the burden of justifying their diversions.

If justice delayed is justice denied, a six-year wait for some leftover trickles is an insult to justice," said Earthjustice attorney Isaac Moriwake. "We will not

# Obama Allows Jews' Military Occupation of Palestine

You won't see TV or hear radio or read mainstream Zionist controlled newspaper reports about Obama's continued support for Jews military violence against occupied Palestine. Jews bomb civilian targets, cold blooded murder.

Israeli wrecking teams unexpectedly advanced into the city's Arab suburbs and bulldozed six Palestinian-owned buildings; AND, the Obama-Navy stops aid ship destined for Gaza in Palestine.

In the suburb of Zeitoun an ambulance crew member said he saw "about 70" bodies around the compound of the Samouni family before Israeli soldiers drove off the ambulances with gun shots.

As revealed by The Telegraph yesterday, the attack on the home of Wael Samouni is believed to be the bloodiest

single incident of the conflict with Israel shelling a house its army knew to be crowded with around 100 civilians. Mohammed Shaheen, a volunteer with Palestinian Red Crescent, was in the first convoy of ambulances to reach the site of the blast in Zeitoun since it was first occupied then shelled by the Israeli army.

His testimony confirmed accounts, first reported in The Telegraph, from survivors of the extended al Samouni clan who said they feared between 60 and 70 family members had been killed. "Inside the Samouni house I saw about ten bodies and outside another sixty," Mr Shaheen said.

"I was not able to count them accurately because there was not much time and we were looking for wounded people. We found fifteen people still alive but injured so we took them in the ambulances. I could see an Israeli army bulldozer knocking down houses nearby but we ran out of time and the Israeli soldiers started shooting at us. We had to leave about eight injured people behind because we could not get to them and it was no longer safe for us to stay." Mr Shaheen was in a convoy led by a jeep from the International Committee of the Red Cross that made its way past demolished houses to the town of Zeitoun.

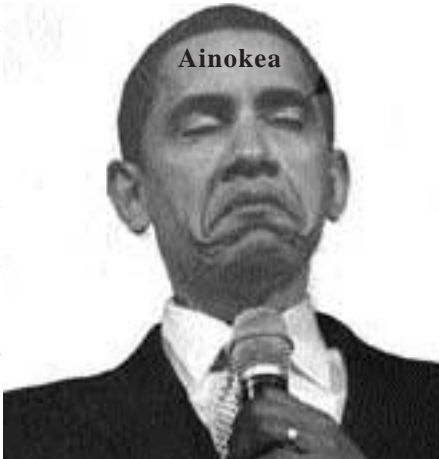
Zeitoun had witnessed massive civilian casualties after surviving members of the Samouni clan reached Gaza City three days ago. They said that after the Israeli army first took the town on Saturday night soldiers had ordered about 100 members of the clan to gather in a single house owned by Wael Samouni around dawn on Sunday. At 6.35am on Monday the house full of civilians was repeatedly shelled with appalling loss of civilian life.

A handful of survivors, some wounded, others carrying dead or dying infants, made it on foot to Gaza's main north-south road before they were given lifts to hospital. Three small children were buried in Gaza City that afternoon. According to the survivors between 60 and 70 family members had been killed.

Convoys of ambulances twice headed to the area to look for wounded but they were driven back by Israeli shooting.

Israeli airstrikes killed 29 Palestinians in Rafah raising the total Palestinian death toll during Israel's 12-day assault to 688 and drove home the complexities of finding a diplomatic endgame for Israel's Gaza invasion. More than 5,000 people have fled the border area so far.

Israel sought to keep up pressure on Hamas by announcing its war cabinet had authorised preparations for a third and more devastating phase of the offensive on Gaza which would involve raids on urban areas.

## Obama's Nomination of Kagan to US Supreme Court Must Be Stopped

Hearings on Elena Kagan to be a justice on the U.S. Supreme Court are over. And, Senate Democrats rushed through quickly, in the same way they did ObamaCare. And, like ObamaCare, they made sure that Senate Republicans would not have the material they needed to review Kagan's record -- withholding, for example, large amounts of Clinton administration legal advice from Kagan on a claim of executive privilege.



What we do know about Kagan is not good, as her government employment history has clearly shown antagonism to the Constitution for the united States.

For example, when it became clear that the Supreme Court might strike down parts of the Brady Act (which it eventually did in 1997), Kagan suggested that President Clinton "by executive order, [might] prohibit a FFL from selling a handgun" without a certification from local police.

In other words, Kagan believed that the President could circumvent the role of Congress and to act unilaterally, without any legal authority, to impose restrictions upon the private ownership of handguns.

Not only that, Kagan drafted a memo for President Clinton suggesting a whole list of guns that could be banned by executive fiat. The Los Angeles Times reported on May 27, 2010, that: "At the time of the [1997] import ban, Jose Cerda, who worked in the domestic policy shop run by Kagan and her boss, Bruce Reed, said, 'We are taking the law and bending it as far as it can to capture a whole new class of guns.'"

Combine all of this with the fact that in 1987 Elena Kagan told her boss, Justice Thurgood Marshall, that she was "not sympathetic" to the plight of an African-American man who wanted to own a gun for self-protection because he carried large sums of cash when depositing money for the laundromat where he worked in Washington, D.C.

Elena Kagan will follow philosophically in the footsteps of Sonia Sotomayor. During her confirmation hearings, Americans were promised that Sotomayor believed the Heller case in 2008 established "that the Second Amendment right is an individual right." But in the recent McDonald case, Sotomayor joined the minority in wanting to both overturn Heller and deny that the Second Amendment protects a "fundamental" right.

So, Justice Sonia Sotomayor lied her way onto the bench. And "cagey Kagan" is doing exactly the same thing. Please make sure you take action!

The Senate Judiciary Committee will probably be voting on the Elena Kagan nomination next week -- which means the proverbial ball is now rolling. So contact your Senators and urge them to oppose Kagan for the U.S. Supreme Court. And please urge your family and friends to do the same.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

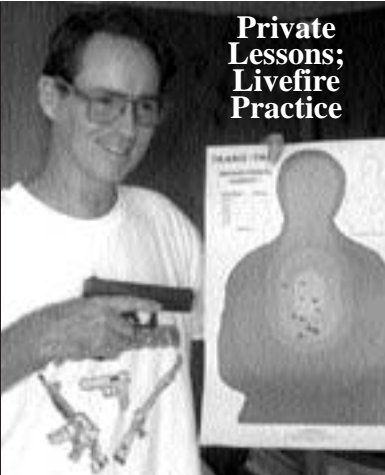

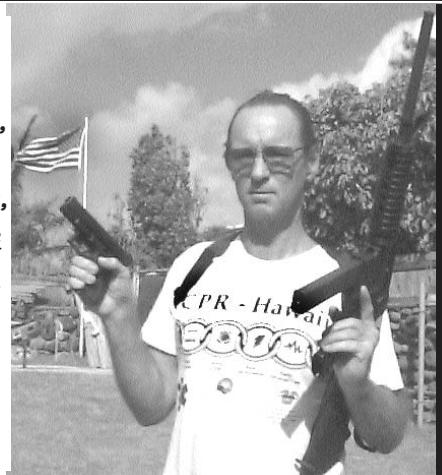

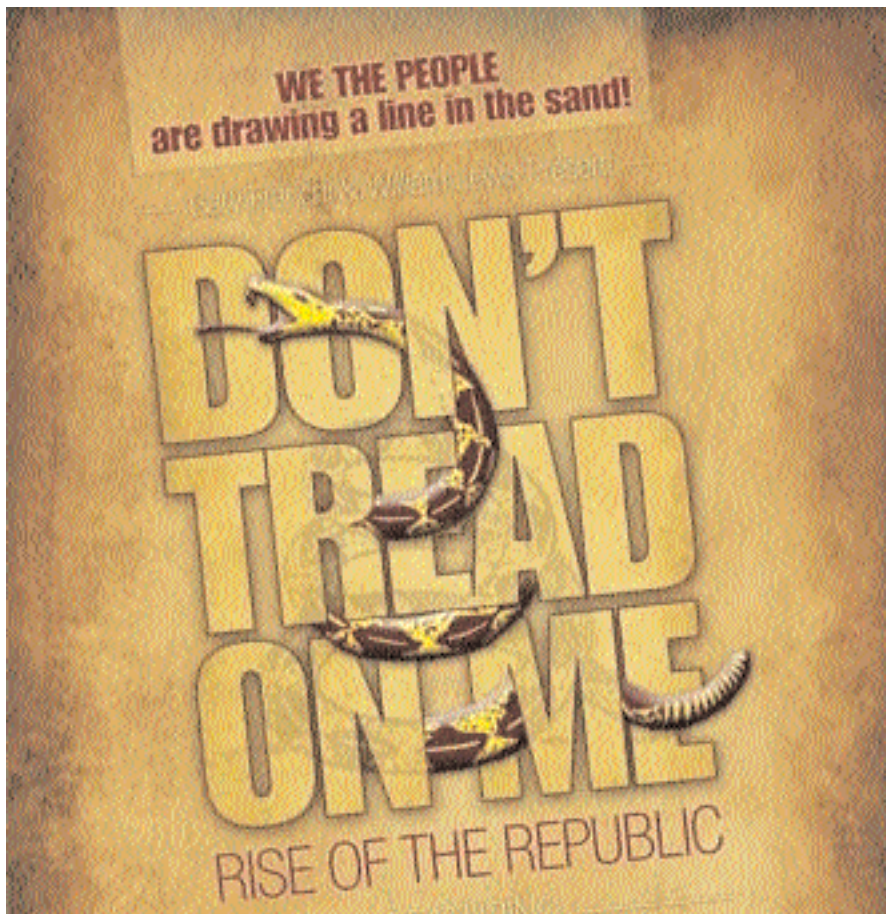

### Jews Attack Palestinians' Homes and Gardens With Bulldozers!

The return of the bulldozers, seen by Palestinians as one of the most hated symbols of Israeli occupation, is ongoing again. The fate of East Jerusalem, which Palestinians regard as their future capital, generates more emotion than perhaps any single issue in the long-running conflict and any attempts to change the delicate demographic balance in the city often provokes uproar.

Jerusalem's Jewish city council, which ordered the demolitions, insisted that none of the buildings it destroyed were houses inhabited by Palestinians.

But that claim appeared questionable, as Dalel Rajabi was not at home when the bulldozers arrived -- she had taken her sick 10-month-old daughter to hospital. The demolition noise roused her sister, who lives next door. According to Linda Rajabi, she was given half an hour to remove vital documents and school work from her sister's house. Just half an hour to move out of her home.

Shortly after the bulldozers finished their destroying the home, Dalel Rajabi returned. As she turned into the lane on which her house had stood earlier in the morning, Mrs Rajabi's knees buckled underneath her and she collapsed in tears.

"We were given no warning," she said, as her nephew salvaged frying pans from the ruins. "Me and my children are now in the street."

Similar scenes unfolded elsewhere in the city, and Mahmoud Abbas, the moderate Palestinian leader, must do something with Israel to protect people.

The demolition could also damage attempts to salvage Israel's historic relationship with the US, which had become strained as a result of the Israeli government's policies confiscating Palestinians' homes in East Jerusalem.

Benjamin Netanyahu, the Israeli prime minister, was to refrain from demolishing Palestinian houses or expanding Israeli settlements in East Jerusalem, which Israel captured in 1967 and later annexed. In March, Israel announced plans to build 1,600 new homes in East Jerusalem contrary to previous commitments to USA.

Mr Netanyahu's government insisted that it had nothing to do with the demolitions or a decision on Monday to build 32 more Jewish homes in East Jerusalem, saying such matters were in the hands of the courts.

"Israel acts in these matters with great sensitivity because we do understand the political environment," said Mark Regev, Mr Netanyahu's spokesman. "As a government we have shown great restraint."

But Meir Margalit, a Left-wing city councillor who has campaigned against Palestinian house demolitions, said his colleagues were intent on ensuring the preservation of a Jewish majority in Jerusalem.

"The idea is to convince Palestinians to leave their homes voluntarily by making life so hard for them that they will move to other places," he said.

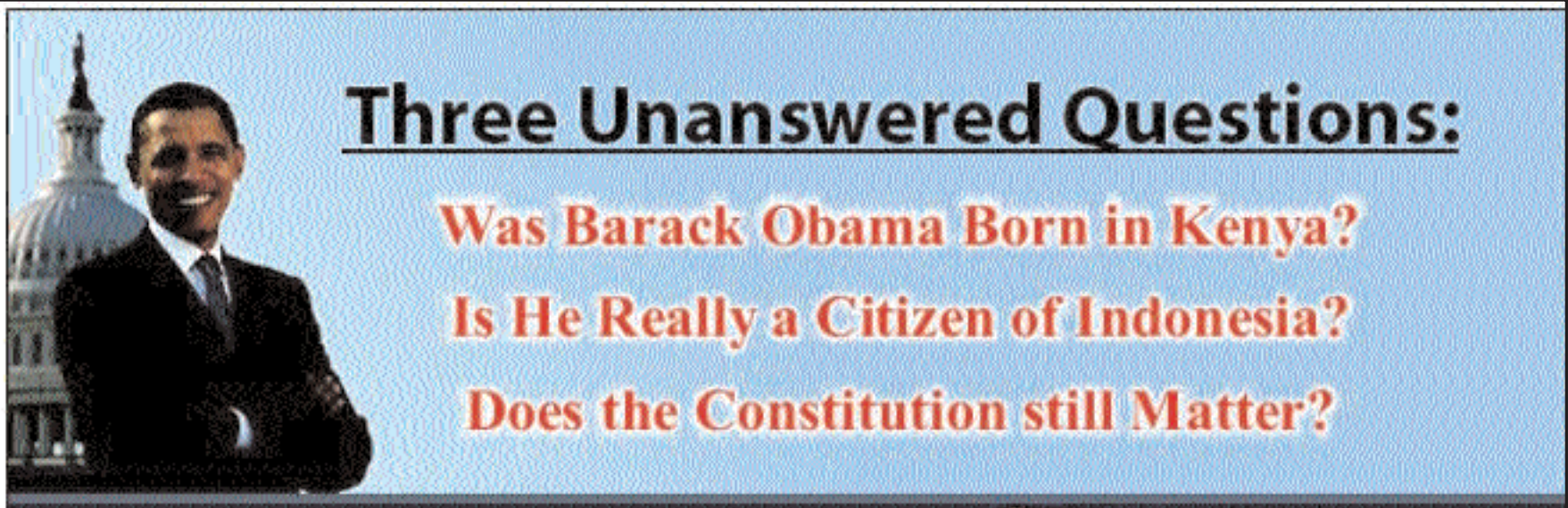

**Electors are sworn to uphold it** with their vote on December 15<sup>th</sup> in the Electoral College. But they must first know for sure that the candidates meet the Constitutional requirements for the office of President beginning with being a natural born citizen.

**Exhibit D: U.S. Law**

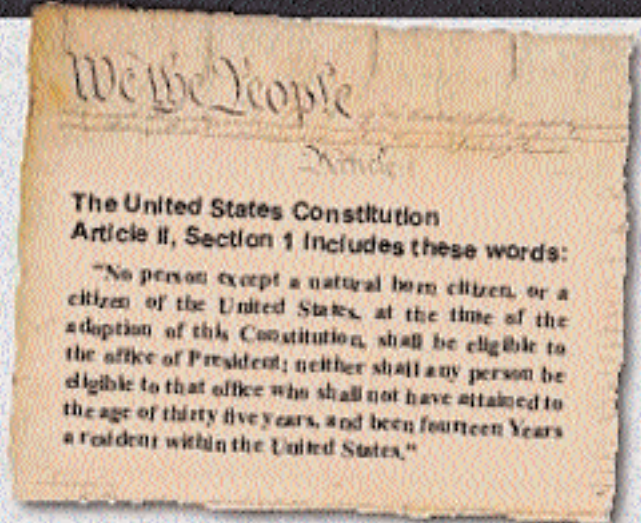

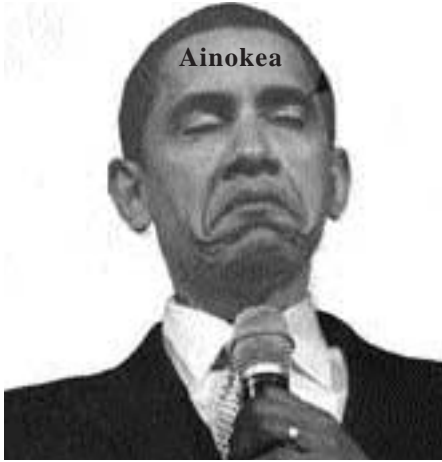

## FBI- tracking Your cell phone ~!

Obama's FBI and other police agencies don't need to obtain a search warrant to learn the locations of Americans' cell phones, says Obama's Department of Justice attorneys who told that to a federal appeals court.

Obama's DOJ attorney Mark Eckenwiler said There "is no constitutional bar" to acquiring "routine business records held by a communications service provider." He added, "The government is not required to use a warrant when it uses a tracking device."

This is the first federal appeals court to address warrantless location tracking, which raises issues of government surveillance and whether Americans have a reasonable expectation of privacy and their location.

Location data can reveal whether people "have been at a protest, or at a meeting, or at a political meeting" and that rogue governments could misuse

that information to arrest people.

Police are tapping into the locations of mobile phones thousands of times a year, but the legal ground rules remain unclear—that is if they ignore the 4th Amendment on privacy.

When the government acquires historical cell location information, it effectively commandeers our cell phones and turns them into electronic trackers that report, without our knowledge or consent, where we have been and how long we have spent there.

Cellphone tracking! Armed Drone planes to kill suspects.....makaala!!!

The Bureau of Alcohol, Tobacco, Firearms and Explosives is asking the court for an order divulging historical (meaning stored, not future) phone location information because a set of suspects "use their wireless telephones to arrange meetings and transactions in furtherance of their drug trafficking activities." It's unclear how detailed this stored information is; there's some evidence that the FBI can use it to narrow down the location to a city block but perhaps not an individual house.

The Obama regime argues that no search warrant is necessary; it says what's needed is only a court order, which requires law enforcement to show that the records are "relevant and material to an ongoing criminal investigation." Because that standard is easier to meet than that of a search warrant, it is less privacy-protective.

Cell phone tracking comes in two forms: police obtaining retrospective historical data kept by mobile providers for their own billing purposes that is typically not very detailed, or prospective tracking--that reveals the minute-by-minute location of a handset or mobile device.

Tracking cell phones can be useful for law enforcement. Agents from the Drug Enforcement Administration in Arizona tracked a tractor trailer with a drug shipment through a GPS-equipped Nextel phone owned by the suspect. Texas DEA agents have used cell site information in real time to locate a Chrysler 300M driving from Rio Grande City to a ranch about 50 miles away. Verizon Wireless and T-Mobile logs showing the location of mobile phones at the time calls were placed became evidence in a Los Angeles murder trial.
