Who Owns Molokai? Contested Land Title issues & Development Details Cited by Planning Commissioners to defer Griep's SMA Exemption

First time I ever hear the Attorney for the Molokai Planning Commissioners meeting give some legal advice regarding requirements for evidence of clear Title to lands and authority to apply for SMA approvals. The July 14 meeting audio recorded him stating that the MPC rules require a completed SMA Application etc: Here's the ownership documentation that we got as part of the application. The MPC can not adjudicate ownership, only Courts do that. If there is a basis, title or other papers you can ask them if that goes toward a complete application or environmental affects, then you can consider that.

Title to land claimed by Stanley Griep et al is challenged by the Naki Ohana after Griep's filed a Quiet Title lawsuit [Civ 05-0148-1]. Paul Kauka Naki-Cullen, of Waialua, Molokai, submitted chain of Title evidence and objections to any attempt by Grieps et al to use fraudulent documents and/or judgments that disregard the Original Will of Lunalilo chain title to Naki Ohana. Trial is scheduld for August 9, 2010 on Maui.

Inspite of that Trial date, Griep testified to the MPC that the Commissioners need not be concerned about land Title. He stated on the record that all adverse claimants have been defeated in this case, there's just a few paperwork deeds have to be drawn up, payments, for the final summary judgement on ownership and this partition. "The title has been settled," claimed Griep.

Apparently, Griep did not include Clear Title evidence for the land he claims to own as part of his SMA exemption application for an easement across lands of the Austin Estate to access that land that is also claimed by Naki. So there are questions whether his SMA Application is a completed application, and whether Griep has given false testimony to the MPC regarding Title status, and did he false claim that his proposed access road does not involve a commitment for larger actions in the future such as house construction, etc.

MPC commissioners summarized tht Greip wants to put in a road and to get his access easement. What we're trying to do is figure out what he trying to do. Griep submitted a permission letter of easement from Austin Estate, but no details about how to construct his access road, utilities installations, or removal of heavy forestation, and possible existance of historic sites.

Undersea Cable Broke July 27: no phones; no cable

Molokai residents tried calling Oceanic Cable when internet service and cable TV went down locally, but all lines were not working, or busy.

Later we got this Press Release: The disruption in phone service is believed to have been caused by a cut in an undersea fiber-optic cable that has impacted several service providers. Families and neighbors of the frail, elderly and disabled that only have land line phone service are asked to check in with them to ensure their well-being.

[Does this bring images to mind of deep diving robot submarines attempting to repair oil wells in Gulf of Mexico? Anyway, a repair ship will reportedly take about 5-days to arrive to repair the break. Meantime some other measures unknown, maybe wireless?, will be taken to restart our teleComms. hmmm]

Phone service for County of Maui offices with a 270- telephone prefix is expected to be restored by tomorrow morning according to the County's service provider, Wavecom Solutions, formerly known as Pacific LightNet. Wavecom Solutions said it is in the process of restoring service for its customers so that 99 percent of its customers on Maui, which includes County of Maui phone systems, can be restored by tomorrow morning.

Sites are currently beginning to come back online on Maui, while service has been restored 100 percent to the company's customers on Molokai. County offices on Lanai do not utilize the 270- prefix and are not expected to be affected by the service disruption.

Affected offices include the County of Maui building in Wailuku, DMVL and Real Property tax offices located at the Maui Mall Service Center, Parks offices at the War Memorial Gym, County in Wailuku and MPD and MFD.



This 12# Honu or Green Sea Turtle and these puffer fish deaths are mystery

Honu and Puffer fish Mystery Deaths



The dead Honu photo above was found floating in shallow waters at Waialua Beach in east Molokai last weekend by local residents. No apparent cause of death or injury was seen. DLNR officials recommended that it be buried to prevent any spearding of disease that might be present. Done.

Puffer fish dying across state from a mysterious disease is killing striped and porcupine puffer fish. Dr. Thierry Work with the U.S. Geological Survey has received at least 100 reports of dead puffer fish from across the state in the last six months.

The sick and dying puffer fish have had lesions on the skin, but what's been found on the inside has researchers alarmed. "We're seeing things like enlarged livers and enlarged swim bladders, which is the organ that allows puffer fish to float" said Work.

His staff have been able to analyze only 14 sick puffer fish so far and they're baffled as to what is killing them: They are leaning towards a virus or toxicosis. "We really need to sort out what it is that's killing them. Once we sort out the cause, we can decide if it can affect other fish or not," said Work.

"You'll see these fish either floating and can't submerge and they just don't look right, or if they're on the beach, their gills will be moving a little bit," said Work. "As long as there's a little bit of movement in those fish, they're super fresh and we can use them. If they've been on the beach a while, they're too decomposed and we can't do lab testing with them." Just bury then deep.

You can help by reporting all observations of dead or dying puffer fish, and if you spot a freshly dead puffer fish place it on ice. Then, Call Arleone at 553-5992 to ship to the USGS National Wildlife Health Center.

Molokai High Dress Code-Uniform Policy

Obama's Nomination of Kagan to US Supreme Court Must Be Stopped

If Senators vote NO on Kagan, her confirmation could be defeated. But, if Kagan is approved to fill the seat of retiring Justice John Paul Stevens, Kagan would become the fourth woman to join the nation's highest court and the 5th Jew on the 9-member Supreme Court of Appeals panel.

While Kagan does not have a record of judicial opinions, her views on the Second Amendment are no mystery. Some things that have come to light since her nomination include:

- * While serving in the Clinton administration, Kagan drafted an executive order to ban certain semi-automatic firearms;

- * As a law clerk, she advised against the Supreme Court considering *Sandridge v. United States* in a case that questioned the constitutionality of the D.C. gun ban, writing that she was "not sympathetic" to the gun owner's Second Amendment claims; and

- * Kagan was also part of the Clinton team that pushed the firearms industry to include gun locks with all gun purchases and was in the Clinton administration when the President pushed legislation that would close down gun shows.

During her hearings, Kagan ducked and dodged questions about the Second Amendment, and she refused to declare whether she believes the Second Amendment protects an individual right.

Kagan insisted that the Supreme Court decisions in *Heller* and *McDonald* are precedent and "settled law," but this in no way precludes her from ruling that almost all gun laws -- including gun owner registration, purchasing limits, waiting periods, private sale background checks, and more -- are consistent with the Constitution.

Recall the confirmation hearings of Sonia Sotomayor, the newest Supreme Court Justice. Sotomayor assured the Senate, and the American people, that she accepted the Court's ruling in *Heller* that the Second Amendment protects an individual right.

Yet, in the *McDonald* case, Sotomayor joined the dissent in writing that "I can find nothing in the Second Amendment's text, history, or underlying rationale that could warrant characterizing it as 'fundamental' insofar as it seeks to protect the keeping and bearing of arms for private self-defense purposes."

Now Kagan has made the same promises to the Senate, but the available evidence portrays her as a forceful advocate of restrictive gun laws and driven by political considerations rather than the rule of law.

As GOA attorney William J. Olson, who testified at the hearings, noted: "If [Kagan] were to go on the Court, with what we know about her now, she could be the most anti-gun justice on that Court."

There is NO WAY any Senator who claims to support the Second Amendment could vote to confirm anti-gun radical Elena Kagan to the Supreme Court of the United States!

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

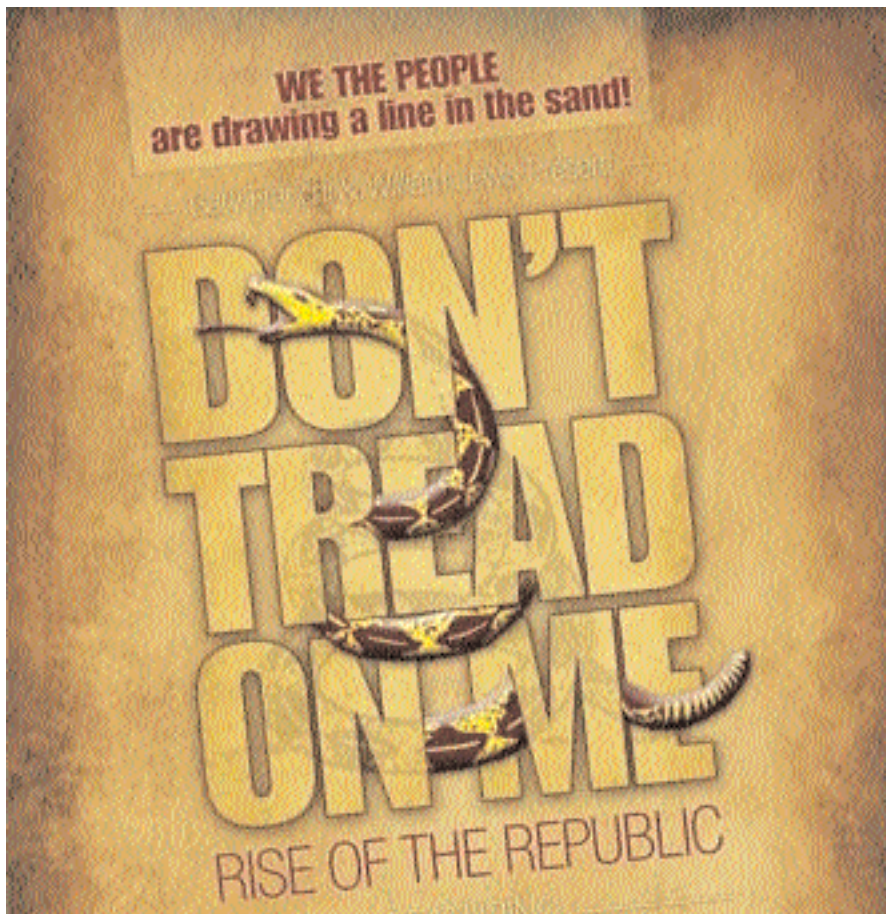

Is that clear ... ?

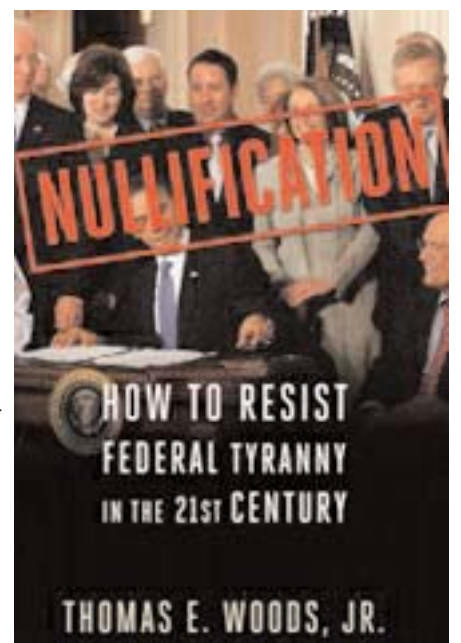

Three Unanswered Questions:

Was Barack Obama Born in Kenya?

Is He Really a Citizen of Indonesia?

Does the Constitution still Matter?

Electors are sworn to uphold it with their vote on December 15th in the Electoral College. But they must first know for sure that the candidates meet the Constitutional requirements for the office of President beginning with being a natural born citizen.

That's what Philip J. Berg has asked the United States Supreme Court to verify. The Supreme Court has asked for a response from Senator Barack Obama a long with the Democratic National Committee and Federal Elections Commission. And they have until December 1st to respond. Other cases have been filed asking for the same thing.

Not extreme. Not fringe. Just Constitutional.

Obama says he's qualified. But, Berg, multiple legal suits and a growing number of American citizens are saying: "Prove it." A basic, vital and Constitutional request.

Why won't Obama answer such a simple and essential request?

Exhibit A: The Grandmother's tape

Barack Obama's own grandmother said he was born in Kenya. While politicians are known for it, grandmothers seldom lie. It's recorded on tape:

"I was in the delivery room in [Mombasa,] Kenya, when he was born Aug. 4, 1961." – Sarah Obama, Obama's paternal grandmother

Exhibit B: No Original Birth Certificate

Experts have called the Certification of Live Birth posted online a forgery. Berg reported "It's clearly been altered," which invalidates it, according to the document itself. Add to this the Hawaiian law at the time which allowed people to register for this non-hospital short form certificate (without a doctor's signature) up to one year from the date of the child's birth.

Exhibit C: Indonesian citizenship

Only Indonesian citizens could attend Indonesian schools at the time Barack Obama attended the Indonesian school where he was registered as Barry Soetoro. His citizenship was listed as Indonesian, his religion as Islam, and his father as Lolo Soetoro, M.A. There was also no dual citizenship at the time. If he was adopted by his Indonesian stepfather, he would have forfeited any U.S. citizenship he may have had, just as when a child is adopted in America, he or she becomes an American.

Exhibit D: U.S. Law

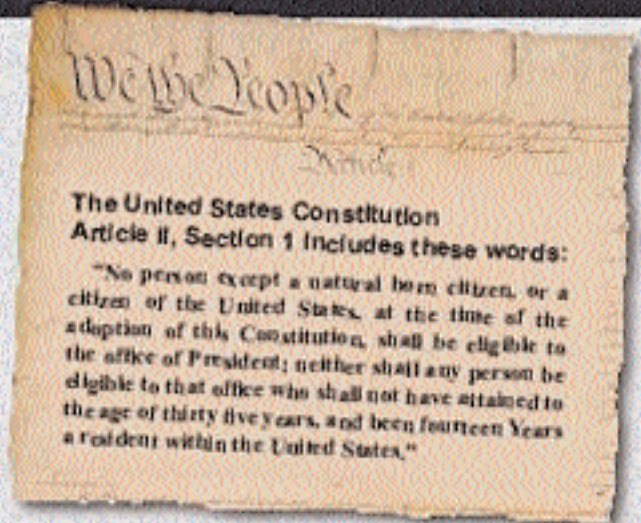
In addition, according to U.S. law pertaining to births abroad, from "Dec. 24, 1952, to Nov. 13, 1986," in order to register the child's birth as a U.S. natural-born citizen at the time of Obama's birth, he or she must be: 1. Born to two U.S. citizen parents, OR 2. If only one parent was a U.S. citizen at the time of the birth, that parent must have resided in the United States for at least 10 years, at least five of which must be after the age of 14.

The Jews' Devilish Diplomacy

Moshe Dayan, Israel's most celebrated general, famously outlined the strategy he believed would keep Israel's enemies at bay: Israel must be a like a Devil, too dangerous.

Until now, most observers had assumed Dayan was referring to Israeli military or possibly nuclear strategy, an expression of the country's familiar doctrine of deterrence.

But the Israeli commando attack last month on the Gaza-bound flotilla, in which nine activists have so far been confirmed killed and dozens were wounded as they tried to break Israel's blockade of the enclave, proves beyond doubt that this is now a diplomatic strategy too. Israel is feeling cornered on every front it considers important – and like Dayan's "mad dog", it is likely to strike out in unpredictable ways.

Domestically, Israeli human rights activists have regrouped after the Zionist left's dissolution in the wake of the outbreak of the second intifada. Now they are presenting clear-eyed – and extremely ugly – assessments of the occupation that are grabbing headlines around the world.

That move has been supported by the leadership of Israel's large Palestinian minority, which has additionally started questioning the legitimacy of a Jewish state in ways that would have been unthinkable only a few years ago.

Regionally, Hizbullah has progressively eroded Israel's deterrence doctrine. It forced the Israeli army to exit south Lebanon in 2000 after a two-decade occupation; it stood firm in the face of both aerial bombardment and a ground invasion during the 2006 war; and now it is reported to have accumulated an even larger arsenal of rockets.

Iran, too, has refused to be intimidated and is leaving Israel with an uncomfortable choice between conceding to Tehran the room to develop a nuclear bomb, thereby ending Israel's regional nuclear monopoly, and launching an attack to unleash a global conflagration.

In the US, Israel's most resolute ally, young American Jews are starting to question their unthinking loyalty to the Jewish state. Blogs and new kinds of Jewish groups are bypassing their elders and the American media to widen the scope of debate about Israel.

Israel has responded by characterising these "threats" all as falling within its ever-expanding definition of "support for terrorism". It was therefore hardly surprising that the first reaction from the Israeli government to the fact that its commandoes had opened fire on civilians in the flotilla of aid ships was to accuse the solidarity activists of being armed.

Similarly, Danny Ayalon, the deputy foreign minister, accused the organisers of having "connections to international terrorism", including al-Qaeda. Turkey, which assisted the flotilla, is widely being accused in Israel of supporting Hamas and trying to topple Benjamin Netanyahu's government that terrorises Palestinians and blockades food.

Palestinians are familiar with such tactics. Gaza's entire population of 1.5 million is now regularly presented in the Israeli media in collective terms, as supporters of terror – for having voted in Hamas – and therefore legitimate targets for Israeli "retaliation". Even the largely docile Palestinian Authority in the West Bank has rapidly been tarred with the same brush for its belated campaign to boycott the settlements and their products.

When false rumours briefly circulated on Monday that Sheikh Raed Salah, a leader of Israel's Islamic Movement who was in the flotilla, had been gravely wounded, Israeli officials offered a depressingly predictable, and unfounded, response: commandoes had shot him after they came under fire from his cabin.

The few brave souls in the Israeli media who try to hold the system to account have been given a warning shot with the exile of Haaretz's investigative journalist Uri Blau, who is threatened with trial on spying charges if he returns.

Finally, Israel's treatment of those onboard the flotilla has demonstrated that the net against human rights activism is being cast much wider, to encompass everybody but Jews.

Foreigners, even high-profile figures such as Noam Chomsky, are now routinely refused entry to Israel and the occupied territories. Many foreign human rights workers face severe restrictions on their movement and efforts to deport them or ban their organisations. The Israeli government is agreed that Europe should be banned from "interfering" in the region by supporting local human rights organisations.

The epitome of this process was Israel's reception of the UN report last year into the attack on Gaza by Richard Goldstone, a respected judge and international law expert who suggested Israel had committed many war crimes during its three-week operation. Goldstone has faced savage personal attacks ever since.

But more significantly, Israel's supporters have characterised the Goldstone report and the related legal campaigns against Israel as examples of "lawfare", implying that those who uphold international law are waging a new kind of war of attrition on behalf of terror groups like Hamas and Hizbullah.

These trends are likely only to deepen in the coming months and years, making Israel an ever greater pariah in the eyes of much of the world. The Devil is baring his teeth, and it is high time the international community decided how to deal with him.
