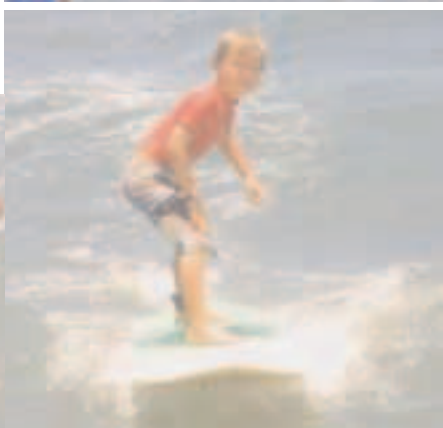

New Book
Pacific Passages:
Surf Writers



[ISBN 9780824831554, University of Hawai'i Press, softcover, \$32.00]
Pacific Passages brings together four centuries of writing about surfing, the most comprehensive collection of perspectives on the history and culture of a sport that has recently been transformed into a global industry.

The anthology begins with "Kelea-nui-noho-'ana-'api'api" (1865) by noted historical Samuel Manaiakalani Kamakau. Samuel Kamakau taught at Lahainaluna, beginning his recording of native history in the 1830s. His story of Kelea, beautiful chiefess of Maui who loved to surf is one often repeated surfing legends. Also included are more Hawaiian legends and chants, journals of the first Western explorers to the South Pacific and travel narratives of missionaries. Well-known authors Herman Melville, Mark Twain and Jack London, John Papa 'I'i, Hiram Bingham, Isabella Bird and J. Waiamau are among the collection of observations of surf riding between 1769-1896.

Pacific Passages allows readers to trace the historical transformation of surfing's image through the centuries from the Polynesian myths of love, to the first Western accounts of "Horror & Destruction" to modern representations of surfing as a character-building activity. Stories are not focused on Hawaii, but the worldwide growth of the sport. Stories include "Gidget" the Malibu scene and more recently the adaptation to the trends of social concerns of technology, competition, gender, heritage, and globalism.

Author Patrick Moser is associate professor of French at Drury University in Springfield, Missouri, where he teaches a course on the history and culture of surfing. There are no photographs in this anthology, but the cover, of Larry Bertleman, Reno Abillira and Eddie Aikau t Sunset Beach, is part of surfing's history.
 Published by the University of Hawai'i Press (ISBN 978-0-8248-3155-4, soft cover 339 pp.) *Pacific Passages* is an collection of 67 historical chapters in the popular sport once of kings, now for all.

DLNR Proposed New Rules: Civil Penalty for Natural Resources Violations
 Molokai meeting scheduled for August 1

In an effort to step up the protection and compliance with the state's natural resources laws, the Department of Land and Natural Resources (DLNR) will hold statewide public informational meetings on draft rules to establish an administrative system to process DLNR's civil (non-criminal) enforcement cases in a just, expeditious and cost-effective manner.

DLNR proposes to amend Hawai'i Administrative Rules, Title 13, Chapter 13-1, to add a new Subchapter 7, Civil Resource Violations System, that will authorize DLNR to:

- Issue citations for an alleged civil resource violation;
- Assess an administrative penalty for such a violation according to a penalty schedule adopted by the Board of Land and Natural Resources;
- Summon that person to answer the citation by choosing from three options - 1) pay the fine 2) request mitigation; or 3) contest the citation;

"People in Hawai'i care deeply about our natural and cultural resources, and want us to do a better job in protecting them and enforcing against violations that harm our lands and environment" Laura H. Thielen, DLNR chairperson, said.

"The civil penalty system to be set up under these draft rules is an important part of our new DLNR strategic plan, and will involve stakeholders and communities. We want to engage the public to help us finalize this draft and prepare for the rule-making process," Thielen said.

At the same time, DLNR also proposes to amend and compile other subchapters of Chapter 13-1, HAR, which are related to the enforcement process as well; in particular Subchapter 5, Contested Case Proceedings; and Subchapter 6, Post-Hearing Procedures for a Hearing Conducted by a Hearing Officer.

The meetings are intended to allow the public to be informed of this new enforcement process as proposed in the new rules, to ask questions on the rules, and to engage in live discussion with DLNR staff.

Tyranny in DC/Hawaii Again !

Only a few weeks after the U.S. Supreme Court's ruling in the Heller case, which struck down D.C.'s ban on handguns and having a firearm in operable condition at home as an individual right protected by the 2nd Amendment, D.C. has passed "emergency" laws and new police regulations intended to retain as much of the ban and storage requirement as possible. This ultra vires anti gun rights rule was crafted in consultation with the Brady Anti-gun Campaign, according to the Washington Post.

There are many objectionable features to the new D.C. law and regulations, but two stand out as particularly egregious. Though the Supreme Court ruled that D.C. could not ban handguns, the new rules would still ban all or most semi-automatic pistols. And in spite of the fact that the court ruled that D.C. cannot ban the use of guns for protection in the home, the District still prohibits having a gun loaded and ready unless an attack within your home is imminent or underway.

Without a public revolt and Congress' intervention, D.C. can violate the intent of the Heller decision indefinitely. That is because under "Home Rule," D.C.'s emergency bills are not subject to review by Congress, and D.C. can reinstitute "emergency" laws every 90 days. The city's officials are already thumbing their noses at the Supreme Court, the 2nd Amendment, and the Constitution for the united States of America

GOOD NEWS is that the Village of Morton Grove moved to amend its Village Code to remove the current handgun ban and incorporate sections of the Illinois Criminal Code, following the filing of NRA's lawsuit against the city.

"We are pleased that the Village of Morton Grove took steps to repeal its draconian gun ban," said NRA-ILA Executive Director Chris W. Cox. "Finally Village residents can exercise the same constitutionally-protected rights that the rest of the country enjoys."

Final action by the Village of Morton Grove Board on this ordinance is expected at the July 28 meeting. The NRA is committed to restoring the individual Second Amendment rights to all law-abiding Americans, as recently recognized by the United States Supreme Court in Heller v. District of Columbia.




