## US Debt Ceiling Raised !!?

KingObama signed the Increase in the Debt Ceiling his Congress-commies offered him on bended knee, and Obama added that taxes must also be raised on We The People. WTF !

It raises the debt limit by up to \$2.4tn (£1.5tn) from \$14.3tn, and proposes savings of at least \$2.1tn in 10 years, but increasing the debt immediately. Economists have said that failure to pass the debt deal would shake markets around the globe.

Obama said more action was needed, saying it was impossible for the US to "close the deficit with just spending cuts", —taxes must be raised.

Some Democratic and Republican lawmakers have bitterly opposed the legislation in recent days, saying it offered too much of their opponents' agenda.

Democrats have been unhappy that the bill does not include tax increases for the wealthy, although Obama could still let Bush-era tax cuts for the top brackets expire in January 2013 if he is still usurping the Office of President.

Obama is happy the bill raises the debt ceiling into 2013 - meaning he will not face another congressional showdown on spending in the middle of his re-election campaign next year.

It will also establish a 12-member, bipartisan House-Senate SuperCongress charged with producing significant deficit cuts in ten years. Analysts have said the cuts will probably come from programmes like federal retirement benefits, farm subsidies, Medicare and Medicaid and Social Security. Makaala! The "Super Congress" is an unaccountable politburo legislature without debate or amendment.

### Biggest Middle Class Tax Increase in History Will Come in Five Months

On July 11th Obama stated: I want to be crystal clear. Nobody has talked about increasing taxes now...cuts in FICA payroll taxes." It was another lie.

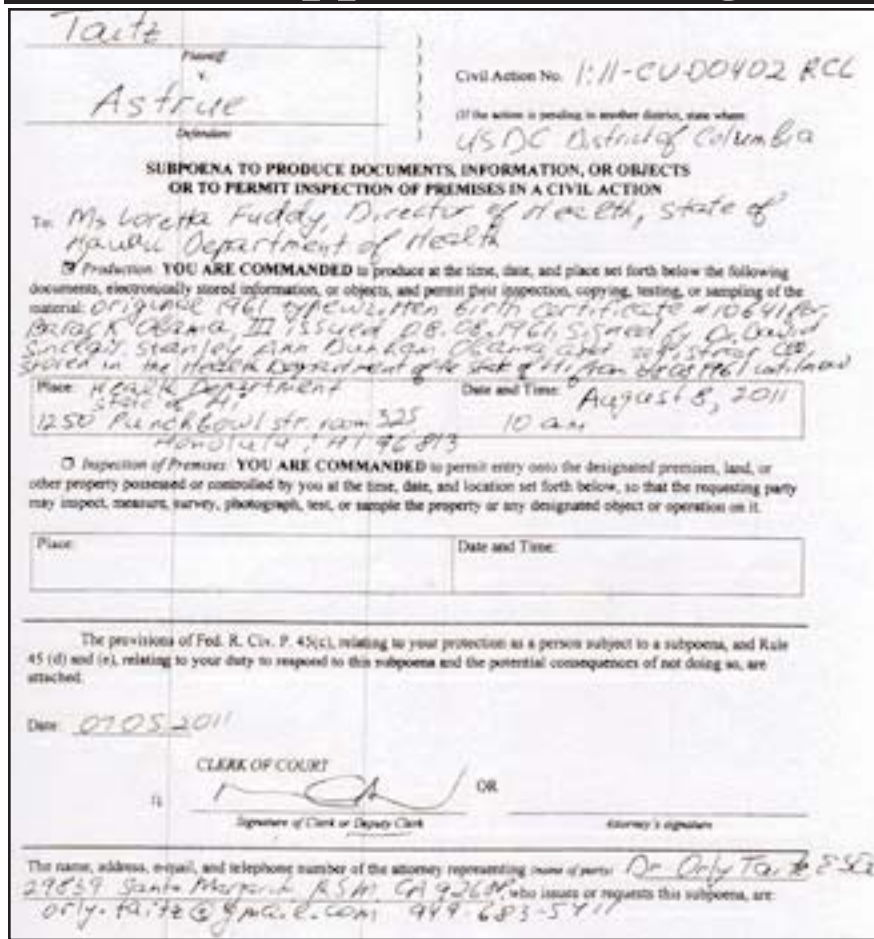

## Hawaii DOH Fuddy Subpoena Served Demanding Obama BC Exam Appointment Aug. 8



The The birth certificate please! The U.S. District Court Honolulu July 5, issued a Subpoena Ordering DOH and Hawaii AG to show Obama's 1961 B.C.

Computer scanning expert Doug Vogt and typesetting expert Paul Irey say they will accompany attorney Orly Taitz when she presents to the Hawaii Department of Health a subpoena that Orders her to examine Barack Obama's original 1961 typewritten birth certificate at DOH, August 8, at 10 a.m. in person.

"We will plan to hold a press conference late in the day of Aug. 8," Vogt said, "and if the document we see varies from the birth certificate documents the White House released, we plan to file criminal charges in Hawaii immediately."

Vogt has filed a 22 page Complaint against Obama with the FBI.

Fuddy did not file opposition to the court-issued subpoena, so the Hawaii DOH must comply by producing Obama's original birth certificate for Taitz's examination. Also, Taitz's July 27 letter to Fuddy got no reply.

To date, the Hawaii Department of Health has kept whatever record of Obama's birth that exists in its files in the agency's vault. The department refuses to grant any requests to show the original document to the public or to allow independent forensic examiners to authenticate it.

Will Obama obstruct justice yet again? COMMENT: William wrote My presumption is that Taitz and her two forensic experts will be stopped by physical force at the DoH. The DoH and the office of the HI Atty General believes that they themselves are above the law. IMO, the power of the federal courts to compel the production of evidence means nothing to these bureaucrats.

## Be Armed Against Socialist Violence

Don't settle for Preparedness Lite, that is, depending on government.

Police have no affirmative duty to protect individuals from the criminal acts of others. Remember that the Police are not the only agent of the law, the sovereign citizens being the ultimate law enforcement. Any person can keep the peace and enforce the law within reason, especially felonies, and self-defense is one of the better established doctrines which citizens have summoned for generations.

Guns: being armed for the security of the household and the neighborhood, is one of the ingredients missing from Preparedness Lite. One does not "Play Cop"; one realizes that cops derive their authority from us, but we do not give up our Right to Keep and Bear Arms just because cops are hired to help.

Personal preparedness means learning how to shoot, and taking training in personal defense. Thugs who are hungry and vicious are among the worst hazards. You will not talk them out of plundering you. Less-than-lethal doesn't work.

A handgun is essential for close quarter use and less conspicuous movement around the neighborhood. I will not say that all laws are suspended and encourage people to willy-nilly break laws, but in time of emergency, latitude and reasonableness under the circumstances reigns for neighborhood safety. Reasonableness is a superb guide under any circumstances.

At other times, a shotgun is better suited than a handgun. There are bazillions of reports where the sound of a well-oiled slide action of a shotgun with the subtle sound of a shell actually being chambered has saved more lives than some might think. Ownership of lethal force kept handy and battery-ready in preparedness is safer than an entire neighborhood being disarmed only to be at the mercy of thugs.

Understand why you are armed: you are alone and without anyone else to protect your family or the community. Be a community resource! Be armed with knowledge, authority, and the lethal force of guns. You are in control of all three.

You don't have to shoot as a knee-jerk reaction. Self-defense is not about reaction, it is about purposeful response. Often - often enough - this is adequate to discourage predators, but you can't do that without a gun and you certainly won't be taken seriously without one. The key is to resolve that you will be armed for the case when you need it to protect yourself and loved ones, and resolve that you will be fully prepared to shoot to stop a threat.

Hopefully, you will retain the ability to move and to help others. Being visibly armed, you may find, is common in time of emergency. You do not want your household to be one which is noticeably not armed. Being armed resonates with other armed families and builds cohesion, which is essential for neighborhood survival by having at least one less hazard. Being armed is not a hazard, it removes a hazard of not being armed and therefore likely prey. Being able to leave your family with security of arms so you can move about the community safely to aid others may make all the difference in their world, and your safety.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

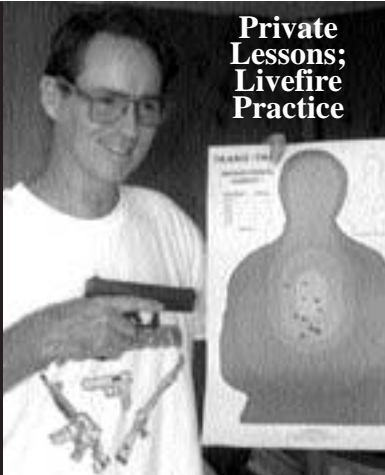

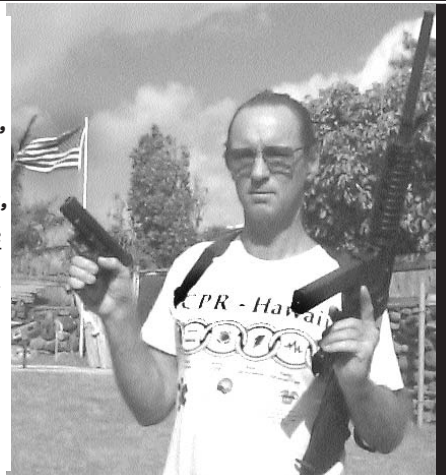

## Jewish Israeli Army Attacks Dutch Music Orchestra with Tear Gas



The Dutch street orchestra 'Fanfare van de Eerste Liefdesnacht' (the First Night of Love Brass Band) from Amsterdam was attacked with tear gas today by the Israeli army during their performance in the Palestinian village Kufr Qadum near Nablus, northern West Bank.

The bands tour of Palestine is designed to be interactive, working with children from a refugee camp in the east of Bethlehem and having them play along with the band and dancing in the streets together.

The musicians were confronted with tens of soldiers who shot tear gas canisters from behind their military jeeps during the musical performance. They then found themselves surrounded with snipers. Several members of the band were injured and suffered from tear gas inhalation.

Kufr Qadum is a village near Nablus that has suffered in recent years from radical jewish settlers who have attacked the villagers, cut down olive trees and set fire to fields. The roads that lead to the village are often blocked by Israeli military checkpoints.

The Dutch music orchestra has travelled around the West Bank for a duration of two weeks to perform in towns, villages and refugee camps. The band consists of 25 musicians with different musical instruments. They were invited by the town council of Kufr Qadum to perform in the village.

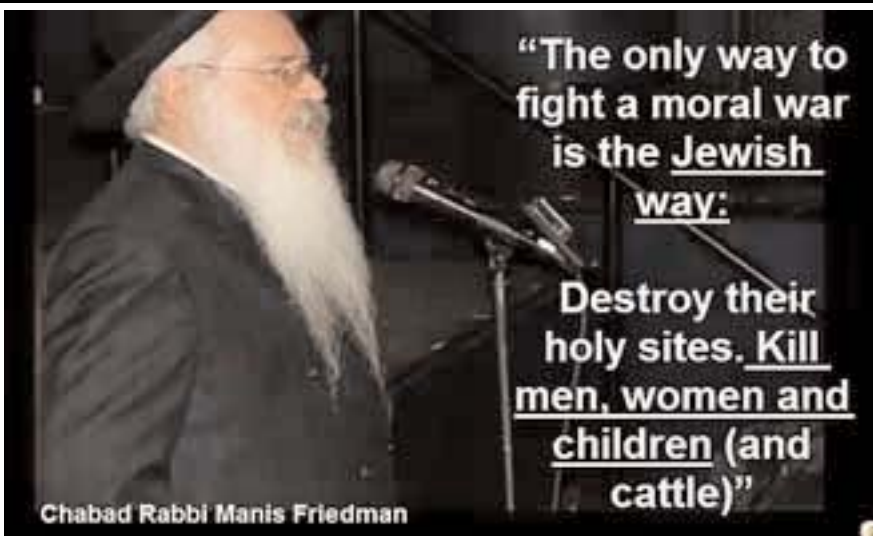
## Congress Candidates Campaign for Weiner's Seat: "Israelier Than Thou" ?

# Obama's F.D.A. Is Bad for Food Nullify FDA Law by Washing State Is the example Hawaii needs to follow!

**A county assembly in Washington State has just passed a food freedom ordinance which would punish federal agents with up to ten years in prison and \$20,000 fines.**

On July 20th, the Stevens County Assembly finalized the ordinance. They are now in the process of collecting signatures from the residents of Stevens County – urging them to claim his/her natural right to grow, produce, purchase, and consume the foods of their choice. WHEREAS, We find the history of government regulators, even with hundreds of food regulations on the books, shows they are incapable of protecting citizens from exposure to food poisoning events from foods produced by corporate farming

Beyond that, the passed ordinance would make it unlawful for agents of either the State or Federal government to execute to interfere with the ordinance.

Four towns in Maine have passed similar measures, and Hawaii should, too. WHY, you ask?

Last year, Congress introduced the Food Safety Modernization Act (S. 510) which opponents say will lead to crushing regulations on local food production – at the benefit of the big corporate farming interests that backed passage of the law. Local food ordinances appear to be a direct response to the new regulations.

What exactly have the FDA regulations enforcement done? For example:

The year-long raw milk sting operation that resulted in a raid consisting of two US Marshals, two State Troopers and two FDA officials on a SWAT like assault on an Amish farm in Pennsylvania at 5 a.m. see <<http://www.tenthamentcenter.com/2011/07/22/push-back-against-fda-growing/>>

–In the first half of 2008, there was an epidemic of human salmonella poisoning that afflicted 1,294 people in 43 states, the District of Columbia and Canada. The FDA immediately sprang into action and after a hasty investigation they proclaimed that tainted tomatoes may be the source of the epidemic. Several varieties of tomatoes were withdrawn from markets and restaurants across the country. Several weeks later, the FDA proclaimed that it may indeed be jalapeno peppers and cilantro that could be contributing to the outbreak. All of these ingredients are commonly used to make salsa which is a staple when eating Mexican food. Surprise! Finally the FDA pinpointed the peppers and cilantro that were imported from Mexico because it had traced contaminated irrigation water. The American tomato industry lost millions of dollars because of these errant recalls.

–Last year, FDA “Investigators” entered an organic grocery store in Venice, California – warrant and guns in hand. As reported by the LA Times, they “ordered the hemp-clad workers to put down their buckets of mashed coconut cream and to step away from the nuts. Then, guns drawn, four officers fanned out across Rawesome Foods in Venice. Skirting past the arugula and peering under crates of zucchini, they found the raid’s target inside a walk-in refrigerator: unmarked jugs of raw milk.

These are but a few of the seemingly endless examples of how the FDA and its increasing regulatory and police power have been keeping you “safe.” Some people, as shown by the five towns taking matters into their own hands, have decided that “enough is enough.”

## LOCALS SPEAK OUT

Sedgwick, Maine resident Mia Strong told Natural News: “Tears of joy welled in my eyes as my town voted to adopt this ordinance. I am so proud of my community. “I still can’t believe they took our yogurt,” Rawesome volunteer Sea J. Jones told the LA Times a few days after the raid. “There’s a medical marijuana shop a couple miles away, and they’re raiding us because we’re selling raw dairy products?”

## COMMUNITY FARMING, ORGANIC FOODS: Nullification 101

While the media would like to portray any and all actions that assert the Tenth Amendment as a “tea party” or “right wing” movement, support for food sovereignty ordinances, along with fifteen states passing medical marijuana laws, certainly proves that stereotype to be little more than media hype.

### The ordinance from Stevens County makes this clear:

WHEREAS, We, the people of the State of Washington domiciled on Stevens county, declare:

1. The Tenth Amendment to the Constitution for the United States, states, “The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people”; and

2. That pursuant to Article 1, Section 8, of the Constitution for the United States, there is no power granted to the federal government to regulate local foods on Stevens county; and

3. The Ninth Amendment to the Constitution for the United States, states, “The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people.”; and

4. That pursuant to the Ninth and Tenth Amendments to the Constitution for the United States, the power to regulate local foods on Stevens county is reserved to the State of Washington or the people of the State of Washington.



## WARNING TO Obama FEDS

Like the four towns in Maine that have passed similar ordinances, Stevens County means business. They’ve also included an enforcement clause – telling the feds, in essence, to butt out.

## ENFORCEMENT CLAUSE;

(A)(1) The people of the State of Washington domiciled on Stevens county, declare that any law enacted by the congress of the United States; any federal regulation, rule, or policy promulgated; any executive order issued by the president of the United States; and any court decision; that seeks, purports, or is otherwise intended to regulate, in any way, the unalienable and fundamental rights of the people on Stevens county to choose the local foods they produce; process or prepare; sell, purchase, or distribute; preserve and store for extended periods of time; and consume, for food or drink, for people or other life forms, is not authorized by the Constitution for the United States of America; and

(2) The people of the State of Washington domiciled on Stevens county, declare the federal laws, etc., referred to in subsection (A)(1):

- (a) Are invalid on Stevens county; and
- (b) Will not be recognized by Stevens county; and
- (c) Are specifically rejected by Stevens county; and
- (d) Are null and void, having no effect on Stevens county.

The ordinance continues

(D)(1) Public employees employed at the federal, state, or local levels, including, but not limited to, agents of the Federal Bureau of Investigation, Department of Homeland Security, Food and Drug Administration, Washington state Patrol, sheriff’s departments, and municipal and county police will not enforce or attempt to enforce the federal laws, etc., referred to in (A) subsections (1) and (2); or treaties referred in (B) subsections (1) and (2); or Washington state laws, etc., referred in (C) subsections (1) and (2);

and

(2) A violation of subsection (D)(1) is a class B felony (as defined at RCW 9A.20.021(1)(b)) and is punishable by confinement in a state correctional institution for a term fixed by the court not to exceed ten (10) years, or by a fine in an amount fixed by the court not to exceed twenty thousand dollars (\$20,000), or by both such confinement and fine; and

While the FDA has been getting increasingly aggressive – raiding raw milk activists, threatening walnut producers, and the like – these activists believe that they can push back and win by doing the same to DC. Will a local government ever attempt to arrest an FDA official? Only time will tell, and maybe they’ll never have to.
