## Hawaii Democratic Party Officials Should be Called to Testify re: Obama; and National Review Joins Call to Investigate Obama's Justice Department, and others

Information has come to light that the Democratic Party in Hawaii refused to certify that Obama is Eligible to be President and that Nancy Pelosi falsified the Forms sent to Hawaii to ensure Obama got on the ballot and his eligibility was therefore a Fraud, and thereby established that Obama is not eligible to be President. Nationwide there are calls to subpoena the whole Democratic Party Leadership from Hawaii to Testify before a Federal Grand Jury. However, a means needs to be found to by-pass the DOJ and Eric Holder, we all know where that will get us. [We The People are Sovereign, the final Enforcers of the Law of the Land, and we may need to use our guns to enforce the Law this time against Obama]

The flagship publication of the conservative movement has joined the call to investigate Barack Obama's Justice Department. In his his article on NRO entitled "Investigate Racism in the Obama Justice Department," Andrew C. McCarthy agrees the department's racially charged dismissal of the Black Panther case of Intimidation of White Voters represents a "crime" and Congress has the Constitutional obligation to end the "criminalization of the Justice Department."

Taking note of the Republican Party's new Pledge to America, McCarthy begins: If the Republican party is interested in making...a pledge that will resonate with the vast majority of the American people — here's a suggestion: Promise an unwavering commitment to the principle of equal protection of the law for every American citizen; and that Congress will investigate weighty allegations that the Obama Justice Department is engaged in racist law-enforcement practices, and that any executive-branch high official who has conspired to deny American citizens equal protection, or who has obstructed justice in an effort to cover up such a conspiracy, will be impeached and removed from office.

McCarthy has an unimpeachable background in the law and high-stakes investigations. A former federal prosecutor, his endorsement brings significant legal gravitas to the argument that Obama's officials, possibly up to and including Obama himself, have run afoul of the legal and constitutional functions of the Offices they hold and should face impeachment.

Last Friday, career Justice Department lawyer Christopher Coates, who once headed the Voting Rights division, testified the department retreated from a case it had already won after pressure from the president's political allies (especially the NAACP), and under the direction of Obama's political appointees.

In other words, the U.S. Justice Department is a racist institution dedicated to denying white people equal protection under the law. That, notes McCarthy, is a violation of every canon of American jurisprudence.

In addition to the racial discrimination, the Black Panther case may involve perjury and obstruction of justice. The third-ranking official in the Department of Justice, Thomas Perez, testified under oath that there had been no "political leadership involved in the decision not to pursue this particular case." However, new documents show Democratic Party lawyer and political appointees had been deeply involved, including deputy associate attorney general Sam Hirsch (a former Obama campaign operative who has pushed for the race-based Balkanization of Hawaii)." He favored the Akaka bill, a race-based bill to grant native Hawaiians tribal rule (and a large chunk of 1.8 million acres of federal land under dispute), having testified on its behalf in August 2009."

If Perez lied under oath, as it increasingly appears he did, that constitutes perjury and obstruction of justice. If he acted on orders from above, and he almost invariably did, his superiors should share the blame — and the witness stand.

McCarthy concludes such a violation of fundamental legal principle requires action: The Constitution guarantees all Americans equal protection under the law. The civil-rights laws, moreover, make it a crime for government officials to deprive "any person" — not any black or minority person, but any person, period — of "any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States." It is a grave violation of law for the Justice Department to practice racial discrimination in deciding which cases it will bring, to determine that Americans of one race or class are not entitled to the same protection as all Americans.

That's not just politicization of the Justice Department. It is criminalization of the Justice Department. Under the Constitution, it is Congress's obligation to stop it. The current Congress obviously won't do its duty. Americans will strongly support congressional candidates who pledge to right that wrong.

Thus, one of the featured writers of conservatism's most prestigious magazine has endorsed the call for an investigation — and "impeachment" — of anyone involved in this travesty. Those proceedings should be among the first undertakings of any new Republican Congress elected in November.

But how you going do business without a cash register? Today, Alicia and Mr. Ruiz were using a little metal box to hold the receipts and make change.

"Its sad," lamented Mr. Ruiz as he stood behind the counter on which the cash register used to sit. "They need money, they should work like we do to earn the money, not steal our hard earned money and equipment. I hope who ever took our cash register and our money will think first, do the right thing and return to us. But I reported this to police, and now police will try to find it."

## Food Corruption by Congress?

## Military Pay for Retroactive Stop Loss Service Deadline Oct

WASHINGTON – Military members whose service was involuntarily extended, or whose retirement was suspended between September 11, 2001 and September 30, 2009, due to stop loss are entitled to retroactive payments of \$500 for each month they were extended, according to Department of Defense officials. But the deadline to receive those benefits is rapidly drawing to a close. The deadline to apply for the benefits is October 21, 2010.

Only about 58,000 of the 145,000 eligible claims have been paid, leaving more than \$300 million available to eligible veterans. The average payout for each veteran is close to \$4,000. Survivors of a service member whose service was extended, are also eligible to apply for the retroactive payments.

The 2009 War Supplemental Appropriations Act established the Retroactive Stop Loss Special Pay and throughout the past year the services have been reaching out to eligible veterans, service members and their families through direct mail, veteran service organizations and the media. But by law there is no authorization to make payments on claims submitted after October 21, 2010.

Eligible people should print, complete and sign Department of Defense Form 2944, Claim for Retroactive Stop Loss Payment. They must then select the appropriate method for submitting their claim form based upon their service requirements. Sep 23, 2010 The state Public Utilities Commission has approved an annual revenue increase of \$548,682, or 126.5 percent, for Molokai Public Utilities Inc. The commission said Thursday that it recognizes the increase in MPU's water rates is large. But it says the increase is needed for MPU to continue essential water serve in the Kaluakoi area without interruption.

The company initially requested an increase of 201.5%, but subsequently amended its request to seek an increase of 126.8%.

**U.S. Supreme Court Upholds**

**“...the right of the People to keep and bear arms shall not be infringed.”**



**“Fundamental” Right to Guns**

Gun ownership rights of the People as stated in the 2nd Amendment were upheld again in Monday's U.S. Supreme Court Ruling, and supporters of the Constitution for the United States of America have hailed the ruling as a victory. This is the first time the US Supreme Court has offered a clear definition of national significance of the 2nd Amendment's guarantee that right of the People to keep and bear arms shall not be infringed, and orders the lower federal appeals court to reconsider its ruling - leaving little doubt that the Chicago laws will eventually be overturned, and Hawaii's chapter 134 HRS challenged.

In McDonald, v. Chicago, (08-1521) the ruling makes it clear that this does not mean that all laws governing gun ownership in America are immediately void. But Justice Samuel A. Alito, Jr., in the Court's main opinion did make unmistakably clear to lower court judges that the right to have a gun for self-defense in the home is a "fundamental" constitutional right; and that the Second Amendment right of the People to keep and bear arms shall not be infringed applies equally against the federal government and against the states.

## The Kioea: Unofficial Bird of Kaunakakai

The kioea (Bristle-thighed Curlew, *Numenius tahitiensis*) is a large shorebird that has been returning to Kaunakakai's coast every winter for centuries. Most of its days are spent at Ka la`i o kioea 'the tranquil spot of the kioea' - the Koheo wetland at the end of Seaside Place. In 1909, John F.G. Stokes of the Bishop Museum wrote "Here there were numerous plover and curlews. The curlews are said to have called to the canoes to go out to sea to fish. Hence, the saying, "Moloka`i i ke kioea ho`olale ka wa`a - Moloka`i where the kioea urge on the canoes." The kioea can also be observed at Duke Maliu Regional Park second base outfield, the Monsanto corn field to the east, and the Molokai Education Center lawn. The curlews are easily recognized by an 8" long decurved bill which is used to probe beneath stones and in soft soils. The species is the only shorebird known to use tools when foraging and will hammer prey such as crabs and eggs of other birds with a rock held in its bill.

Bristle-thighed Curlews are considered one of the rarest and most unique shorebirds in the world. It winters exclusively on islands of Oceania and its breeding grounds remained a mystery until 1948, when birds were discovered nesting in a remote area of the Alaskan tundra. A federally protected species, population estimates are fewer than 7,000 individuals. A bird banded in 1967 was accidentally killed during a scientific study in 1991 and holds the longevity record of 23 years and 10 months. Over the past several years a research project by the USGS Alaska Science Center utilized surgically implanted satellite transmitters to identify habitats and migration routes of curlews.
