America Wants Answers, says AOL Poll

Even Obama's grandmother in Kenya says he was not born in Hawaii, but right before her eyes in Kenya. Now, America Online is asking the nation, "Do you think there is any merit to the controversy surrounding Barack Obama's citizenship?" The national AOL poll reflects the view of more than 81,000 respondents across the Nation: the majority (49%) of the participants believe there's merit in determining whether or not Barack Hussein Obama is a natural born citizen—one of the qualifications for becoming president. A number of "blue states" which had voted for Obama in the election [ CO, NH, NM, PA, and VA) now want to see proof that their candidate is constitutionally eligible to be president, or not.

Writ of Certiorari is still pending and is now scheduled for Conference before U.S. Supreme Court on January 9, 2009. At least 17 lawsuits have been filed over Obama's eligibility to assume the office of the president, many have been dismissed, while others remain pending.

The cases have, in various ways, alleged Obama does not meet the "natural born citizen" clause of the U.S. Constitution, Article 2, Section 1, which reads, "No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President."

Some of the legal challenges have alleged that Obama was not born in Hawaii, but in Kenya. Obama's American mother was too young at the time of his birth to confer American citizenship to her son under the law at the time.

Other challenges have focused on Obama's citizenship through his father, a Kenyan subject to the jurisdiction of the United Kingdom at the time of his birth, thus making him a dual citizen. Such cases contend the Constitution excludes dual citizens from qualifying as natural born, and ineligible to be President. AMEN!

The Birth Of Christ And The Birth Of America Are Linked

That it forms a leading event in the progress of the Gospel dispensation? That it laid the cornerstone of human government upon the first precepts of Christianity, and gave to the world the first irrevocable pledge of the fulfillment of the prophecies announced directly from Heaven at the birth of the Savior and predicted by the greatest of the Hebrew prophets six hundred years before?"

Adams was exactly right: America's birth is directly linked to the birth of our Savior. In fact, the United States of America is the only nation established by Christian people, upon Biblical principles, and dedicated to the purpose of religious liberty. This truth is easily observed within America's earliest history.

America's forebears first established a written covenant with God as early as November 11, 1620, when they penned The Mayflower Compact. It states in part:

"In the name of God, Amen. ... Having undertaken, for the Glory of God, and Advancement of the Christian Faith, and the Honour of our King and Country, a voyage to plant the first colony in the northern parts of Virginia; do by these presents, solemnly and mutually in the Presence of God and one of another, covenant and combine ourselves together into a civil Body Politick, for our better Ordering and Preservation, and Furtherance of the Ends aforesaid; And by Virtue hereof to enact, constitute, and frame, such just and equal Laws, Ordinances, Acts, Constitutions and Offices, from time to time, as shall be thought most meet and convenient for the General good of the Colony; unto which we promise all due submission and obedience."

The sentiments and statements of America's founders make it clear that this nation has enjoyed a love and appreciation for the rights and freedoms recognized in Natural Law that is unique in the annals of human history. No other people have such a heritage.

One thing America's founders could not envision was--after they had paid so terrible a price to purchase our liberties--that the time would come when their posterity would be denied the basic freedoms to publicly express their reverence for God. Never could they have imagined that the day would come when citizens of the sovereign states (each with a state constitution protecting religious liberty) would be denied their right to pray in school, or place Nativity scenes on public property, or hang copies of the Ten Commandments on courthouse walls.

Democrats and Republicans alike have created a central government so large that it would be unrecognizable by any Founding Father. In addition, both Big Business and Big Religion have sold our great country down the proverbial river, as surely as there is a sun in the sky. Truly, our Founding Fathers must be rolling over in their graves.

Therefore, at this Christmas season, let us remember well the founding principles of these United States of America. Furthermore, let us renew with vigor the fight for freedom before our liberties and our heritage are gone altogether.

**Auditor Blasts Lingleferry**

There is plenty of blame to go around on the Superferry debacle including many Democratic legislators as well as convicted felon aka The Usurper Linda Lingle who twisted arms and greased the skids for the Stupidferry launch, according to the State Auditor report. After the Courts ruled that Lingle had broken the law by telling the Superferry not to do an EIS, she colluded with Hawaii Superferry to move up its start date and initiate service in the 4 days between the ruling and the imposition of the injunction against operating on Maui.

During the two days HSF operated, 3 truckloads of natural resources were stolen from Maui. HSF \$5 fares enabled 'Oahu to dump their homeless on Maui, worsening our already dangerous homeless drug users problem.

\* In those two days, Lingle precipitated huge protests on Kaua'i in which unarmed protestors faced down the Superferry. Because of protester actions, Kaua'i was spared the harm that came to Maui.

**STATE AUDITOR'S REPORT FINDINGS**

» In their haste to support Hawaii Superferry Inc., state officials ignored the recommendations of their technical staff, setting off a chain of events that resulted in the selection of inadequate harbor improvements.

» The combination of harbor improvements, barges and ramps built statewide at a cost of \$38 million has proved problematic and costly at Kahului Harbor and would have likely created similar problems at Kawaihae Harbor.

»A law known as Act 2, passed in a special session last year on behalf of Hawaii Superferry Inc., compromised the state's environmental laws and set a precedent that puts the interests of a single business before the state's environmental, fiduciary and public safety responsibilities.

The state ignored its own long-standing policy and environmental laws when it built barges and ramps for the Hawaii Superferry, a performance audit states.

The audit, released last week, said the state had never built ramps for any other users, but caved in to pressure from the Superferry, which said it would not come to Hawaii if it had to build its own on-board ramps.

However, the inclusion of a ramp on the second Superferry vessel means at least \$10 million in taxpayer funds and maybe more will have been wasted, states the report by Marion Higa, legislative auditor.

Lingle threatened to use Child Protective Services to take away the children of the protesters.

Lingle threatened the unarmed peaceful protesters with prosecution under Homeland Security - 10 years in Federal prison and \$25,000 in fines.

Lingle has pitted 'Oahu against the Neighbor Islands, family member against family, friend against friend by ignoring the law and pushing the unwanted Superferry over the objections of neighbor island county councils and neighbor residents.

She has ignored every single request that conflicts with her overall goal of political favor-carrying for those she thinks will advance her national aspirations.

After the county councils of Kaua'i, Maui and Hawai'i begged her to do an EIS so that the neighbor islands could mitigate the impacts of the Superferry, she ignored them. She ignored their problems. **IMPEACH LINDA LINGLE !!!**
