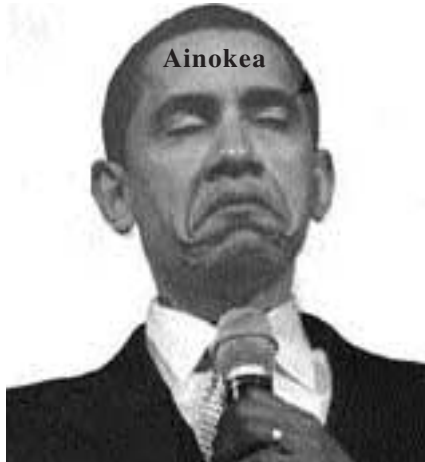

It was a long hearing with federal judge Carter, from about 8:30 AM to 11:45 AM Pacific time yesterday, the 5th of October, 2009. More than 100 persons attended. There was an overflow room with video hookup to accommodate everyone, and the big news witnessed was when Carter denied Obama's attorneys' request to immediately dismiss the lawsuit.

Judge Carter also denied Attorney Gary Kreep's Motion for Severance, which would have created a parallel case for his clients. Carter also questioned Obama's attorneys regarding the method of impeachment of Obama by Congress, and how that would address this controversy over claims that Obama aka Barry Soetoro is not a natural born American Citizen, therefore, not eligible to be president.

Obama Delays Visit with Dalai Lama to Keep China Happy?

The Obama decision came after China stepped up a campaign urging nations to shun the Tibetan spiritual leader. It means Mr Obama will become the first president not to welcome the Nobel peace prize winner to the White House since the Dalai Lama began visiting Washington in 1991.

The Buddhist monk arrived in Washington on Monday for a week of meetings with Congressional leaders, celebrity supporters and interest groups, but the president will not see him until after he has made his first visit to China next month.

Samdhong Rinpoche, the Tibetan prime minister-in-exile, has accused the United States and other Western nations of "appeasement" toward China as its economic weight grows.

"Today, economic interests are much greater than other interests," he said.

Mr Obama's decision dismayed human rights and Tibetan support groups, who said he had made an unnecessary concession to the Chinese, who regard the Dalai Lama as a "splittist", despite his calls for autonomy rather than independence for Tibet. The Chinese invaded in 1950, forcing the young leader to flee.

Sophie Richardson, Asia advocate for Human Rights Watch, said: "Presidents always meets the Dalai Lama and what happens? Absolutely nothing.

"This idea that if you are nice to the Chinese Communist Party up front you can cash in later is just wrong. If you lower the bar on human rights they will just move it lower and lower."

Over several months of discussions the Tibetans resisted entreaties to delay the meeting, arguing that a refusal would make smaller countries more vulnerable to pressure from China not to meet the Dalai Lama.

But they were told by US officials they wanted to work with China on critical issues, including nuclear weapons proliferation in North Korea and Iran, according to The Washington Post. Mr Obama then sent a delegation to the Dalai Lama's home in exile in India last month that confirmed the meeting would be deferred.

Mr Obama has changed his position on Tibet since his election campaign.

In April 2008, he was joined by Hillary Clinton, then his rival for the Democratic nomination and now his Secretary of State, in calling on George W Bush to boycott the Beijing Olympics opening ceremony in protest at the bloody repression of a popular uprising in Tibet.

"If the Chinese do not take steps to help stop the genocide in Darfur and to respect the dignity, security, and human rights of the Tibetan people, then the President should boycott the opening ceremonies," they said.

Mrs Clinton has been at the forefront of a new approach, called "strategic reassurance", which seeks a more amicable partnership with the emerging power.

On her first trip to China in February she said public pressure on China over human rights was ill-advised as she "knew what the Chinese were going to say".

Lodi Gyaltzen Gyari, the Washington-based special envoy to the Dalai Lama, issued a brief statement, saying: "We came to this arrangement because we believe that it is in our long-term interests."

A White House official said the administration and the Tibetans had "agreed the timing would be best after the visit".

"Both sides attach importance to a strong US-China relationship," the official said. "There are benefits in that to our goals for Tibet, as we have been working to resume discussions between the Chinese government and the Dalai Lama's representatives."

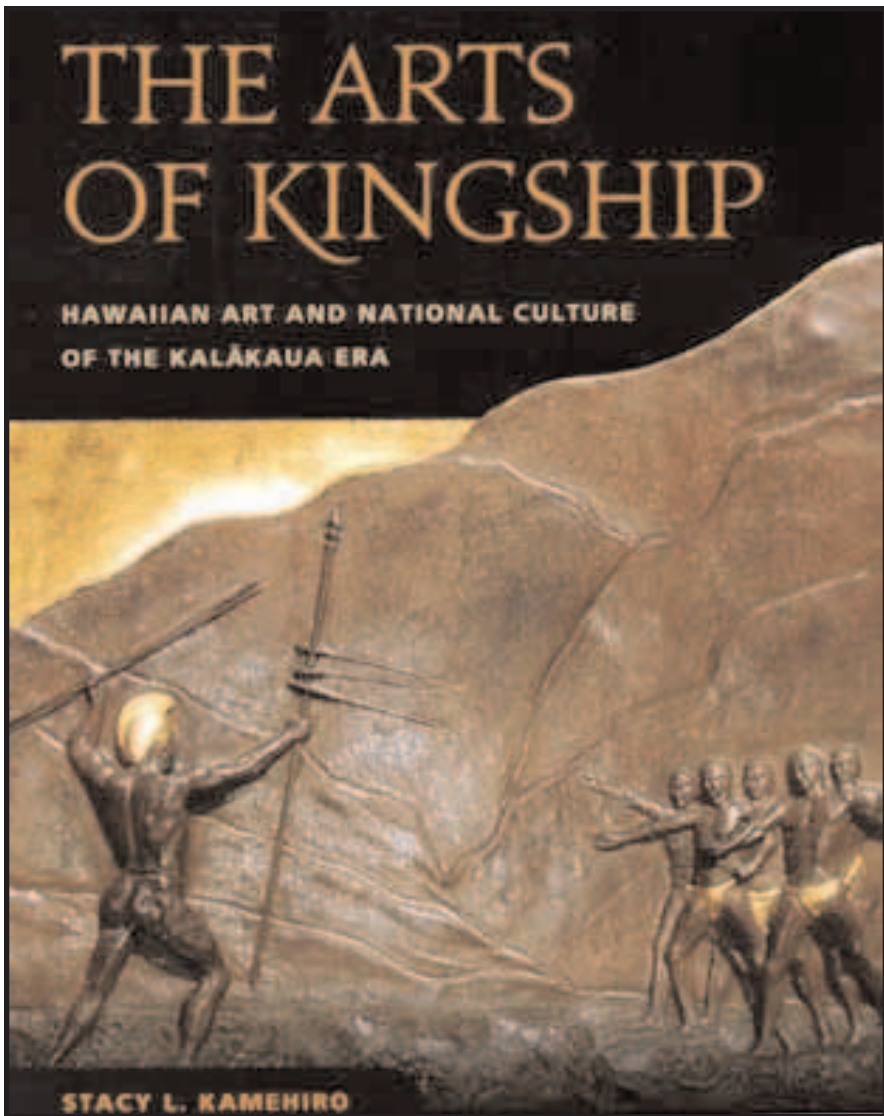
The Tibetan leader's ten meetings with US presidents have played an important role in maintaining his international profile, even though they have never been filmed or followed by a press conference.

The exception was 2007, when George W Bush conferred the Congressional Gold Medal, Congress's highest civilian award, on the Dalai Lama in front of the cameras.

Frank Wolf, a Republican congressman and outspoken critic of China's human rights record, said: "What would a Buddhist monk or Buddhist nun in Drapchi prison think when he heard that President Obama, the president of the United States, is not going to meet with the Dalai Lama?"

"It's against the law to even have a picture of the Dalai Lama. I can almost hear the words of the Chinese guards saying to them that nobody cares about you in the United States."

Ms Richardson said treating human rights as separate from other issues guaranteed failure "across the board".

.....Dr. Orly Taitz responded by citing precedents in the 9th Circuit, that allow quo warrento proceedings to be held in Calif., rather than in Washington, D.C., because of the great distance to the other side of the continent.

Obama's government attorneys argued that judge Carter had no authority to hear the case, and that claims were political in nature and therefore not for the Judiciary to adjudicate. Judge Carter pointed out that the case was unique, that there were no precedents to guide him thoroughly, and would hear the case.

The lawsuit was brought by several political candidates and party officials, including former U.S. ambassador Alan Keyes and Wiley Drake and Markham Robinson of the American Independent Party.

They are suing Obama alleging he is not eligible to be president under the U.S. Constitution's requirement for a "natural born" citizen in the Oval Office." One argued impeachment wasn't relevant, since "you have to have a valid, elected president." He said a court hearing with full disclosure of evidence is required, since the impeachment provision wouldn't technically apply to someone who never was qualified to be president. The Constitution, Article 2, Section 1, states, "No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President."

Had Obama's ineligibility been publicized before the election, some other candidate would have become the Democrat Party's nominee, instead.

Obama's attorneys claim that the plaintiffs are really seeking nothing less than a determination by this United States District Court that President Obama should be removed from office and that no single United States District Court judge has the power to try the question of whether a sitting president of the United States should be allowed to remain in office.

Plaintiff's attorney Gary Kreep has requested immediate access to Obama's records, such as his original long-form birth certificate and his Occidental College records. The plaintiffs' suspicion is that those records would undermine the president's statements that he is a "natural born" citizen, which could disqualify him.

Likewise, the Occidental College records could be significant if Obama attended on a program for foreign students or represented himself as a foreign student at the time. Complicating the situation is Obama's decision to spend more than \$1 million in legal costs to avoid releasing an original long-form state birth certificate that would put to rest some of the questions of his birthplace; and, there is that Kenyan birth certificate recently brought as potential evidence.

Some of the lawsuits question whether he was actually born in Hawaii, as he insists with a fake Hawaii BC posted online. If he was born out of the country, as the Kenya BC indicates is a fact, then Obama's American mother, the suits contend, was too young at the time of his birth to confer American citizenship to Barry.

With judge Carter's decision to make the trial schedule final, this will be the first time the merits of the dispute are presented by Plaintiffs in an open court trial.

New Book Release *The Arts of Kingship*

Hawaiian Art and National Culture of the Kalakaua Era

The Arts of Kingship: Hawaiian Art and National Culture of the Kalakaua Era, is a detailed scholarly work about Hawaiian public art and architecture during the reign of David Kalakaua. Nineteenth-century Hawaiian sovereigns celebrated native traditional, history, and modernity by intertwining indigenous conceptions of superior chiefly leadership with the apparati and symbols of Asian and European rulers and American government systems.

Author Stacy L. Kamehiro, an associate professor in the History of Art and Visual Culture Department at the University of California, Santa Cruz, provides visual and historical analysis of Kalakaua's coronation and regalia, the King Kamehameha Statue, Iolani Palace, and the Hawaiian National Museum that holds artifacts directly related to a pre-Kamehameha chief from Kauai named Umi-a-liloa, who apparently unified the Islands in his day. The enduring symbols of the Kalakaua Era (1874-1891) have provided the settings and attention for a Hawaiian national visual culture.

The cultural projects were part of the monarchy's effort to promote a national culture in the face of colonial pressures, internal political divisions, and declining social conditions for Native Hawaiians, which, in combination, posed serious threats to the survival of the nation. The Kalakaua leadership endorsed images that boosted international relations and appeased foreign agitators in the kingdom while addressing indigenous political entanglements.

Author Kamehiro interprets the images, spaces, and institutions as articulations of the complex cultural entanglements and creative engagement with international communities which prolonged colonial contact.

Architecture of Iolani Palace and the Kalakaua Bandstand, the Royal Crowns, Sword of State, The Kamehameha Statue, and the Collections of the Hawaiian National Museum are illustrated in photographs throughout the book. A resource for anthropological researchers, historians and readers interested in the culture of Hawaiian royalty, The Arts of Kingship is a valuable reference source.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

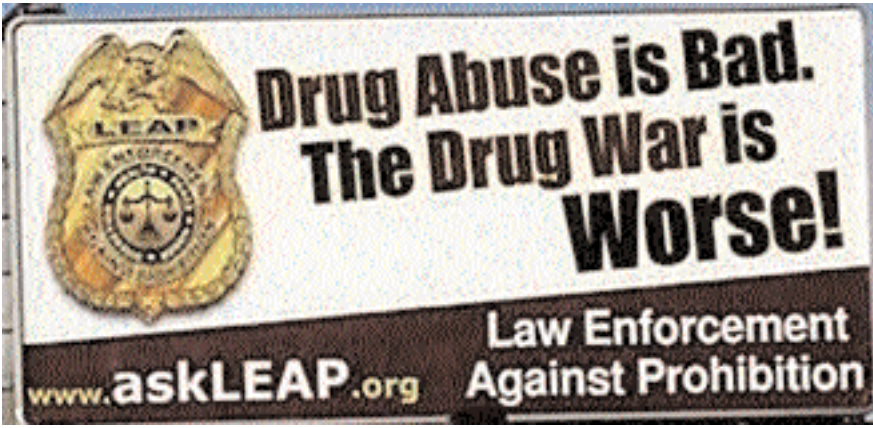

Medical Marijuana Attacked

And let's not forget what President Barack Obama, New York Mayor Michael Bloomberg and California Gov. Arnold Schwarzenegger all have in common: They are all elected officials who have admitted to smoking marijuana.

The unConstitutional War on Drugs Continues: Redding police Chief Peter Hansen sent letters to nine medical marijuana dispensaries and their landlords Monday reminding them in no uncertain terms that marijuana is still illegal under federal law, despite California voters' legalization of medicinal pot 13 years ago.

The letter comes after the Obama publicly stated earlier this year that U.S. attorneys around the country should not enforce marijuana bans if they ran counter to state laws, a move that triggered a statewide rush of new medical marijuana dispensaries, co-ops and smoking rooms. But Obama lied, and he let federal and state cops continue to raid the coops.

"The law has not changed because of the whims of the attorney general and president of the United States," Hansen said in an interview.

As reported first on Redding.com, his letter warns of federal violators facing potential 20-year prison terms and the possibility of having their property seized.

The letter was immediately criticized by a marijuana-legalization advocate, who called it a police intimidation tactic.

"It's hard to imagine what else it is," said Bruce Mirken, spokesman for the Washington, D.C.-based Marijuana Policy Project. "One could only assume that the guy doesn't like the medical marijuana laws. That's fine, but as a law enforcement officer, he's sworn to enforce California law. I'm old-fashioned enough to think he should do it."

Chief Hansen acknowledged that his office doesn't usually enforce federal laws, and that he doesn't plan to have his officers target the pot shops specifically because federal prosecutors won't charge them. "I don't mean it to be perceived as a threat," Hansen said. "But I do I want these folks to understand they're operating outside of federal law."

Walt Carney, the owner of River Valley Collective on Market Street, agreed with Mirken that the letter was an intimidation tactic. He's drafting a letter in response. Carney said he believes Hansen's letter was a result of pressure from members of Redding's religious community and conservative constituents.
