Letter to Obama: Health Care?

Dr. Arleen Meyers, a physician, attorney, and president of the Hawaii Coalition For Health, wrote a letter to Barack Obama which I think he ought to read and take to heart. Her letter is dated December 24, 2009, the day before Christmas, and it is still valid today, the day before New Years. Neither the president nor Congress seem to have gotten this message yet.

Dear President Obama:

It is surely a historic moment, but we may not like what we get. Through the work of a non-profit healthcare consumer advocacy organization, the Hawaii Coalition For Health, I and several of my civic minded fellow physicians and public interest lawyers founded in 1996, we have zealously strived to protect and preserve the rights of patients in Hawaii to receive quality and affordable health care. We all shed tears of joy the night you were elected because we believed you could accomplish the meaningful health reform our country sorely needs. However, the health reform bill the Senate just passed may hurt millions more Americans than it will help. It encroaches on the reproductive rights of poor women; the mandate forces Americans to buy insurance they can ill afford in this economy or disobey the law with no meaningful protections against the predatory conduct of health insurers. With ERISA left untouched, there is no way to protect seriously ill patients from the consequences they suffer from the draconian rationing of healthcare in which insurance companies presently engage.

Furthermore, the public option I strongly supported to bring sorely needed competition into the health insurance market place and to reduce the unfettered power insurers now have is gone from the Senate bill. I also understand that Hawaii has been granted an exemption. I don't quite know what that means, or how that will affect Hawaii patients.

In my humble view, this country's serious problems will not be solved by government pouring billions of dollars into the banking industry or health care that does not have with it serious assurances that at least some of that investment will filter down to benefit us little guys. The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

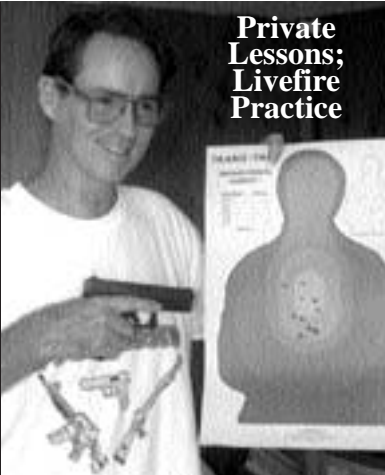

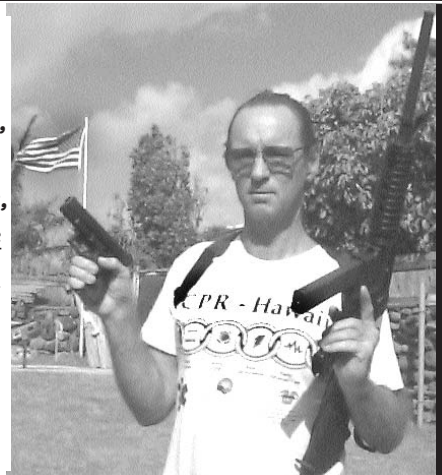

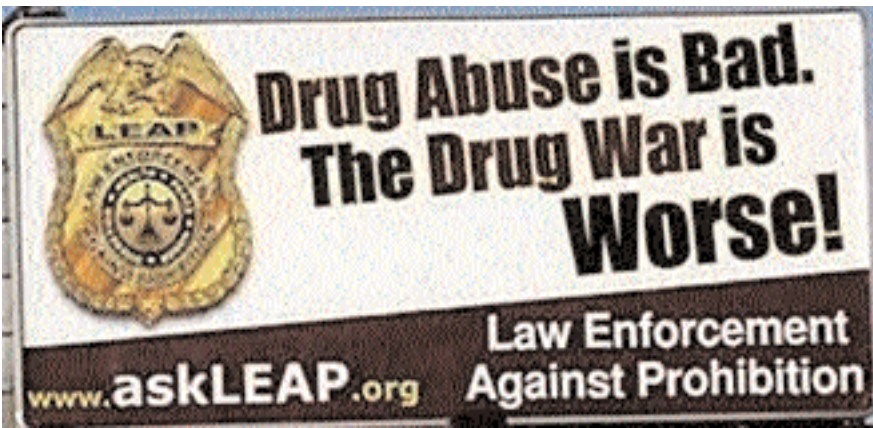

Medical Marijuana Tyranny continues under Obama and the LIAR cops

Medical marijuana patient and now criminal defendant Donna Lambert joined a 10-person medical marijuana collective after the 2006 raids that disrupted supplies. "I provided medical marijuana to a valid qualified patient who turns out was an undercover cop who lied to a doctor to get a doctor's recommendation," said Lambert, one of 14 people arrested in the Operation Green RX raids conducted in February. "There was no dispute about my patient status or his patient status."

In Operation Green RX, as many as ten detectives spent six months becoming qualified medical marijuana patients on fraudulent grounds and then joining medical marijuana collectives. Undercover San Diego Police Detective Scott Henderson lied to a doctor to obtain a valid medical marijuana recommendation and then reached out to Ms. Lambert for help. When, believing she was lawfully helping another patient, she supplied him with medical marijuana, Lambert became yet another of Prosecutor Dumanis' victims.

"Lambert, a 47-year-old San Diego resident, began relying on marijuana to cope with chemotherapy. She struggles with a number of serious illnesses, including hepatitis C, cirrhosis, cancer and Sjogrens Disease. She was bound over for December trial during a preliminary hearing last week, despite the judge in that hearing noting that she was clearly not in it for profit. "My attorney says they've never dismissed a medical marijuana sales case in San Diego," she said.

"They are a little more conservative down there than the other coastal cities," said San Francisco-based Marijuana Policy Project spokesman Bruce Mirken when asked what was the matter with San Diego. "It seems like the county is more a problem than the city, and some of their officials, including the DA, are particularly bad."

California's confused medical marijuana law is part of the problem, said Mirken. "It doesn't specify with absolute clarity what is legal and what isn't when it comes to medical marijuana distribution. Everyone is operating on the attorney general's guidelines, which haven't been tested in court, and that leaves room for interpretation, so you have fertile ground for officials who choose to be jerks to wreak a great deal of havoc. That's what's happening in San Diego County."

"People got up in arms at the DEA, but in this case, they were playing a supporting role," said Mirken. "The real problem is local officials who think medical marijuana is okay as long as you don't actually get it from anyone. The law says patients can have marijuana, so it makes sense to have an aboveground, organized distribution system. We have working models for that in places like San Francisco. It's not that hard to do if you have the political will to do it," Mirken said.

re: Barack Hussein Obama: Quo Warranto

Dear Mr. Holder,

On March 1st on behalf of my clients I have submitted to you a request to file Quo Warranto against Mr. Barack Hussein Obama. The request was filed due to following troubling facts:

1. According to a number of licensed investigators National Databases show Mr. Obama using as many as 39 different Social Security numbers, which included the numbers of deceased individuals and numbers never assigned.

2. Number 042-68-4425 that Mr. Obama used for most of his life and is currently using while residing in the White House, is a number assigned to an individual born in 1890, who resided in the state of Connecticut and this Social Security number was issued in the state of Connecticut where Mr. Obama never resided.

3. The state of Hawaii since 1911 had in its statutes a provision allowing Foreign born children of Hawaiian residents of get Hawaiian Birth Certificates (currently statute 338-17) and currently statute 338-5 allows one to get a birth certificate based on a statement of one relative only without any corroborating evidence from the hospital.

4. In spite of over 100 law suits filed around the country and 12 Citizen Grand Jury indictments Mr. Obama refused to sign a consent to unseal his original birth certificate currently sealed in the Health Department of the state of Hawaii and all the other vital records.

5. Ms. Chiuomi Fukino, Director of the Health Department of the State of Hawaii has provided a statement that there is a document on file in Hawaii, however she refused.... to answer any questions as to whether his birth certificate was obtained based on a proper hospital birth certificate or based on a statement of one of his relatives only, which needs to be corroborated.

6. Regardless of place of birth of Mr. Obama, since birth and until now Mr. Obama had a split allegiance. He had British citizenship at birth, Kenyan since age 2 and Indonesian since age 5. Allegiance to other Nations goes as a clear violation of the Natural citizenship clause of the article 2 section 1 of the Constitution.

7. Under the Freedom of Information act 5 US 552, since no response was provided to numerous certified mail letters received by your office nine months ago, I demand a written response or Administrative hearing on the matter within 30 days. On behalf of my clients I demand an answer, as to when the Quo Warranto against Mr. Obama will be filed by the US Attorney General office, or in the alternative if the Attorney General office refuses to file Quo Warranto, I demand an ex-relator status for my clients to proceed with the Quo Warranto action against Mr. Obama in the DC court or the Supreme Court of the United States.
